A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. The sum of \$762,900, or so much thereof as
6 may be necessary, is appropriated to the Illinois Student
7 Assistance Commission from the General Revenue Fund for costs
8 associated with marketing for the College Illinois! Prepaid
9 Tuition Program.

10 Section 5. The following named amount, or so much
11 thereof as may be necessary, is appropriated from the General
12 Revenue Fund to the Illinois Student Assistance Commission
13 for the following purpose:

14 To support outreach, research, and
15 training activities1,754,600

16 Section 10. In addition to any other sums appropriated, the
17 sum of \$2,288,700, or so much thereof as may be necessary, is
18 appropriated from the General Revenue Fund to the Illinois
19 Student Assistance Commission for operational expenses during

1 the fiscal year ending June 30, 2015.

2 Section 15. The sum of \$322,851,900, or so much thereof
3 as may be necessary, is appropriated to the Illinois Student
4 Assistance Commission from the General Revenue Fund for grant
5 awards to students eligible for the Monetary Award Program,
6 as provided by law, and for administrative costs not to
7 exceed 2 percent of the total appropriation in this Section.

8 Section 20. The sum of \$30,500, or so much thereof as
9 may be necessary, is appropriated from the Education
10 Assistance Fund to the Illinois Student Assistance Commission
11 for costs associated with the Veterans' Home Nurses' Loan
12 Repayment Program pursuant to Public Act 95-0576.

13 Section 25. The sum of \$343,300, or so much thereof as
14 may be necessary, is appropriated from the Education
15 Assistance Fund to the Illinois Student Assistance Commission
16 for grants to eligible nurse educators to use for payment of
17 their educational loan pursuant to Public Act 94-1020.

18 Section 30. The following named sums, or so much thereof
19 as may be necessary, respectively, are appropriated from the
20 Education Assistance Fund to the Illinois Student Assistance
21 Commission for the following purposes:

1	Grants and Scholarships	
2	For the payment of scholarships to students	
3	who are children of policemen or firemen	
4	killed in the line of duty, or who are	
5	dependents of correctional officers killed	
6	or permanently disabled in the line of	
7	duty, as provided by law	841,900
8	For payment of Minority Teacher Scholarships	<u>1,907,200</u>
9	Total	\$2,749,100

10 Section 35. The sum of \$5,071,400, or so much thereof as
 11 may be necessary, is appropriated from the Education
 12 Assistance Fund to the Illinois Student Assistance Commission
 13 to the Golden Apple Scholars of Illinois program, as provided
 14 by law.

15 Section 40. The sum of \$572,200, or so much thereof as
 16 may be necessary, is appropriated from the Education
 17 Assistance Fund to the Illinois Student Assistance Commission
 18 for the Loan Repayment for Teachers Program.

19 Section 45. The sum of \$300,000, or so much thereof as
 20 may be necessary, is appropriated from the ISAC Accounts
 21 Receivable Fund to the Illinois Student Assistance Commission
 22 for costs associated with the collection of delinquent

1 scholarship awards pursuant to the Illinois State Collection
2 Act of 1986.

3 Section 50. The sum of \$110,000, or so much thereof as
4 may be necessary, is appropriated to the Illinois Student
5 Assistance Commission from the University Grant Fund for
6 payment of grants for the Higher Education License Plate
7 Program, as provided by law.

8 Section 55. The following named sum, or so much thereof
9 as may be necessary, is appropriated from the Illinois
10 Student Assistance Commission Contracts and Grants Fund to
11 the Illinois Student Assistance Commission for the following
12 purpose:

13 To support outreach, research, and
14 training activities10,000,000

15 Section 60. The following named sum, or so much thereof
16 as may be necessary, is appropriated from the Optometric
17 Licensing and Disciplinary Board Fund to the Illinois Student
18 Assistance Commission for the following purpose:

19 Grants and Scholarships
20 For payment of scholarships for the
21 Optometric Education Scholarship
22 Program, as provided by law50,000

1 Section 65. The following named sum, or so much thereof
 2 as may be necessary, is appropriated from the National Guard
 3 and Naval Militia Grant Fund to the Illinois Student
 4 Assistance Commission for the following purpose:

5 Grants and Scholarships

6 For payment of Illinois National Guard and
 7 Naval Militia Scholarships
 8 at State-controlled universities
 9 and public community colleges in
 10 Illinois to students eligible to
 11 receive such awards, as provided by law20,000

12 Section 70. The sum of \$140,000, or so much thereof as
 13 may be necessary, is appropriated from the Illinois Future
 14 Teacher Corps Scholarship Fund to the Illinois Student
 15 Assistance Commission for the Golden Apple Scholars of
 16 Illinois Program, as provided by law.

17 Section 75. The following named sums, or so much thereof
 18 as may be necessary, respectively, are appropriated to the
 19 Illinois Student Assistance Commission from the Student Loan
 20 Operating Fund for its ordinary and contingent expenses:

15 Section 80. The sum of \$3,500,000, or so much thereof as
16 may be necessary, is appropriated to the Illinois Student
17 Assistance Commission from the Student Loan Operating Fund
18 for costs associated with Federal Loan System Development and
19 Maintenance.

20 Section 85. The sum of \$15,000,000, or so much thereof
21 as may be necessary, is appropriated to the Illinois Student
22 Assistance Commission from the Student Loan Operating Fund
23 for distribution as necessary for the following: for payment

1 of collection agency fees associated with collection
 2 activities for Federal Family Education Loans, for Default
 3 Aversion Fee reversals, and for distributions as necessary
 4 and provided for under the Federal Higher Education Act.

5 Section 90. The following named sum, or so much thereof
 6 as may be necessary, is appropriated from the Federal
 7 Congressional Teacher Scholarship Program Fund to the
 8 Illinois Student Assistance Commission for the following
 9 purpose:

10 For transferring repayment funds collected
 11 under the Paul Douglas Teacher Scholarship
 12 Program to the U.S. Treasury400,000

13 Section 95. The sum of \$290,000,000, or so much thereof
 14 as may be necessary, is appropriated from the Federal Student
 15 Loan Fund to the Illinois Student Assistance Commission for
 16 distribution when necessary as a result of the following: for
 17 guarantees of loans that are uncollectible, for collection
 18 payments to the Student Loan Operating Fund as required under
 19 agreements with the United States Secretary of Education, for
 20 payment to the Student Loan Operating Fund for Default
 21 Aversion Fees, for transfers to the U.S. Treasury, or for
 22 other distributions as necessary and provided for under the
 23 Federal Higher Education Act.

1 Section 100. The sum of \$15,000,000, or so much thereof
2 as may be necessary, is appropriated from the Federal Student
3 Incentive Trust Fund to the Illinois Student Assistance
4 Commission for payment of grants for the Federal College
5 Access Challenge Grant Program, with up to six percent of the
6 funding appropriated to meet allowable administrative costs,
7 as part of the College Cost Reduction and Access Act (CCRAA),
8 as provided by law.

9 Section 105. The sum of \$500,000, or so much thereof as
10 may be necessary, is appropriated from the Federal Student
11 Incentive Trust Fund to the Illinois Student Assistance
12 Commission for the John R. Justice Student Loan Repayment
13 Program.

14 Section 999. Effective date. This Act takes effect July 1,
15 2014.
