1 AMENDMENT TO HOUSE BILL 217

2 AMENDMENT NO. _____. Amend House Bill 217 on page 9, by
3 replacing lines 1 through 20 with the following:

4 "Section 25. Advertisement and sales; misrepresentation.
5 No person or entity may, in the conduct of any trade or
6 commerce, use or employ any deception, fraud, false pretense,
7 false promise, misrepresentation, or the concealment,
8 suppression, or omission of any material fact in advertising or
9 otherwise offering conversion therapy services in a manner that
10 represents homosexuality as a mental disease, disorder, or
11 illness, with intent that others rely upon the concealment,
12 suppression, or omission of such material fact. A violation of
13 this Section constitutes an unlawful practice under the
14 Consumer Fraud and Deceptive Business Practices Act.

15 Section 30. Discipline. Any sexual orientation change
16 efforts attempted on a person under the age of 18 by a mental

1 health provider may be considered unprofessional conduct.
2 Mental health providers found to have engaged in a sexual
3 orientation change effort on a patient under the age of 18 may
4 be subject to discipline by the licensing entity or
5 disciplinary review board with competent jurisdiction.

6 Section 90. The Consumer Fraud and Deceptive Business
7 Practices Act is amended by changing Section 2Z as follows:

9 Sec. 2Z. Violations of other Acts. Any person who knowingly
10 violates the Automotive Repair Act, the Automotive Collision
11 Repair Act, the Home Repair and Remodeling Act, the Dance
12 Studio Act, the Physical Fitness Services Act, the Hearing
13 Instrument Consumer Protection Act, the Illinois Union Label
14 Act, the Job Referral and Job Listing Services Consumer
15 Protection Act, the Travel Promotion Consumer Protection Act,
16 the Credit Services Organizations Act, the Automatic Telephone
17 Dialers Act, the Pay-Per-Call Services Consumer Protection
18 Act, the Telephone Solicitations Act, the Illinois Funeral or
19 Burial Funds Act, the Cemetery Oversight Act, the Cemetery Care
20 Act, the Safe and Hygienic Bed Act, the Pre-Need Cemetery Sales
21 Act, the High Risk Home Loan Act, the Payday Loan Reform Act,
22 the Mortgage Rescue Fraud Act, subsection (a) or (b) of Section
23 3-10 of the Cigarette Tax Act, subsection (a) or (b) of Section
24 3-10 of the Cigarette Use Tax Act, the Electronic Mail Act, the

1 Internet Caller Identification Act, paragraph (6) of
2 subsection (k) of Section 6-305 of the Illinois Vehicle Code,
3 Section 11-1431, 18d-115, 18d-120, 18d-125, 18d-135, 18d-150,
4 or 18d-153 of the Illinois Vehicle Code, Article 3 of the
5 Residential Real Property Disclosure Act, the Automatic
6 Contract Renewal Act, Section 25 of the Youth Mental Health
7 Protection Act, or the Personal Information Protection Act
8 commits an unlawful practice within the meaning of this Act.
