1 AMENDMENT TO HOUSE BILL 217

2 AMENDMENT NO. \_\_\_\_\_. Amend House Bill 217 on page 9, by

3 replacing lines 1 through 20 with the following:

"Section 25. Advertisement and sales; misrepresentation. No person or entity may, in the conduct of any trade or commerce, use or employ any deception, fraud, false pretense, false promise, misrepresentation, or the concealment, suppression, or omission of any material fact in advertising or otherwise offering conversion therapy services in a manner that represents homosexuality as a mental disease, disorder, or illness, with intent that others rely upon the concealment, suppression, or omission of such material fact. A violation of this Section constitutes an unlawful practice under the Consumer Fraud and Deceptive Business Practices Act.

Section 30. Discipline. Any sexual orientation change efforts attempted on a person under the age of 18 by a mental

- 1 health provider may be considered unprofessional conduct.
- 2 Mental health providers found to have engaged in a sexual
- 3 orientation change effort on a patient under the age of 18 may
- 4 be subject to discipline by the licensing entity or
- 5 disciplinary review board with competent jurisdiction.
- 6 Section 90. The Consumer Fraud and Deceptive Business
- 7 Practices Act is amended by changing Section 2Z as follows:
- 8 (815 ILCS 505/2Z) (from Ch. 121 1/2, par. 262Z)
- 9 Sec. 2Z. Violations of other Acts. Any person who knowingly
- 10 violates the Automotive Repair Act, the Automotive Collision

- 13 Instrument Consumer Protection Act, the Illinois Union Label

- 3-10 of the Cigarette Tax Act, subsection (a) or (b) of Section
- 3-10 of the Cigarette Use Tax Act, the Electronic Mail Act, the

- 6 Contract Renewal Act, Section 25 of the Youth Mental Health
- Protection Act, or the Personal Information Protection Act 7
- 8 commits an unlawful practice within the meaning of this Act.
