## SYNOPSIS AS INTRODUCED:

720 ILCS 5/11-0.1

Amends the Criminal Code of 2012. Changes the definition of "sexual conduct" in the Sex Offenses Article of the Code to any knowing touching, kissing, or fondling by the victim or the accused, either directly or through clothing, of the sex organs, anus, buttocks, or breast of the victim or the accused, or any part of the body of a child under 13 years of age, or any transfer or transmission of semen by the accused upon any part of the clothed or unclothed body of the victim, for the purpose of sexual gratification or arousal of the victim or the accused (currently, kissing and buttocks are not included in the definition).

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- 4 Section 5. The Criminal Code of 2012 is amended by changing
- 5 Section 11-0.1 as follows:
- 6 (720 ILCS 5/11-0.1)
- 7 Sec. 11-0.1. Definitions. In this Article, unless the
- 8 context clearly requires otherwise, the following terms are
- 9 defined as indicated:
- "Accused" means a person accused of an offense prohibited
- 11 by Section 11-1.20, 11-1.30, 11-1.40, 11-1.50, or 11-1.60 of
- this Code or a person for whose conduct the accused is legally
- 13 responsible under Article 5 of this Code.
- 14 "Adult obscenity or child pornography Internet site". See
- 15 Section 11-23.
- "Advance prostitution" means:
- 17 (1) Soliciting for a prostitute by performing any of
- the following acts when acting other than as a prostitute
- or a patron of a prostitute:
- 20 (A) Soliciting another for the purpose of
- 21 prostitution.
- 22 (B) Arranging or offering to arrange a meeting of
- persons for the purpose of prostitution.

- 1 (C) Directing another to a place knowing the 2 direction is for the purpose of prostitution.
  - (2) Keeping a place of prostitution by controlling or exercising control over the use of any place that could offer seclusion or shelter for the practice of prostitution and performing any of the following acts when acting other than as a prostitute or a patron of a prostitute:
    - (A) Knowingly granting or permitting the use of the place for the purpose of prostitution.
    - (B) Granting or permitting the use of the place under circumstances from which he or she could reasonably know that the place is used or is to be used for purposes of prostitution.
    - (C) Permitting the continued use of the place after becoming aware of facts or circumstances from which he or she should reasonably know that the place is being used for purposes of prostitution.

- 16 least 6 months.
- "Force or threat of force" means the use of force or
- 18 violence or the threat of force or violence, including, but not
- 19 limited to, the following situations:
- 20 (1) when the accused threatens to use force or violence
- on the victim or on any other person, and the victim under
- 22 the circumstances reasonably believes that the accused has
- 23 the ability to execute that threat; or
- 24 (2) when the accused overcomes the victim by use of
- superior strength or size, physical restraint, or physical
- confinement.

- 20 part from the practice of prostitution.

- 1 "Sexual abuse". See Section 11-9.1A.
- 2 "Sexual act". See Section 11-9.1.
- "Sexual conduct" means any knowing touching, kissing, or 3 fondling by the victim or the accused, either directly or 4 5 through clothing, of the sex organs, anus, buttocks, or breast 6 of the victim or the accused, or any part of the body of a child 7 under 13 years of age, or any transfer or transmission of semen 8 by the accused upon any part of the clothed or unclothed body 9 of the victim, for the purpose of sexual gratification or 10 arousal of the victim or the accused.
- "Sexual excitement". See Section 11-21.
  - "Sexual penetration" means any contact, however slight, between the sex organ or anus of one person and an object or the sex organ, mouth, or anus of another person, or any intrusion, however slight, of any part of the body of one person or of any animal or object into the sex organ or anus of another person, including, but not limited to, cunnilingus, fellatio, or anal penetration. Evidence of emission of semen is not required to prove sexual penetration.
- "Solicit". See Section 11-6.

- "Surveillance agent". See Section 11-9.2.
- "Treatment and detention facility". See Section 11-9.2.
