Amends various Acts relating to the governance of public universities in Illinois and the Public Community College Act. Requires a university or community college to waive its fee for the receipt or transmission of a transcript for each veteran, member of the Armed Forces of the United States, member of the Reserve components thereof, or member of the Illinois National Guard who resides in this State and has been admitted to the institution. Effective immediately.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The University of Illinois Act is amended by adding Section 90 as follows:
- 6 (110 ILCS 305/90 new)
- 7 Sec. 90. Waiver of transcript fee. The University shall
- 8 waive its fee for the receipt or transmission of a transcript
- 9 for each veteran, member of the Armed Forces of the United
- States, member of the Reserve components thereof, or member of

- been admitted to the University.
- 13 Section 10. The Southern Illinois University Management

- 17 Section 35. The Northeastern Illinois University Law is
- amended by adding Section 25-185 as follows:

- 20 Sec. 25-185. Waiver of transcript fee. The University shall
- 21 waive its fee for the receipt or transmission of a transcript
- for each veteran, member of the Armed Forces of the United

- 1 States, member of the Reserve components thereof, or member of

- 3 been admitted to the University.
- 4 Section 40. The Northern Illinois University Law is amended
- 5 by adding Section 30-195 as follows:

- 8 waive its fee for the receipt or transmission of a transcript
- 9 for each veteran, member of the Armed Forces of the United
- 10 States, member of the Reserve components thereof, or member of
- 11 the Illinois National Guard who resides in this State and has
- been admitted to the University.
- 13 Section 45. The Western Illinois University Law is amended
- 14 by adding Section 35-190 as follows:
- 15 (110 ILCS 690/35-190 new)
- Sec. 35-190. Waiver of transcript fee. The University shall
- waive its fee for the receipt or transmission of a transcript
- 18 for each veteran, member of the Armed Forces of the United
- 19 States, member of the Reserve components thereof, or member of
- 20 the Illinois National Guard who resides in this State and has
- 21 been admitted to the University.

- 1 Section 50. The Public Community College Act is amended by
- 2 adding Section 3-29.11 as follows:
- 3 (110 ILCS 805/3-29.11 new)
- 4 Sec. 3-29.11. Waiver of transcript fee. A community college
- 5 shall waive its fee for the receipt or transmission of a
- 6 transcript for each veteran, member of the Armed Forces of the
- 7 United States, member of the Reserve components thereof, or
- 8 <u>member of the Illinois National Guard who resides in this State</u>
- 9 <u>and has been admitted to the community college.</u>
- 10 Section 99. Effective date. This Act takes effect upon
- 11 becoming law.
