The estimated dates of completion of the redevelopment 7 8 project and retirement of obligations issued to finance 9 redevelopment project costs (including refunding bonds under 10 Section 11-74.4-7) may not be later than December 31 of the 11 year in which the payment to the municipal treasurer as 12 provided in subsection (b) of Section 11-74.4-8 of this Act is 13 to be made with respect to ad valorem taxes levied in the 33rd 14 calendar year after the year in which the ordinance approving 15 the redevelopment project area was adopted if the ordinance was 16 adopted on May 20, 1985 by the Village of Wheeling.
