January 31st an affidavit stating the percentage of its 1 gross income during the prior calendar year that was 2 3 derived from the sale of loose tobacco, plants, or herbs and cigars, cigarettes, pipes, or other smoking devices for 4 5 smoking tobacco and related smoking accessories. Any retail tobacco store that begins operation after the 6 7 effective date of this amendatory Act may only qualify for 8 an exemption if located in a freestanding structure 9 occupied solely by the business and smoke from the business 10 does not migrate into an enclosed area where smoking is 11 prohibited.

(3) (Blank).

13 (4) Hotel and motel sleeping rooms that are rented to 14 quests and are designated as smoking rooms, provided that 15 all smoking rooms on the same floor must be contiguous and 16 smoke from these rooms must not infiltrate into nonsmoking 17 rooms or other areas where smoking is prohibited. Not more 18 than 25% of the rooms rented to guests in a hotel or motel 19 may be designated as rooms where smoking is allowed. The 20 status of rooms as smoking or nonsmoking may not be 21 changed, except to permanently add additional nonsmoking 22 rooms.

(5) Enclosed laboratories that are excluded from the
definition of "place of employment" in Section 10 of this
Act. Rulemaking authority to implement this amendatory Act
of the 95th General Assembly, if any, is conditioned on the

rules being adopted in accordance with all provisions of the Illinois Administrative Procedure Act and all rules and procedures of the Joint Committee on Administrative Rules; any purported rule not so adopted, for whatever reason, is unauthorized.

(6) Common smoking rooms in long-term care facilities 6 7 operated under the authority of the Illinois Department of 8 Veterans' Affairs or licensed under the Nursing Home Care 9 Act that are accessible only to residents who are smokers 10 and have requested in writing to have access to the common smoking room where smoking is permitted and the smoke shall 11 12 not infiltrate other areas of the long-term care facility. 13 Rulemaking authority to implement this amendatory Act of 14 the 95th General Assembly, if any, is conditioned on the 15 rules being adopted in accordance with all provisions of the Illinois Administrative Procedure Act and all rules and 16 procedures of the Joint Committee on Administrative Rules; 17 any purported rule not so adopted, for whatever reason, is 18 19 unauthorized.

20 (7) A convention hall of the Donald E. Stephens 21 Convention Center where a meeting or trade show for 22 manufacturers and suppliers of tobacco and tobacco 23 products and accessories is being held, during the time the 24 meeting or trade show is occurring, if the meeting or trade 25 show:

(i) is a trade-only event and not open to the

| 13 | to August 14, 2015 that was constructed for the purpose of |
| 14 | compliance with this Act, including, but not limited to, |
| 15 | buildings created solely for the purpose of smoking at |
| 16 | which no food or alcohol is served and outdoor smoking |
| 17 | areas, provided that such facilities or areas have signs |
| 18 | clearly stating that the building or area is used for |
| 19 | smoking. The Department shall adopt any rules necessary to |
| 20 | implement this paragraph (8). For the purposes of this |
| 21 | paragraph (8), "veterans organization" means an |
| 22 | organization comprised of members of which substantially |
| 23 | all are individuals who are veterans or spouses, widows, or |
| 24 | widowers of veterans, the primary purpose of which is to |
