Makes appropriations for the ordinary and contingent expenses of the Office of the State Appellate Defender. Makes further appropriations for: expenses related to federally assisted programs to work on systemic sentencing issues appeals cases; expenses related to providing public defenders in rural counties the resources needed to adequately investigate and defend indigent clients; the ordinary and contingent expenses of the Expungement Program; statewide training to Public Defenders; and developing a Juvenile Defender Resource Center. Effective July 1, 2016.

#### Be it enacted by the People of the State of Illinois, represented 2 in the General Assembly: 3

Section 5. The following named amounts, or so much of 4 5 those amounts as may be necessary, respectively, for the objects and purposes named, are appropriated from the General 6 Revenue Fund to meet the ordinary and contingent expenses of 7 8 the Office of the State Appellate Defender:

The amount of \$75,000, or so much thereof as 7 may be necessary, is appropriated from the General Revenue 8 Fund to the Office of the State Appellate Defender for 9 expenses related to providing public defenders in rural 10 counties the resources needed to adequately investigate and 11 defend indigent clients.

Section 20. The amount of \$160,000, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Office of the State Appellate Defender for the ordinary and contingent expenses of the Expungement Program.

16 Section 25. The amount \$63,000, or so much thereof as may 17 be necessary, is appropriated from the General Revenue Fund 18 to the Office of the State Appellate Defender to provide 19 statewide training to Public Defenders under the Public 20 Defender Training Program.
