## HOUSE RESOLUTION

2 members Illinois WHEREAS, The of the House of 3 Representatives recognize that there distressed are 4 communities throughout Illinois that struggle with many 5 economic and social problems, including crime, unemployment, 6 poverty, mortgage foreclosures, declining property values, 7 deficiencies in public health services, and deficits in public 8 education: and

9 WHEREAS, In recent years, these economic and social 10 problems have become more prevalent and they have exacerbated 11 existing conditions; it is important to take a comprehensive 12 approach to the ongoing crisis of distressed communities in 13 Illinois; as long as these problems are not successfully 14 addressed, the cost to taxpayers in Illinois will only 15 increase; and

16 WHEREAS, State government resources are expended in 17 ever-increasing amounts to address these social and economic problems, and those expenditures are a significant drain on the 18 19 State's road to financial stability; there exist numerous ways 20 for State government to be operated more efficiently and more economically; more effective, efficient, and economical ways 21 22 to raise the overall welfare of the distressed communities can then be replicated, with adjustments as appropriate, to all 23
