HOUSE RESOLUTION

2 WHEREAS, The members of the Illinois House of 3 Representatives wish to congratulate and celebrate Coach Dan 4 Rourke on the occasion of his retirement as head football coach 5 at Glenwood High School in Chatham; and

6 WHEREAS, In 1993, Dan Rourke was in the midst of his 12th 7 year teaching and coaching football in Plano, Texas; he earned 8 his master's degree in 1992 from Texas A&M - Commerce and was 9 seeking a head coaching and administrative job in Texas; things 10 quickly changed when his uncle, John Rourke of Chatham, was 11 diagnosed with cancer; Dan made the decision, after consulting 12 with his wife Julie, to move back to Chatham and spend time 13 with his uncle; and

14 WHEREAS, Principal Mike Collins, assistant principal Chuck 15 Hoots, and Superintendent Don Kauerauf among others were 16 instrumental in Dan Rourke's hiring at Glenwood High School; he 17 promised to bring a competitive team to Glenwood within 5 18 years; and

19 WHEREAS, In 1993, Dan Rourke arrived in the inaugural 20 season of the Central State Eight Conference; he retained 21 assistant coach Steve Cox and started building a staff whose 22 core would stay mostly intact during his tenure; he got word HR0972 -2- LRB099 16166 GRL 44395 r
that Len Onken was interested in getting back into coaching
and, after a phone call was made, Onken was immediately
installed as a defensive coordinator; he also sought commitment
of the administration, and Superintendent Kauerauf and
Principal Collins were instrumental in getting additional
coaches added to the staff; and

7 WHEREAS, During Dan Rourke's second season, he brought in 8 Mike Janke and David Hay; during his third year, he brought in 9 Vondel Edgar; all 3 remain on the coaching staff at Glenwood 10 today; and

11 WHEREAS, There have been numerous assistant coaches over 12 the years at Glenwood during the Dan Rourke era, including Mike 13 McGiles, Dan Sheedy, John Hyde, Josh Crossland, Jared Bruner, 14 Keith Moomey, Trevor Lehnen, and Caleb Cox, to name a few; and

15 WHEREAS, Dan Rourke kept his promise to bring a competitive 16 team to Glenwood High School; in just 5 years, Glenwood won the 17 Class 4A State title with a perfect 14-0 record; his teams went 18 on to make 18 playoff appearances in 23 years; Glenwood High 19 School was also the runner-up in Class 5A in 2010 and the 20 program qualified for the State quarterfinals in 1997, 2003, 21 2004, 2011, and 2012; and

WHEREAS, After 35 years coaching football, with the last 23
