AN ACT concerning local government.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 Section 5. The Metropolitan Water Reclamation District Act 5 is amended by changing Section 308 and adding Section 309 as 6 follows:

8 Sec. 308. District enlarged. Upon <u>August 3, 2015 (</u>the 9 effective date of <u>Public Act 99-231</u>) this amendatory Act of the 10 <del>99th General Assembly</del>, the corporate limits of the Metropolitan 11 Water Reclamation District of Greater Chicago are extended to 12 include within those corporate limits the following described 13 tracts of land and the tracts are hereby annexed to the 14 District:
