1 AN ACT concerning appropriations.

(o) Deposits to other funds.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 ARTICLE 1 Section 1. "Operational expenses" defined. For the 5 purposes of this Act, the term "operational expenses" 6 7 includes the following items: 8 (a) Personal Services; 9 (b) State contributions to Social Security (c) Group Insurances; 10 (d) Contractual Services 11 12 (e) Travel; 13 (f) Commodities; 14 (g) Printing; 15 (h) Equipment; (i) Electronic data processing; 16 17 (j) Telecommunications services; 18 (k) Operation of automotive equipment; 19 (1) Refunds; (m) Employee retirement contributions paid by the employer; 20 21 (n) Permanent improvements;

1	Section 5. In addition to other amounts appropriated,
2	the amount of \$12,125,300, or so much thereof as may be
3	necessary, is appropriated from the General Revenue Fund to
4	the Department of Military Affairs for operational expenses,
5	awards, grants and permanent improvements for the fiscal year
6	ending June 30, 2016.

Section 10. The sum of \$2,765,200, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Department of Military Affairs Office of the Adjutant General Division for expenses related to Lincoln's Challenge for the fiscal year ending June 30, 2016.

Section 15. The following named sums, or so much thereof as may be necessary, respectively, for the objects and purposes hereinafter named, are appropriated to meet the ordinary and contingent expenses of the Department of Military Affairs:

- 2 Payable from Federal Support Agreement Revolving Fund:
- 3 Army/Air Reimbursable Positions14,610,700
- 4 Section 20. The sum of \$13,000,000, or so much thereof
- 5 as may be necessary, is appropriated from the Federal Support
- 6 Agreement Revolving Fund to the Department of Military
- 7 Affairs Facilities Division for expenses related to Army
- 8 National Guard Facilities operations and maintenance as
- 9 provided for in the Cooperative Funding Agreements, including
- 10 costs in prior years.
- 11 Section 25. The sum of \$1,000,000, or so much thereof as
- may be necessary, is appropriated from the Military Affairs
- 13 Trust Fund to the Department of Military Affairs Office of
- 14 the Adjutant General Division to support youth and other
- programs, provided such amounts shall not exceed funds to be
- made available from public or private sources.
- 17 Section 30. The sum of \$5,000,000, or so much thereof as
- 18 may be necessary, is appropriated from the Illinois Military
- 19 Family Relief Fund to the Department of Military Affairs
- 20 Office of the Adjutant General Division for the issuance of
- 21 grants to persons or families of persons who are members of
- 22 the Illinois National Guard or Illinois residents who are

- 1 members of the armed forces of the United States and who have
- 2 been called to active duty as a result of the September 11,
- 3 2001 terrorist attacks, including costs in prior years.
- 4 Section 99. Effective date. This Act takes effect July 1,
- 5 2015.
