AMENDMENT NO. _____. Amend Senate Bill 2036 by deleting everything after the enacting clause and inserting the following:

"ARTICLE 1

6 Section 5. The sum of \$610,000, or so much thereof as 7 may be necessary, is appropriated from the General Revenue 8 Fund to the Deaf and Hard of Hearing Commission for 9 operational expenses of the fiscal year ending June 30, 2016.

10 Section 10. The sum of \$200,000, or so much thereof as 11 may be necessary, is appropriated from the Interpreters for 12 the Deaf Fund to the Deaf and Hard of Hearing commission for 13 administration and enforcement of the Interpreter for the 09900SB2036sam001 -2- HDS099 00103 GJP 20103 a Deaf Licensure Act of 2007.

ARTICLE 2

3 Section 5. The sum of \$9,384,000, or so much thereof as 4 may be necessary, is appropriated from the General Revenue 5 Fund to the Guardianship and Advocacy Commission for 6 operational expenses of the fiscal year ending June 30, 2016.

Section 10. The sum of \$2,300,000, or so much thereof as may be necessary, is appropriated from the Guardianship and Advocacy Fund to the Guardianship and Advocacy Commission for services pursuant to Section 5 of the Guardianship and Advocacy Act.

ARTICLE 3

13 Section 5. The sum of \$9,106,400, or so much thereof as 14 may be necessary, is appropriated from the General Revenue 15 Fund to the Department of Human Rights for operational 16 expenses of the fiscal year ending June 30, 2016.

The sum of \$73,500, or so much thereof as 18 may be necessary, is appropriated from the General Revenue 19 Fund to the Department of Human Rights for the purpose of 09900SB2036sam001 -3- HDS099 00103 GJP 20103 a 1 funding expenses associated with the Commission on 2 Discrimination and Hate Crimes as provided in Public Act 95-3 0425.

4 Section 15. The sum of \$350,000, or so much thereof as 5 may be necessary, is appropriated from the Department of 6 Human Rights Training and Development Fund to the Department 7 of Human Rights for the purpose of funding expenses 8 associated with administration.

9 Section 20. The following named sums, or so much thereof 10 as may be necessary, respectively, are appropriated from the 11 Special Projects Division Fund:

1 Section 25. Section 30. The sum of \$500,000, or so much thereof as may be necessary, is appropriated from the Department of Human Rights Special Fund to the Department of Human Rights for the purpose of funding expenses associated with the Department of Human Rights.
