

## 99TH GENERAL ASSEMBLY State of Illinois 2015 and 2016 SB2862

Introduced 2/17/2016, by Sen. Michael E. Hastings

## SYNOPSIS AS INTRODUCED:

20 ILCS 1805/22

from Ch. 129, par. 220.22

Amends the Military Code of Illinois. In a provision requiring the Adjutant General to order Illinois National Guard personnel into active service as required by the Commander-in-Chief to support non-emergency functions of the State, provides that the Adjutant General shall perform this duty subject to the availability of funds (rather than subject to the appropriation of funds by the General Assembly for this purpose). Effective immediately.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Military Code of Illinois is amended by changing Section 22 as follows:
- 6 (20 ILCS 1805/22) (from Ch. 129, par. 220.22)
- Sec. 22. Adjutant General; duties. The Adjutant General shall be charged with carrying out the policies of the Commander-in-Chief and shall issue orders in his name. Orders of the Adjutant General shall be considered as emanating from the Commander-in-Chief.
- of 12 shall be the immediate adviser the (a) Не 13 Commander-in-Chief on all matters relating to the militia and 14 shall be charged with the planning, development and execution of the program of the military forces of the State. He shall be 15 16 responsible for the preparation and execution of plans, for 17 organizing, supplying, equipping and mobilizing the Organized Militia, for use in the national defense, and for State 18 defense, and emergencies. 19
- 20 (b) He shall hold major organization commanders 21 responsible for the training of their commands, and shall issue 22 all orders and instructions for the government of the militia 23 and of the officers, warrant officers, and enlisted personnel

- 2 (c) He shall make such returns and reports as may be
- 3 prescribed by the Commander-in-Chief or required by the laws or
- 4 regulations of the State or of the United States.
- 5 (d) He shall, subject to the availability appropriation of
- funds by the General Assembly for this purpose, order such
- 7 personnel of the Illinois National Guard into active service of
- 8 the State as are required by the Commander-in-Chief to support
- 9 non-emergency functions of the State, including but not limited
- 10 to National Guard involvement in training exercises conducted
- in conjunction with the Illinois Emergency Management Agency.
- 12 Illinois National Guard personnel placed on duty pursuant to
- this item (d) shall be paid in accordance with the provisions
- of Sections 48 and 49.
- 15 (e) The Adjutant General shall be the head of the
- 16 Department of Military Affairs of the Executive Branch of the
- 17 government of the State and shall be the Commander of the
- 18 Illinois National Guard.
