### SYNOPSIS AS INTRODUCED:

225 ILCS 55/10

from Ch. 111, par. 8351-10

Amends the Marriage and Family Therapy Licensing Act. Provides that "title or description" means to hold oneself out as a licensed marriage and family therapist or an associate licensed marriage and family therapist to the public by means of stating on signs, mailboxes, address plates, stationery, announcements, calling cards, Internet website, social media, or other instruments or means of professional identification.

# 2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Marriage and Family Therapy Licensing Act is
amended by changing Section 10 as follows:

6 (225 ILCS 55/10) (from Ch. 111, par. 8351-10)

7 (Section scheduled to be repealed on January 1, 2018)

8 Sec. 10. Definitions. As used in this Act:

9 "Address of record" means the designated address recorded 10 by the Department in the applicant's or licensee's application 11 file or license file maintained by the Department's licensure 12 maintenance unit. It is the duty of the applicant or licensee 13 to inform the Department of any change of address, and such 14 changes must be made either through the Department's website or 15 by contacting the Department's licensure maintenance unit.

16 "Advertise" means, but is not limited to, issuing or 17 causing to be distributed any card, sign or device to any 18 person; or causing, permitting or allowing any sign or marking 19 on or in any building, structure, newspaper, magazine or 20 directory, or on radio or television; or advertising by any 21 other means designed to secure public attention.

22 "Approved program" means an approved comprehensive program23 of study in marriage and family therapy in a regionally

accredited educational institution approved by the Department
 for the training of marriage and family therapists.

3 "Associate licensed marriage and family therapist" means a
4 person to whom an associate marriage and family therapist
5 license has been issued under this Act.

Board" means the Illinois Marriage and Family TherapyLicensing and Disciplinary Board.

8 "Department" means the Department of Financial and 9 Professional Regulation.

10 "License" means that which is required to practice marriage 11 and family therapy under this Act, the qualifications for which 12 include specific education, acceptable experience and 13 examination requirements.

14 "Licensed marriage and family therapist" means a person to 15 whom a marriage and family therapist license has been issued 16 under this Act.

17 "Marriage and family therapy" means the evaluation and treatment of mental and emotional problems within the context 18 19 of human relationships. Marriage and family therapy involves 20 the use of psychotherapeutic methods to ameliorate 21 interpersonal and intrapersonal conflict and to modify 22 perceptions, beliefs and behavior in areas of human life that 23 include, but are not limited to, premarriage, marriage, sexuality, family, divorce adjustment, and parenting. 24

25 "Person" means any individual, firm, corporation,26 partnership, organization, or body politic.

1 "Practice of marriage and family therapy" means the 2 rendering of marriage and family therapy services to 3 individuals, couples, and families as defined in this Section, 4 either singly or in groups, whether the services are offered 5 directly to the general public or through organizations, either 6 public or private, for a fee, monetary or otherwise.

7 "Secretary" means the Secretary of Financial and8 Professional Regulation.
