**A BILL FOR**

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. The following named amounts, or so much  
6 thereof as may be necessary, respectively, for the objects  
7 and purposes hereinafter named, are appropriated from the  
8 Illinois Workers' Compensation Commission Operations Fund to  
9 the Illinois Workers' Compensation Commission:

4 Section 5. The amount of \$34,100, or so much thereof as  
5 may be necessary, is appropriated from the Illinois Workers'  
6 Compensation Commission Operations Fund to the Illinois  
7 Workers' Compensation Commission for the implementation and  
8 operation of an accident reporting system.

9 Section 10. The following named amounts, or so much  
10 thereof as may be necessary, respectively, for the objects  
11 and purposes hereinafter named, are appropriated from the  
12 Illinois Workers' Compensation Commission Operations Fund to  
13 the Illinois Workers' Compensation Commission:

4 Section 15. The amount of \$2,041,500, or so much thereof  
5 as may be necessary, is appropriated from the Illinois  
6 Workers' Compensation Commission Operations Fund to Illinois  
7 Workers' Compensation Commission for costs associated with  
8 the establishment, administration and operations of the  
9 Insurance Compliance Division of the workers' compensation  
10 anti-fraud program administered by Illinois Workers'  
11 Compensation Commission.

12 Section 20. The amount of \$60,000, or so much thereof as  
13 may be necessary, is appropriated from the Illinois Workers'  
14 Compensation Commission Operations Fund to Illinois Workers'  
15 Compensation Commission for costs associated with the  
16 establishment of the Medical Fee Schedule and other  
17 provisions of the Workers' Compensation Act.

18 Section 99. Effective date. This Act takes effect July 1,  
19 2016, if and only if Senate Bill 2789 of the 99<sup>th</sup> General  
20 Assembly (the Unbalanced Budget Response Act), as introduced  
21 in the Illinois Senate, becomes law.
