SYNOPSIS AS INTRODUCED:

Makes various appropriations concerning higher education and the Illinois Math and Science Academy, if and only if Senate Bill 2400 and Senate Bill 2789 of the 99th General Assembly become law. Provides that the appropriation authority is valid for costs incurred from July 1, 2015 through June 30, 2016. Effective immediately.

AN ACT concerning appropriations.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

ARTICLE 1

Section 5. As used in this Act, "operational expenses" 5 6 includes the following: personal services; State 7 contributions to social security; State contributions to 8 group insurance; contractual services; travel; commodities; 9 electronic printing; equipment; data processing; 10 telecommunications services; operation of automotive 11 equipment; refunds; employee retirement contributions paid by 12 the employer; permanent improvements; and deposits to other 13 funds.
