2 WHEREAS, The members of the Illinois Senate are saddened to 3 learn of the death of Ann Hughes-Johnson of Waukegan, who 4 passed away on January 5, 2015; and

5 WHEREAS, Ann Hughes-Johnson was born on July 23, 1925 in 6 Charleston, West Virginia; and

7 WHEREAS, Ann Hughes-Johnson graduated from Seminole High 8 School in Sanford, Florida in 1943; she subsequently earned her 9 Bachelor of Science degree in Chemistry from Stetson University 10 in 1949, her Master of Education degree (cum laude) from the National College of Education at National Louis University in 11 1964, and 62 hours towards her Ph.D. in math at Northwestern 12 13 University; she was elected to the honorary Gamma Sigma Epsilon 14 Chemistry Fraternity while at Stetson and to the Pi Lambda Theta honorary education fraternity while at Northwestern; and 15
