AN ACT concerning unemployment insurance.

Be it enacted by the People of the State of Illinois,represented in the General Assembly:

Section 5. The Unemployment Insurance Act is amended by
changing Section 612 as follows:

6 (820 ILCS 405/612) (from Ch. 48, par. 442)

Sec. 612. Academic Personnel - Ineligibility between
academic years or terms.

A. Benefits based on wages for services which are 9 employment under the provisions of Sections 211.1, and 211.2, 10 and--302C shall be payable in the same amount, on the same 11 12 terms, and subject to the same conditions as benefits payable 13 on the basis of wages for other services which are employment under this Act; except that an individual is ineligible for 14 benefits, on the basis of wages for services in an 15 16 instructional, research, or principal administrative capacity 17 performed:

1. For an educational institution, for any week 18 19 that begins during the period between 2 successive academic years or terms (or, when an agreement provides 20 instead for a similar period between 2 regular but not 21 22 successive terms, during that period) or during a period of paid sabbatical leave provided for in the individual's 23 contract, if the individual performs those services in 24 the first of the academic years (or terms) and there is a 25 26 contract or reasonable assurance that the individual will 27 perform services in any such capacity for any educational 28 institution, in the second of those academic years or 29 terms.

302. For an educational institution, for any week31that begins during an established and customary vacation

period or holiday recess, if the individual performs those services in the period immediately before the vacation period or holiday recess and there is a reasonable assurance that the individual will perform those services in the period immediately following the vacation period or holiday recess.

3. In an educational institution, while in the 7 8 employ of an educational service agency for any week: (i) 9 during a period between 2 successive academic years or 10 terms, if the individual performed those services in the 11 first of those academic years or terms and there is a reasonable assurance that the individual will perform 12 13 those services in the second of those academic years or terms; and (ii) during an established and customary 14 vacation period or holiday recess, if the individual 15 16 performed those services in the period immediately before 17 the vacation period or holiday recess and there is a reasonable assurance that the individual will perform 18 those services in the period immediately following the 19 20 vacation period or holiday recess. As used in this Section, "educational service agency" means a 21 22 governmental agency or governmental entity that is established and operated exclusively for the purpose of 23 24 providing such service to one or more educational 25 institutions.
