AN ACT in relation to public aid.

Be it enacted by the People of the State of Illinois,represented in the General Assembly:

Section 5. The Illinois Public Aid Code is amended by
changing Section 10-26 as follows:

6 (305 ILCS 5/10-26)

7 Sec. 10-26. State Disbursement Unit.

8 (a) Effective October 1, 1999 the Illinois Department shall establish a State Disbursement Unit in accordance with 9 the requirements of Title IV-D of the federal Social Security 10 The Illinois Department shall enter into an agreement 11 Act. with a State or local governmental unit or private entity to 12 13 perform the functions of the State Disbursement Unit as set forth in this Section. The State Disbursement Unit shall 14 15 collect and disburse support payments made under court and 16 administrative support orders:

17 (1) being enforced in cases in which child and
18 spouse support services are being provided under this
19 Article X; and

(2) in all cases in which child and spouse support
services are not being provided under this Article X and
in which support payments are made under the provisions
of the Income Withholding for Support Act.

(a-2) The contract entered into by the Illinois Department with a public or private entity or an individual for the operation of the State Disbursement Unit is subject to competitive bidding. In addition, the contract is subject to Section 10-26.2 of this Code. As used in this subsection (a-2), "contract" has the same meaning as in the Illinois Procurement Code.

(a-5) If the State Disbursement Unit receives a support

payment that was not appropriately made to the Unit under this Section, the Unit shall immediately return the payment to the sender, including, if possible, instructions detailing where to send the support payments.

5 (b) All payments received by the State Disbursement6 Unit:

7 (1) shall be deposited into an account obtained by
8 the State or local governmental unit or private entity,
9 as the case may be, and

10 (2) distributed and disbursed by the State 11 Disbursement Unit, in accordance with the directions of 12 the Illinois Department, pursuant to Title IV-D of the 13 Social Security Act and rules promulgated by the 14 Department.

(c) All support payments assigned to the Illinois Department under Article X of this Code and rules promulgated by the Illinois Department that are disbursed to the Illinois Department by the State Disbursement Unit shall be paid into the Child Support Enforcement Trust Fund.

20 (d) If the agreement with the State local or 21 governmental unit or private entity provided for in this Section is not in effect for any reason, the Department shall 22 23 perform the functions of the State Disbursement Unit as set forth in this Section for a maximum of 12 months before July 24 1, 2001, and for a maximum of 24 months after June 30, 2001. 25 If the Illinois Department is performing the functions of the 26 State Disbursement Unit on July 1, 2001, then the Illinois 27 Department shall make an award on or before December 28 31. 29 2002, to a State or local government unit or private entity 30 to perform the functions of the State Disbursement Unit. Payments received by the Department in performance of the 31 32 duties of the State Disbursement Unit shall be deposited into the State Disbursement Unit Revolving Fund established under 33 34 Section 12-8.1.

1 (e) By February 1, 2000, the Illinois Department shall 2 conduct at least 4 regional training and educational seminars 3 to educate the clerks of the circuit court on the general 4 operation of the State Disbursement Unit, the role of the 5 State Disbursement Unit, and the role of the clerks of the 6 circuit court in the collection and distribution of child 7 support payments.

(f) By March 1, 2000, the Illinois Department shall 8 9 conduct at least 4 regional educational and training seminars to educate payors, as defined in the Income Withholding for 10 11 Support Act, on the general operation of the State Disbursement Unit, the role of the State Disbursement Unit, 12 and the distribution of income withholding payments pursuant 13 to this Section and the Income Withholding for Support Act. 14 (Source: P.A. 91-212, eff. 7-20-99; 91-677, eff. 1-5-00; 15 91-712, eff. 7-1-00; 92-44, eff. 7-1-01.) 16
