22 WHEREAS, After Richard moved his family to Arizona, his 23 brother Dan took over the operation of the family farm; and

24 WHEREAS, The Seidel farm has survived good and bad 25 seasons but thanks to the astuteness of the various heads of 26 the farm it has become a success through scientific 27 advancements in farming; and

28 WHEREAS, An expected 80 descendents of Sebastian Seidel 29 from California, Arizona, Georgia, Maryland, Florida, and 30 Illinois plan to attend the 100th celebration in August;
