Sec. 356z.1. Prenatal HIV testing. An individual or 7 group policy of accident and health insurance that provides 8 9 maternity coverage and is amended, delivered, issued, or 10 renewed after the effective date of this amendatory Act of the 92nd General Assembly must provide coverage for prenatal 11 HIV testing ordered by an attending physician licensed to 12 practice medicine in all its branches, or by a physician 13 14 assistant or advanced practice registered nurse who has a written collaborative agreement with a collaborating 15 16 physician that authorizes these services, including but not 17 limited to orders consistent with the recommendations of the American College of Obstetricians and Gynecologists or the 18 American Academy of Pediatrics. 19
