15 Section 3. The sum of \$1,050,000, or so much thereof as 16 may be necessary, is appropriated from the General Revenue 17 Fund to the Illinois Arts Council for the purpose of funding 18 administrative and grant expenses associated with humanities 19 programs and related activities.

20 Section 4. The amount of \$371,000, or so much thereof as 21 may be necessary, is appropriated from the General Revenue 22 Fund to the Illinois Arts Council for grants to certain 23 public radio and television stations for operating costs.

Section 5. The amount of \$5,000,000, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Illinois Arts Council for grants to certain public radio and television stations and related administrative expenses, pursuant to the Public Radio and Television Grant Act.

1 July 1, 2001.
