- 1 AN ACT concerning vehicles.
- 2 Be it enacted by the People of the State of Illinois,
- 3 represented in the General Assembly:
- 4 Section 5. The State Finance Act is amended by adding
- 5 Section 5.570 as follows:
- 6 (30 ILCS 105/5.570 new)
- 7 <u>Sec. 5.570. The Choose Life Fund.</u>
- 8 Section 10. The Illinois Vehicle Code is amended by
- 9 adding Section 3-654 as follows:
- 10 (625 ILCS 5/3-654 new)
- 11 <u>Sec. 3-654. Choose Life license plates.</u>
- 12 <u>(a) The Secretary, upon receipt of an application made</u>
- in the form prescribed by the Secretary, may issue special
- 14 registration plates designated as Choose Life license plates.
- 15 The special plates issued under this Section shall be affixed
- 16 only to passenger vehicles of the first division and motor
- vehicles of the second division weighing not more than 8,000
- 18 pounds. Plates issued under this Section shall expire
- 19 <u>according to the multi-year procedure established by Section</u>
- 20 <u>3-414.1 of this Code.</u>
- 21 (b) The design and color of the plates is wholly within
- 22 <u>the discretion of the Secretary, except that the phrase</u>
- 23 "Choose Life" shall be on the plates. The Secretary may allow
- 24 the plates to be issued as vanity plates or personalized
- 25 <u>under Section 3-405.1 of this Code. The Secretary shall</u>
- 26 <u>prescribe stickers or decals as provided under Section 3-412</u>
- of this Code.
- 28 (c) An applicant for the special plates shall be charged
- 29 <u>a \$25 fee for original issuance in addition to the</u>

- 1 appropriate registration fee. Of this \$25 fee, \$10 shall be
- 2 <u>deposited into the Choose Life Fund and \$15 shall be</u>
- 3 <u>deposited into the Secretary of State Special License Plate</u>
- 4 Fund, to be used by the Secretary to help defray the
- 5 <u>administrative processing costs.</u>
- 6 For each registration renewal period, a \$25 fee, in
- 7 <u>addition to the appropriate registration fee, shall be</u>
- 8 charged. Of this \$25 fee, \$23 shall be deposited into the
- 9 Choose Life Fund and \$2 shall be deposited into the Secretary
- of State Special License Plate Fund.
- 11 (d) The Choose Life Fund is created as a special fund in
- 12 the State treasury. All moneys in the Choose Life Fund shall
- be paid, subject to appropriation by the General Assembly and
- 14 approval by the Secretary, to the Department of Children and
- 15 <u>Family Services (DCFS). DCFS must dispense these moneys as</u>
- 16 grants to non-governmental, not-for-profit crisis pregnancy
- 17 <u>centers whose services are limited to counseling and meeting</u>
- 18 the physical needs of pregnant women. These moneys shall not
- 19 <u>be distributed to any agency that is involved or associated</u>
- 20 <u>with abortion activities, including counseling for or</u>
- 21 <u>referrals to abortion clinics, providing medical procedures</u>
- 22 <u>related to abortion, or advertising that supports abortion.</u>
- 23 These moneys may not be distributed to any agency that
- 24 <u>charges a fee to women for services received. Agencies that</u>
- 25 <u>receive these moneys must use the moneys to provide for the</u>
- 26 <u>material needs of pregnant women, including clothing,</u>
- 27 <u>housing</u>, <u>medical</u> <u>care</u>, <u>food</u>, <u>utilities</u>, <u>and</u> <u>transportation</u>.
- 28 These moneys may not be used for administrative expenses,
- 29 <u>legal expenses, or capital expenditures.</u>
