And so, this is -- this will help us to make sure that those who are children in custody of DCFS are cared for as their making their transportation between the foster home and back to the parents. This is generally when a -- when a young man or woman becomes independent and moves out of the foster home. I don't know of any questions to answer but I'm happy to take any. Studies have shown that forty-two to seventy-one percent of prescribed opioids ultimately go unused by the patient, which means that the path to opioid addiction often starts in the home medicine cabinet. But flushing medicines down the toilet or throwing them in the garbage can contaminated ground and drinking water where it cannot be filtered out. This bill provides an alternative by establishing a statewide program to provide for the safe and secure collection of disposal of medications. Illinois would be a lead on product The Drug Take-Back Act establishes a statewide stewardship. convenient standard and authorizes collection sites, as well as consumer education, to ensure that people understand where they can drop off or mail back unused and unwanted drugs. This bill is

### SENATOR McCONCHIE:

Thank you, Mr. President. Ladies and Gentlemen of the Senate. I'd like for us to pause for a moment to honor the life of one of my constituents and an important Illinois leader, the late Richard Duchossois, who passed away on January 28th. Mr. Duchossois was

born in Chicago on October 7th, 1921. He served in the U.S. Army during World War II and during that time in which he was assigned to the six-hundredth and tenth tank destroyer battalion and served as commander of the tank destroyer company throughout five different European campaigns under General George S. Patton. Survived a gunshot wound during that time, recovered, and instead of going home, returned back to the front, leading his company through famed operations, such as the Battle of the Bulge. He was awarded the purple heart, bronze star and the Order of St. Maurice Upon returning home, Mr. Duchossois, joined his family's rail cart parts business, the Thrall Car Manufacturing Company in Chicago Heights, where he helped grow the company from thirty-five employees to three-thousand by the time that it was sold in 2001. Mr. Duchossois is probably best known for his association with Arlington Park, the thoroughbred race track that is located in Arlington Heights. After an electrical fire destroyed the entire facility in 1985, he galvanized his employees to hold the famed Arlington Million Race just days after the fire, and this fate -- feat became a horse racing legend known as the 'Miracle Million'. He turned around and then championed the real -- rebuilding of that facility making it one of the most amazing horse racing facilities in the entire world and was inducted into the National Museum of Racing and Hall of Fame in 2019. His first major philanthropic gift was to the University of Chicago Medical Center in 1978, where he supported world renowned experts in lymphoma, including Dr. John Ullman as the first director of the Cancer Research Center at the University of Chicago. He lived for a hundred years and Mr. Duchossois left an indelible impression upon our State as a decorated war hero, renowned entrepreneur,

horse racing icon, and philanthropist, as well as family man. One of the benefits that we have by being in the Senate is the opportunity to meet some truly amazing people. I met Mr. Duchossois during my first year in the Senate, back in 2016, and despite us being nearly fifty years apart in age, we immediately bonded, probably not least of which was because we were both veterans who served in the infantry. We're joined in the gallery today by his daughter Kim, grandson Oliver, and Tony Petrillo, the President of Arlington Park, which is where I first met Mr. and Mrs. Duchossois. And for any of you that ever-visited Arlington Park, you knew that Mr. Duchossois was ever the consummate host. He was always bustling around the confines of the track ensuring that all who came, young and old alike, were having a good time and hopefully winning a little bit of money. So, Mr. President, I'd like to ask for a moment of silence to honor the life and legacy of Mr. Richard Duchossois.

Thank you very much, Mr. President. I rise today on this thirteenth annual Transgender Day of Visibility to recognize the hardship that the transgender community faces every day. This year so far, seven transgender people have already lost their lives in Chicago, including my own constituent, the late Elise Malary,

who was found dead in Lake Michigan last week and who scores of people in my district are now grieving. Despite our best efforts, far too often, the transgender community faces discrimination, violence, and an abject disregard for their humanity. So, on this day it behooves us to think more about how we can serve transgender people across Illinois, either by showing them a sign of support or by-passing legislation that directly benefits their right to exist. This is progress that I encourage my colleagues to scaffold upon to envision real change for the transgender community. Visibility and recognition are a good first step in supporting this community because it moves us closer to creating what Dr. Martin Luther King, Jr. called the "beloved community", an environment where everyone is supported and respected, no matter their gender identity or expression. Chicago Therapy Collective, a leading LGBTQ+ rights organization in my district, and former home of my now deceased constituent Elise Malary, has a mission of "trans-inclusive" Chicago, particularly within creating a neighborhoods on Chicago's north side that I represent. So, it is my hope that this - in this "trans-inclusive" focus outside of Chicago we can expand that to the rest of our State. Doing so, will allow transgender people to live and thrive wherever they desire in our State, free from violence, discrimination, and disrespect. That's why I support and partner with organizations like Brave Space Alliance, the first Black-led and trans-led LGBTQ+ Center located in Chicago, dedicated to creating and providing affirming, and culturally appropriate resources and programming for LGBTQ individuals all across this State. So finally, to the diverse transgender communities across Illinois, parents, siblings, veterans, artists, playing every single imaginable role

Senate -- House Bill 5581 designates that part of Route 21, otherwise known as Milwaukee Avenue, from Sangamon Street in Chicago to Greenwood Road in the Village of Niles is designated as the Milwaukee Avenue Polish Heritage Corridor. I -- this -- I -- I have contacted the Illinois of Transportation and Chicago Department Department Transportation and this particular road, the majority of it, is under the purview of the Department of Transportation and it -oh, the Illinois Department of Transportation. Given the fact that we have a sizeable Polish community in Chicago and the Chicagoland area, it's more than one-million and the fact that individuals have migrated from Poland since the 1830's. Chicago is also the traditional capital of the Polish diaspora in the U.S. I urge an Aye vote. Thank you.

But there are twenty, twenty road designation bills in Assignment, your side and ours, from military, law enforcement, fire, that have been killed in the line of duty. From one of your Members, a Pontoon police beach -- a Pontoon police officer who was killed just recently in the line of duty, from one of your Members. A corporal killed in south Vietnam, myself, I have a few, many Members have some. My opposition here is to this process. we're going to name a road, I'm fine with that and I'm not going to second guess anybody, but in this case, I am second guessing the process because people who died in the line of duty, we shouldn't dishonor them, we shouldn't dishonor their family, their -- you know, their families waiting for this. It's the least we can do, it's the least we can do. Some of these have been waiting multiple years to be called and here we are we're going to name the Milwaukee Avenue Corridor and that's fine, but priorities. These twenty plus people who served our State, served our nation and died in defense of us, they deserve their road name too, and gosh dang it, I don't know what happened to this process. House passes them all the time, as a matter of course, you know why? Because it's the right thing to do, that's why. It's the right thing to do to honor those who paid the ultimate sacrifice. This Body use to do that. We use to do it as a matter of course.

I know I'm probably going to be the only one to vote No here, and it's absolutely not out of any disrespect to the sponsor or to the Polish people, but it is out of respect for these other people who -- who absolutely deserve to have a road named after them too. They paid the ultimate sacrifice. That's why I'm voting No. Mr. President, I appreciate your indulgence for letting me explain my vote. Thank you.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Pacione-Zayas, to close.

## SENATOR PACIONE-ZAYAS:

I just urge an Aye vote for the Polish community in the State of Illinois. Thank you.

PRESIDING OFFICER: (SENATOR MUÑOZ)

#### SENATOR HARMON:

Thank you, Mr. President. Ladies and Gentlemen of the Senate. Last year the General Assembly passed House Bill 2778 in an attempt to deal with issues of paid administrative leave and sick leave for teachers in light of the pandemic and the resulting interruption of the school year. The Governor vetoed that bill but sent back, with his veto, a message to the General Assembly suggesting that we take this course instead. This bill embodies that veto message and deals with both paid administrative leave and sick leave for teachers and other school employees, as well as paycheck protection and retroactive pay. It was negotiated with the two unions that represent teachers, as well as other unions representing employees in the public schools. I'm not aware of any particularized opposition. I ask for your Aye votes.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Is there any discussion? Senator Tracy, for what purpose do you seek recognition?

#### SENATOR TRACY:

Thank you. We have a -- I -- I would like to ask some questions of the sponsor, Mr. President.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Sponsor indicates he will yield.

#### SENATOR TRACY:

President Harmon, do we have any estimate of what the fiscal impact would be for the school districts with this bill being passed?

PRESIDING OFFICER: (SENATOR MUÑOZ)

President Harmon.

No, we do not.

## SENATOR TRACY:

Do we have any idea how many -- well first let me ask, if I'm understanding this bill, it requires that we're going to allow pay concessions for sick days for those teachers or that have been vaccinated only? It only applies to vaccinated individuals, correct?

PRESIDING OFFICER: (SENATOR MUÑOZ)

President Harmon.

## SENATOR HARMON:

Thank you, Mr. President. Thank you for the question, Senator. It does -- it creates a certain set of benefits for people who have taken all of the necessary steps to comply with public health guidance, which would include the vaccination.

Senator Tracy.

#### SENATOR TRACY:

So those for -- those individuals who, for whatever reason, are not vaccinated, whether they have health restrictions that require them not to be vaccinated, this law will not reimburse them for those sick days, correct?

PRESIDING OFFICER: (SENATOR MUÑOZ)

President Harmon.

## SENATOR HARMON:

Thank you, Mr. President. Thank you, Senator. No, not -not quite. If you have a medical exemption or religious exemption

under federal law, then you would still qualify for the enhanced administrative leave issues.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Tracy.

#### SENATOR TRACY:

Thank you for that clarification. So, you do believe that those that have a medical exemption from the vaccine could still be eligible for the sick pay benefits, correct?

PRESIDING OFFICER: (SENATOR MUÑOZ)

President Harmon.

#### SENATOR HARMON:

Thank you, Mr. President. Yes, I believe that to be true, Senator.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Tracy.

## SENATOR TRACY:

And, do you have any opposition to this bill?

PRESIDING OFFICER: (SENATOR MUÑOZ)

President Harmon.

#### SENATOR HARMON:

Thank you, Mr. President. I am not aware of any opposition. I know that there were groups opposed to the first iteration in committee yesterday. I believe that there were five opponents, if I recall correctly. It appeared to be four members of one family or at least four people who all shared the same last name and a fifth individual, but nobody testified against it.

Thank you, Mr. President. Senator, I believe that's correct. Although, in the COVID world all the Sessions seemed to blend together a little bit.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Tracy.

### SENATOR TRACY:

With that, I certainly agree. And I think it was Veto Session, I believe so. And I think it -- it had quite a great bit -- great of support and -- and I believe we had a lot of support on this side of the aisle. The Republicans, many of them did support it, and then it changed. And it's the change that we have paused, and not supporting for several reasons, and certainly it seemed like this was a requirement by the Governor's Office and it seemed to put some people in an unfair position. Thank you.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Leader McConchie, for what purpose do you seek recognition? SENATOR McCONCHIE:

To the bill.

PRESIDING OFFICER: (SENATOR MUÑOZ)

To the bill, Senator.

#### SENATOR McCONCHIE:

Thank you, Mr. President. I did support the original bill on this. I would've preferred that we try to override that veto and run that bill instead of doing this one. I do have concerns in

regards to -- yeah, really two-fold. One of which is putting the vax mandate in law, the Governor's tried through multiple ways to have a vaccine mandate, he's been struck down by the courts and otherwise, and this seems to be yet another attempt for him to get a vaccine mandate. For some people in the law, my bigger concern here actually though, is the fact that this interferes with -this is going to be treating different -- two different employees who are in the -- and under the same collective bargaining in a school differently. Some getting benefits, some not, based on the kind of personal decisions that they've made and their reasons for doing so are going to be personal, and they -- and it's going to apply even in circumstances, for example, if you have two different teachers, one whose vaxed, one is not vaxed, and they both have a child who gets sick, maybe their child hasn't had the opportunity of getting a vaccine, and they need to take off work in order to care for that child, one of them will be able to care for somebody else and get this benefit and the other will not. And I just don't think that is a place of the General Assembly to be getting involved in this, in which we're dividing up people under the same collective bargaining agreement. So, with that I respectfully urge a No vote. Thank you.

PRESIDING OFFICER: (SENATOR MUÑOZ)

President Harmon, to close.

#### SENATOR HARMON:

Thank you, Mr. President. Thank you, Ladies and Gentlemen for a respectful debate. I do want to emphasize one point. This is not a vaccine mandate. There's no requirement that one be -- be vaccinated in -- to work in the public schools. It is however to the leaders point, essentially an incentive, if you take an

affirmative step to be better prepared to be in the school, you get a new benefit. To the collective bargaining point, two members of the same collective bargaining unit, one of whom is pursuing a master's degree, one of whom is not. This to me is analogist, if you are taking an affirmative step to be better prepared to be in the classroom or in the school, you have an enhanced benefit. So, with that, I ask for your Aye votes.

SENATOR D. TURNER:

Thank you, Mr. President. I think that we all remember, January 4th, 2022, when Deidre Silas was killed, horrifically, after she was doing nothing more than going about her business and doing her job that she gets paid to do every single day. I know

that there are a lot of issues that have come forward with regard to DCFS and I'm not saying that this bill is the end-all, be-all to address all of those, but I think that all of us are really trying to approach the issues around DCFS from an administrative, as well as of legislative vantage point, and I -- I think that -that's what I've tried to do. I've tried to work with all the stakeholders and look at all the things that we can do administratively different rules and regulations, and protocols that we can put into place and things that we can give our workers so that they can be better prepared to do their jobs and be safer while they're doing those jobs. This bill, House Bill 3850, is one of those things that I think we can do from a legislative vantage point to help our workers be safer as they're going about their daily work. House Bill 3850 amends the aggravated battery statute to provide that a person who is over the age of twentyone who commits aggravated battery against a caseworker, or investigator, who they know to be working for the Department of Children and Family Services, while that individual is performing or attempting to perform their official duties is in, of course, charged with aggravated battery. I have worked -- I know that there are some opponents to the bill and I have worked with all of them to try to come to a resolution so that we can move this bill I spent many hours on zoom and in face-to-face conversations. So again, this is just one -- one piece of the whole battery of things that we're trying to put together in order so that our DCFS caseworkers will be safer as they go about doing their job. And I would ask for an Aye vote.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Is there any discussion? Senator Tracy, for what purpose do

Thank you, Mr. President. I stand in strong support of this All of us represent workers, DCFS workers, who put themselves in harm's way for protection of children. We've passed a lot of bills this General Assembly, I think we had one regarding foster care today, that asked DCFS workers to do above and beyond what they've already been asked to do. They are short staffed, they are overstressed, they're overworked. We have more children that need their services. We have to give them the best protection that we can -- we can. I -- I talked to a group of young social workers, students actually, from Western Illinois University just last week and just chatting with them, many of them will not go into work for the Department. They'll go other avenues and -- and pursue a career in social work, but they don't want to be put into harm's way like the -- the staff at DCFS. We've got to do more to protect them and I applaud, Senator Turner for bringing this bill. I know in the past, over in the House, Representative Tony McCombie had a bill when one of her constituents had been brutally murdered working as a DCFS worker. I know Senator Stewart has had a similar bill here. I just urge all of you, these are our constituents, all of us have workers. We want to give them the best protection possible. They're protecting our vulnerable children that need their services. When they go to a door, they need something that's going to protect them better than what we've given them so far. So, I -- I urge your support and I'm glad you brought this bill. Thank you.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Rose, for what purpose do you seek recognition?

First of all, this is -- I think a great thing that we're finally doing a penalty enhancement for this. It's too bad it took a death to do it. I mean that's the problem with this. Some things are right and some things are wrong, but it shouldn't take a death to make everybody realize what's going on, by the way that's not aimed at the sponsor, at all. DCFS, my constituents asked for self-defense training and mace, and you know what they were told by their superiors? No mace, and if you want to do selfdefense training, you can take the day off work and pay for it yourself. What -- what is going on? When did the good guys get -- become the bad guys? When did the good guys get treated like dirt by their bosses? When did we as a society say, that we don't have a duty to protect the men and women that go out every day to, not just protect us in the streets as police officers, but in the case to protect children from evil? So, yeah, it's about damn time we did have a penalty enhancement for this and you know what else we need? We need mace for these people. We need self-defense training, paid for by us, not paid for on their own dime on a day off. These people work in -- walk in harm's way and shame, shame on the DCFS administration for letting -- for not training these people and telling them to go pay for it themselves and not equipping them with what they need to be as safe as possible and we all know you can't eliminate everything. You can't stop everything. This bill, this has been around forever, and it wasn't

till somebody died that it becomes a priority. Shame on the administration.

## SENATOR D. TURNER:

I -- I appreciate the bipartisan support for this bill. - I would go back to it -- it -- to Senator Rose, I understand what you're saying. I would go back to what I said in the beginning, that I am continuing to work on administrative protocols and -- and procedures that we can put in place. It's an ongoing conversation. It will not be lost, your words are not lost on me, and we will continue to aggressively look at how we can do everything that, in our power, so that our caseworkers and investigators are safe when they're doing their job. This is -is a, you know, a personal thing for me as well, because I have close relatives that are social workers and caseworkers within this system and I am -- I hear what -- I -- I heard from people the other day during another discussion that everyone wants to go home at the end of their work day. And DCFS caseworkers and investigators want to go home at the end of their work day. So, I appreciate the bipartisan support and I would appreciate an affirmative vote. Thank you.

bills that we have seen in education that help give administration at our schools some relief during COVID and if you will talk to them, they're incredibly busy trying to make sure their schools are open, their schools are safe, that they're trying to put plans into place to close the learning gap, and bills like this is just one example of how we're trying to give the administration some relief, just for this time frame, which will free up some of their time in order to do -- deal with the pandemic that they've been dealing with in the schools. So, again, I ask for an Aye vote. PRESIDING OFFICER: (SENATOR MUÑOZ)

So, this -- I'm going to disagree with my colleague who just spoke. This is -- this you got to cut the cord. And this isn't during the COVID emergency pandemic of the last two years, this is next year, which we haven't even seen is going to be an issue yet, it could be, it could be. In which case and time, we could come back here and address it, if and when it is. But eventually, you got to cut the cord. We got in my area - I've got a teacher who is showing their kids in the classroom the video that they did during COVID on the virtual learning, which by the way was utterly useless virtual learning, as a whole, but the virtual learning video that was shown that they filmed for the whole semester, that's what they do. The kids come in and they sit in their chairs in the school and the teacher puts on a screen and then they have

them watch the lectures they gave on virtual learning. gets better. If you didn't understand something, you ask the teacher and the teacher says, well go watch the video. Call me crazy, but that person needs to be evaluated. That person needs to be evaluated. And so, it's all about where you're going to cut the cord and I realize that reasonable people can disagree, but you're not saying that this is going to apply next year when we haven't even gotten there yet. So, if -- if we get there and the pandemic reemerges, you can deal with it then, as you did then last two years by emergency order. But why are we prospectively doing this? Let's cut the cord, let's try to get as back to normal as possible and for goodness' sake let's let principals get back into the evaluation business, so we can return to excellence in education by having excellent teachers in the classroom and the evaluation process is an important part of that. I'm not going to fault or yell or scream or anything else and anybody that disagrees on the timing. But eventually, you've got to cut the cord and we are now essentially looking forward and declaring a pandemic's going to come again - next school year 2022-2023. That's what the bill did or that's what the sponsor said it did. So, I'm going to vote No. It's time to cut the cord.

It requires DCEO to develop a program to award grants to organizations to distribute subsidies — sorry about that, to individuals participating in an apprenticeship program, pre-apprenticeship program or a work-based learning program. The proponents are, the Illinois State Conferences of IBEW, Safer Foundation, and — and Employed Women. I know of no oppositions and I would ask for an Aye vote.

Is there any discussion? There being none, the question is, shall House Bill 5225 pass. All those in favor will vote Aye. Opposed, Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 54 voting Aye, 0 voting Nay, 0 voting Present. House Bill 5225, having received the required constitutional majority, is declared passed. Senator Stewart, for what purpose do you seek recognition? House Bill 5265, Senator Gillespie. Mr. Secretary, read the bill.

Senator Gillespie.

#### SENATOR GILLESPIE:

Hi, House Bill 5265 waves "school fees" for students experiencing homelessness. This will apply to public schools. It already applies to charter schools under a federal law and this will make it consistent across public, as well as, private schools. I urge an Aye vote.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Any discussion? Senator Rezin, for what purpose do you seek recognition?

#### SENATOR REZIN:

Sure. Thank you, Mr. President. To the bill, please.

PRESIDING OFFICER: (SENATOR MUÑOZ)

To the bill, Senator.

## SENATOR REZIN:

Thank you, Mr. President. I rise in support of this bill. I know we've had two competing bills on this topic. I just feel that this bill is a little bit more defined and gives more clarity to administration on -- on how to help with this issue. So, I rise in support of the bill. Thank you.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Rose, for what reason do you seek recognition? SENATOR ROSE:

Question of the sponsor.

## SENATOR ROSE:

So, Senator, about ten minutes ago we had House Bill 4243, which -- which your side voted Yes on, our side largely voted No, which does - like anybody and then this is a more narrow version which gets to the point of poverty, and you shouldn't have your transcript withheld if you're in poverty, so we're going to vote for this. But assuming this were to pass, we now have two completely different versions out there. Which side is it that - which one do we want, as a Body, because we just passed -- we're getting ready to pass two different things?

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Gillespie.

#### SENATOR GILLESPIE:

Hi, Senator Rose, and the -- appreciate the question. The bill we just passed replies to the holding of diplomas, grades, transcripts. This is waving fees that will allow students to participate in extracurricular activities. It already applies to charter schools under the federal law, so I don't view it as being a narrower version of the first bill, it is addressing two different issues.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Rose.

#### SENATOR ROSE:

Right. But the other one was about waiving fees and we're waving fees again, but the difference here is, you have to be poverty, right? This is the more narrow version? Homeless, only? PRESIDING OFFICER: (SENATOR MUÑOZ)

## SENATOR GILLESPIE:

Hi, the first one isn't waving fees. The vote we voted on before, it's just not -- not allowing the withhold of transcripts for somebody that can't pay the fee. This one is waving fees while they're actively in school for -- for homeless -- kids experiencing homelessness so that they can participate in the full school experience.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Rose.

#### SENATOR ROSE:

Okay. Hi, back, by the way. So, I -- but -- okay you say tomato, I say tomato, alright? That's what that is. If you're not going to hold back the transcript until they pay, you've effectively waived the fees. You might not have said that explicitly, but that's the effect. I mean, that's what it is, because you're not collecting the fees, ergo you've waived the fee. So, I guess my question -- forget it, to the bill, Mr. President.

PRESIDING OFFICER: (SENATOR MUÑOZ)

To the bill, Senator.

#### SENATOR ROSE:

Look our sides going to vote for this I believe, because this is the narrower version to accomplish the goal, which is to help people who are in poverty or homeless not be held hostage because they can't afford to pay. The last version would have meant Bill Gates could stiff the school district and there's nothing they could do about that and that's kind of ridiculous. So, we're going to go ahead and vote for this, I believe. It's going to pass. I

guess the Governor will have to sort out which one he wants to sign into law. It would be pretty hilarious if he signs them both not knowing the difference just like this Body did five minutes ago. But given that this is Illinois, I'll put a dollar down right now that that's exactly what happens. Thank you.

Senator Gillespie, to close.

#### SENATOR GILLESPIE:

I just thank -- urge an Aye vote to allow homeless kids to participate in the full range of school services, like they can in private charter schools. Thanks.

Senator Aquino.

## SENATOR AQUINO:

Thank you, Mr. President. This bill simply creates a task force that is specific towards Internationally-Licensed Health

We're trying to cut the red tape to allow for health care professionals to enter the field of a health fair -- health care industry that is certainly in need of nurses, and doctors and so forth. So, that's what this task force would allow for and so, I ask for an Aye vote but willing to answer any questions.

Is there any discussion? Any discussion? There being none, the question is, shall House Bill 5465 pass. All those in favor, vote Aye. Opposed, Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 53 voting Aye, 0 voting Nay, 0 voting Present. House Bill 5465, having received the required constitutional majority, is declared passed. Page 2 of the Calendar. Senate Bills 3rd Reading. Senate Bill 1104. Senator Harris seeks leave of the Body to return House {sic} (Senate) Bill 1104 on the Order of 2nd Reading. Leave is granted. On the Order of 2nd Reading. House Bill 1104 -- Senate Bill -- correction, Senate Bill 1104. Mr. Secretary, are there any Floor amendments approved for consideration?

## SECRETARY ANDERSON:

Floor Amendment No. 1, offered by Senator Harris.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Harris, on your amendment.

#### SENATOR HARRIS:

Seek its adoption and will explain on 3rd.

Any discussion? All those in favor will say Aye. Opposed, Nay. The Ayes have it, and the amendment is adopted. Are there

## SENATOR HARRIS:

Thank you, Mr. President. Members of the Senate. Senate Bill 1104 establishes the Illinois Regional Generation Reliability Task Force to study the reliability of the Illinois Regional Power Grids and provide findings and recommendations for -- in order to improve stability. There is some opposition. I -- I've talked to the opposition about some of their concerns and their concerns was centered around potential rollbacks of CEJA. I assured them that that's not the intention of this task force, or more so, to -- remain focused on the testing the reliability of what we did and to monitor the grid reliability. And to develop - and two, to - is to evaluate the impact of those proposed policies. And with that, I seek an Aye vote.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Is there any discussion? Senator Rezin, for what purpose do you seek recognition?

SENATOR REZIN:

Thank you, Mr. President. To the bill, please.

PRESIDING OFFICER: (SENATOR MUÑOZ)

To the bill, Senator.

#### SENATOR REZIN:

Thank you. Ladies and Gentlemen of the Senate. I commend the Senator for having a bill regarding reliability and your energy sector. It's something that we've talked about, as we've been talking and discussing energy for the last two years. We - when we go through our energy portfolio, we want to make sure our portfolio reduces carbon, is cost effective to the ratepayers, is resilient, meaning when it's the coldest of cold days or the hottest of hot days, that the power that you have available is available during that -- during that weather spell. And then lastly, reliability. Reliability when you have ten days of a hundred degrees. You need to make sure that we have enough energy on the grid system for everybody whose running their air conditioners. Reliability, when it's twenty below zero or forty below zero and we don't have enough power and we've seen in other States where there's not -- not enough power available to all of the customers during these extreme weather conditions. Reliability, when your coal plants, that we've talked about, go offline and the new power of wind and solar is not yet available or built out to backfill the power plants that go offline. Reliability, to make sure that when you put the -- go to turn the lights on, the lights go on. This is a task force that looks at reliability throughout the entire State. Now, for those of us in the PJM, which is the northern part of Illinois, I would say the reliability issue for us is not as concerning, as definitely it is for the MISO territory, which is southern Illinois. After passing

this bill, we have numerous coal plants that are going offline in southern Illinois and we have no power ready to set to generate to backfill that so, technically in Illinois, southern Illinois, when we have weather this summer and it's a hundred degrees ten days in a row, there's not enough power, we have a problem. And many of you know when the air conditioner doesn't go on, when the lights don't go on, when it's a freezing twenty below degree day, when we have a polar vortex and our furnaces aren't kicking on. What happens? We get calls, from our constituents, wondering why we haven't addressed reliability issues in this State. We've seen it in Texas. We all know what that looks like in Texas. When you have extreme weather conditions and the grid systems are not prepared for reliability. I know it's something that we typically have not talked about in the past two years, but I do commend this sponsor. We're not changing any of the negotiations from the last energy bill that we agreed on and worked on for two years, but this is a task force to make sure that this State's energy portfolio has the mechanism to create reliability on the north -across the entire State, especially in MISO. Those of you who are working in the energy world will always tell you that the MISO RTO has a huge reliability problem because of all of the huge generators that are going offline prematurely. So, I stand and rise, this is a task force, this is only a task force. I stand and rise to the sponsor. I had the same bill, it didn't get out but I'm glad that you have it, to my friend across the aisle, and support a bill that puts a task force together that starts to look at an issue that may not be important today, but I tell you this summer when it's hot and you have two weeks of over a hundred degrees temperature and we have problems with our grid system,

you're going to wish that you had voted for this bill. So, I stand in support of this bill and thank the sponsor. Thank you, Mr... PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Hastings, for what purpose do you seek recognition? SENATOR HASTINGS:

Thank you, Mr. President. To the bill.

PRESIDING OFFICER: (SENATOR MUÑOZ)

To the bill, Senator.

#### SENATOR HASTINGS:

Ladies and Gentlemen of the Senate. I want to make this a quick announcement. In the committee, this was on the Agreed Bill List. All the Members of the committee agreed that this was necessary, not only because it did not undermine the underpinnings of the Clean Energy Jobs Act, or the Energy Transition Act is what its formally known as, I want to make sure that's very clear. This bill is necessary because, to the previous speakers point, reliability is something that our committee holds very, very important. It's a bipartisan issue to ensure that the lights do go on. This bill is a task force bill. This bill does not have any binding resolution. But this bill is also a reminder of one key component, Illinois has one of the broadest - broadest portfolios of energy generation in the entire country. We are a leader. Let me say that again. We are a leader in energy generation across the country. This bill is not only a reminder for our entire State to look at the reliability of our grid, but this bill should be a precursor. A precursor to go ahead and look into other forms of energy that we have right here at our finger tips and I hope that other Members of our General Assembly, which I know are starting to look at those other -- other portfolios,

other sources of energy, and I think that'll help us expand our base and expand our leadership position as a leader in energy policy and energy generation throughout the country. Mr. President, I urge an Aye vote. And I thank the sponsor for bringing this bill forward.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Bush, for what purpose do you seek recognition?

SENATOR BUSH:

To the bill.

PRESIDING OFFICER: (SENATOR MUÑOZ)

To the bill, Senator.

SENATOR BUSH:

So, I'd - I'd like to maybe clarify a few things for myself. My understanding is that the environmental community did ask to testify and was not allowed to testify, that there's been no negotiations that have happened with either the Sierra Club or the IEC and I would -- wonder if the sponsor would be able to answer that. Were they allowed at the table? Were they part of the negotiations? Were they allowed to testify in committee?

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Bush, you said to the bill. Now you asking -- are you asking him to yield for a question?

SENATOR BUSH:

My apologies, halfway through, I decided I would ask a question. So, will the sponsor yield.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Sponsor indicates he will yield.

SENATOR BUSH:

Thank you.

## SENATOR HARRIS:

Yes. Thank you, Senator Bush. This particular piece of legislation was on the Agreed Bills List. They were reached out to, to see if they had any particular changes to the task force, they didn't at the current time. I spoke with the representative yesterday about the concerns and I told that representative that those concerns will be handled in the House.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Bush.

#### SENATOR BUSH:

Thank you. I'd suggest that's a far cry from being allowed at the table and from being allowed to testify in committee. So, now, if I may, to the bill.

PRESIDING OFFICER: (SENATOR MUÑOZ)

To the bill, Senator.

## SENATOR BUSH:

As the Chair of the Environmental Committee for the last eight years, I would ask Members to take a look at who is on the task force. Look, these are a lot of our friends that are a part of this. We want to make sure that we're protecting jobs for labor and that we're protecting our grid. But I would suggest that after such a heavily negotiated bill, there should've been heavy negotiations to make these changes. And I'm reminded of something that happened to me, my freshmen year, and I really hope that Leader Kimberly Lightford is here. She negotiated a bill for two years called Senate Bill 7, as a young freshman I came in and thought, hmm, I found this little problem with this bill and of

course, she'll just want to fix it. It took me months talking to her, saying I think there's just a little problem with the bill. And we got to a place where she invited me to a room to talk to the people that had put Senate Bill 7 together. After I was done sucking wind because I couldn't believe all the people that were in there and that had negotiated this. I worked with her for almost two years to make a small change to a very, very important piece of legislation. Clearly, I was right. She saw the error of her ways, but truly, that's how negotiations work and to do this to CEJA without that attention to detail to me, is wrong. I would ask for a No vote. I would remind Members that the Sierra Club, the IEC are opposed and they do score and they will score on this. I want you to know that and I want too, to be clear for me, I stand in opposition to this kind of negotiations. On that side of the aisle, I hear you talk many times about how things move much too quickly, years to put CEJA together, and no one was at the table to make this change. Thank you.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Bryant, for what purpose do you seek recognition? SENATOR BRYANT:

Thank you, Mr. President. To the bill.

PRESIDING OFFICER: (SENATOR MUÑOZ)

The bill, Senator.

## SENATOR BRYANT:

I would just like to remind everyone in here that this is a task force. It's a task force to talk about some of the issues that I don't think got enough attention when the negotiations were done. If the -- if the stakeholders that were just mentioned by the previous speaker want to be at the table, I believe that I

just heard the sponsor of the bill say, that they could get added on when they go over to the House. But as someone who lives in the MISO district or in the MISO region, we're very concerned that during this summer and during next winter we are not going to have enough power to cool or heat our homes because a lot of the things that were negotiated in the previous bill, the bill that had — that was mentioned, were not considered. This is a task force just to make sure that we've covered everything that can be covered so that everyone in this State has the opportunity to have good — a good power grid. Right now, we're very concerned about the power grid. We'd just like to have a conversation. And I appreciate the sponsor putting the task force together to make sure that we've crossed every 't' and dotted every 'i' and that everyone's voice and needs have been heard. Thank you.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Rose, for what purpose do you seek recognition? SENATOR ROSE:

To the bill.

PRESIDING OFFICER: (SENATOR MUÑOZ)

To the bill, Senator.

## SENATOR ROSE:

I want to thank the sponsor for bringing this forward. This is extremely important to downstate Illinois. The monkeying around that happened last year on this bill, will put our ability to generate power cheaply and efficiently and turn the lights on over the next half century to century, it didn't -- it put it in jeopardy. And we need to know that when we flip the switch, it's not going to cost us an arm and a leg and the power and the lights are going to come on. So, thank you for doing this and I'm looking

forward to voting for it. Thank you.

Senator Harris, to close.

#### SENATOR HARRIS:

Thank you, Mr. President. Just like to clear up a few things that were stated during the debate about the opportunity of not to participate during committee. Each and every person had an opportunity to submit written and oral testimony to the committee. The Members of the committee agreed, for this piece of legislation, to be on the Agreed Bills List. Each and every Member had an opportunity to read the testimony that was written into the report and I never shied away from anyone who called the -- to speak on this legislation. With that being said, this is not an attempt to crawl back anything that was voted on previously under the CEJA Act. This task force, I repeat this task force, is about reliability. It's about keeping the lights on. So, if we want to keep the lights on, I suggest everyone hit the green buttons. Thank you, Mr. President.

## PRESIDING OFFICER: (SENATOR MUÑOZ)

The question is, shall Senate Bill 1104 pass. All those in favor, vote Aye. Opposed, Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 32 voting Aye, 15 voting Nay, 0 voting Present. House Bill 1104, having received the required constitutional majority, is declared passed. ## SENATOR MORRISON:

Thank you, Mr. President. House Bill 4242 makes four changes. It makes parenting youth in care automatically eligible for child

care. And when you think about parenting youth in care it's most likely a teen mom. The bill also makes families who are receiving Extended Family Support Program services automatically eligible for that. A good way to think about that are grandparents, aunts and uncles who are in extended family support systems. Thirdly, it — the families who are involved in a Child Welfare System makes them automatically eligible for Early Intervention Programs. And fourth, it requires DCFS to reimburse child care providers at the same rates paid to providers by DHS for CCAP. Happy to answer questions.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Is there any discussion? Senator Syverson, what purpose do you seek recognition?

SENATOR SYVERSON:

Thank you, Mr. President. Question for the sponsor.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Sponsor indicates she will yield.

## SENATOR SYVERSON:

Senator, I know we talked about this in committee but currently, if these -- in many cases you're talking about teen moms as you mentioned, if they are involved in some kind of improvement, whether it's taking classes, getting treatment, in job training programs, they would already qualify for free child care, is that correct?

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Morrison.

## SENATOR MORRISON:

Yes. That's true, Senator.

PRESIDING OFFICER: (SENATOR MUÑOZ)

#### SENATOR SYVERSON:

And the concern with this one is, it waives all those requirements, and so, we're saying to this young individual in most cases, that we're going to take care of all your child care and you don't have to be involved in anything to improve, but, you know, improve yourself. We want to help these people get out of the situation we're in, which is why under CCAP we require that they be in a program where they're working their way out of these situations, where they're not dependent upon bad people, they're not in bad situations. And yet, in this change, we're making these mothers or parents, do not have to be involved in any kind of training, job -- job training, or education or getting treatment or anything else. Is that -- is that correct between this program and what the current CPAP -- CCAP Program is?

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Morrison.

## SENATOR MORRISON:

The bill does not require any participation like that, you're right.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Syverson.

#### SENATOR SYVERSON:

Thank you. So, that was my concern again that -- that I have with this legislation. The goal of these program is to help move these individuals out of bad situations, move them out of poverty and to become independent. And this really changes that for this group of individuals where, I believe, if we really want to help them, we're going to guide them into programs that are going to

help them move out of that. So, for that reason, I need to stand in opposition to this bill. Thank you, Mr. President.

And while I sincerely hope that every teen mom does take advantage of the programs, the education, the training, the substance abuse services that might be there, for the teen mom that does not do that, that small child that is her responsibility, most likely, will find itself in an even more precarious predicament and the extra set of eyes that child care provides, I think, could go a long ways to keeping that little child safe and on track. I would ask for a favorable consideration and an Aye vote from everyone.

And what this resolution does, it establishes March 31st as "César (Estrada) Chávez Day" in -- in Illinois. But I wanted to tell you just a little about my own personal story with this. I was fortunate enough to work with César Chávez for six years. When I came out of seminary, I was recruited by the National Farmer Co-Ministry, which my denomination, which I'm ordained into United Church of Christ, participated and supported the United Farm Workers, so, we worked all over. I -- I - it was the luckiest thing of my life because I met my wife, who we're now going to celebrate our 46th wedding anniversary, working for the farm workers. She was an intern student from Cleveland State University and it just was a thrill of a lifetime. What an important man this was in our history. I watched him as he worked and really gave inspiration to farm workers all throughout, really all throughout the country. We were lucky enough, before we moved to Peoria, to live in La Paz, California, which is the headquarters of where the farm workers headquarters were and we saw as César would gather the community together to talk about the different victories that we had had in organizing farm workers. He always had with him his two trusty German Shepherds, Huelga and Boycott. And you could hear the cries at the rallies always, Viva La Huelga, Viva La Voce, Viva César Chávez. So, I'd appreciate support on this. I just want to share this with you, a couple days ago, my wife and I were looking through boxes of photos, which is what you do when you get old, and came across this. This is when I was twenty-three years old here, I was the head of the Farm Workers

Boycott Office in Dayton, Ohio, and I had organized a big support rally for union people to come and to listen to César, with me is Eliseo Medina, who was Vice President of the union, he later became the number two person in -- for the SEIU in Washington, D.C., César Chávez and Emil Mazey who was Secretary Treasurer of the UAW under Walter Reuther, and I'll leave it up here if you care to stop by and see it. But, please join me in supporting this to declare today, as César's birthday. "César Chávez Day" in Illinois.

#### SENATOR HUNTER:
