13. And with him are the various commanders of the various veterans  
14. organizations of the State, and I believe you have their names,  
15. Mr. President. And, I would appreciate if we would have an in-  
16. troduction of these fine and honorable gentlemen to the Senate  
17. today.

18. PRESIDENT:

19. Yes, Senator ... I'm pleased ... to introduce to the Senate  
20. ... this delegation of ... hard working, dedicated men in the  
21. field of interest in veterans affairs and activities. Their Chair-  
22. man is John Walsh ... from Chicago ... Chairman Walsh.

23. CHAIRMAN WALSH:

24. Mr. Speaker, Chaplain, ladies and gentlemen, it's as Chairman  
25. of the State Commanders Commission, I'd like to thank you today  
26. for inviting us here, and I'd also would like to thank you for your  
27. support in Veterans Bills in the past and hope that in the future  
28. that we can still have the same support. I want to thank ...  
29. Senator Mitchler and Larry DePrema, known as the DePrema and Mitchler's  
30. Army, for inviting us here today. Thank you very much.

32. The Associates with ... Chairman Walsh are ... this ... fine

3. PRESIDENT:

4. The Chair would ... admonish that the ... Governor's message  
5. is going to be broadcast live, so we should proceed over to the  
6. ... hall of the House ... just as rapidly as we can. We will ...  
7. hopefully stay on track here. ... Messages from the House.

9. A message from the House from Mr. Selcke.

28. PRESIDENT:

29. Executive Committee. Oh, I'm sorry. Senator Hynes.

31. Mr. ... Mr. President, I would ask that all Senators be shown

4. Well, I'm certain we all join in the motion to suspend  
5. the rules for the immediate consideration. All in favor of  
6. Senator Hynes' motion signify by saying aye. Contrary nay.  
7. On the motion to adopt. Is there debate? All in favor  
8. signify by saying aye. Contrary nay. The Resolution is  
9. adopted.

13. PRESIDENT:

14. Senator Mohr.

15. SENATOR MOHR:

16. Mr. President, I move ... the adoption of the ... the

19. Senator Mohr moves the adoption of the Adjournment Reso-  
20. lution. The Chair wishes to point out that Senator Partee and  
21. I discussed the need for an additional legislative day next

2. President. The Appropriations Committee will meet next Wednes-  
3. day, March 14. The following bills are going to be heard. I  
4. don't propose to do this each time, Mr. President, but I thought  
5. this time I would take a moment to read them. There're just a  
6. few. SB 134, 142, 165, 171, 174, 182, 200 and 222. HB 71 and  
7. 201 ... if any sponsor has an objection to these bills being  
8. heard, they can certainly contact me or my office and the bill  
9. will be taken off the call. And, in the future, Mr. President,  
10. it is ... my thinking and the Minority Spokesman think ...  
11. thinking that no bills will be set for hearing even though there  
12. assigned to our committee without a request from the sponsor.  
13. Thank you.

14. PRESIDENT:

15. ... Senator Netsch, did you seek rec ... recognition?  
16. Senator Netsch.

17. SENATOR NETSCH:

18. Mr. President, if this is an appropriate time, may I ask leave  
19. to have my name added as a co-sponsor to Senate Joint Resolution  
20. 20 introduced yesterday.

21. PRESIDENT:

22. Senator Netsch seeks leave of the Body to be added as a  
23. co-sponsor of Senate Joint Resolution 20. Is there leave? So  
24. ordered. Senator Clarke.

25. SENATOR CLARKE:

26. Mr. President, around the order of motions, I'd like to  
27. comment on a bill that came up yesterday, the first subsidy  
28. bill reading that we discussed. SB 21, the sponsor, Senator  
29. Chew, ran into a little bit of difficulty. I started off  
30. the questioning because you are about to go to a vote, and I  
31. felt some of the members might want to look at it a little  
32. more carefully. ... I think that there are maybe some problems.  
33. The bill was put on postpone consideration and after dis ...  
wasn't it postponed?

1. PRESIDENT:

2. No. The bill ... was declared ... declared lost. Yes.

3. SENATOR CLARKE:

4. Well, then having voted on the prevailing side and with  
5. the assurance that Senator Ozinga and others have suggested a  
6. possible amendment would have an opportunity the bill would  
7. be brought back to 2nd reading. I am going to make a motion  
8. today to reconsider.

9. PRESIDENT:

10. Senator Clarke moves to reconsider the vote by which  
11. SB 21 was defeated, be reconsider. All in favor - is ... is  
12. the motion understood? All in favor signify by saying aye.  
13. Contrary nay. All in favor of the motion signify by arising.  
14. Be seated. The Secretary counts 34 Senators supporting Senator  
15. Clarke's motion, so the bill is ordered to the order of 3rd  
16. reading. And I understand that the announcement by the sponsor  
17. has been made, that at the appropriate time, we will recall the  
18. bill to 2nd reading for consideration of an amendment. Senator  
19. Graham.

20. SENATOR GRAHAM:

21. I'd like to move, Mr. President, after talking with the  
22. sponsors and the Chairman of the two respective Committees of  
23. Revenue and Local Government that SB 192 now in ... that we  
24. discharge a Committee of Revenue from consideration of SB 192  
25. and have it re-referred to the Committee on Local Government.

26. PRESIDENT:

27. ... Senator are you ... are the ... are you the Chief  
28. sponsor of ... of 192.

29. SENATOR GRAHAM:

30. The Chief sponsor is Senator Berning, so I understand, and  
31. he asked me to make the motion.

32. PRESIDENT:

33. Senator Graham has moved that SB 192 be discharged from the

1. Committee on Revenue and re-referred to the Committee on Local  
2. Government. All in favor of the motion signify by saying aye.  
3. Contrary nay. The motion is carried and the bill is re-referred

13. PRESIDENT:

14. Senate bills 2nd reading. Senate bills 2nd ... notice  
15. Senator McCarthy is not ... yes ... yes he is returning. Senator  
16. McCarthy. Advance.

17. SECRETARY:

18. SB 23.

19. (Secretary reads title of bill)

20. 2nd reading of the bill. No Committee Amendments.

21. PRESIDENT:

22. Any amendments from the floor? 3rd reading. Senate bill  
23. 49. Senator Moore. Don Moore.

24. SENATOR DON MOORE:

25. ... Yes, Mr. Speaker, in Committee Mr. ... excuse me ... Mr.  
26. President ...

27. PRESIDENT:

28. Yeah.

29. SECRETARY:

30. SB 49.

31. (Secretary reads title of bill)

32. 2nd reading of the bill. The Committee on Local Government offers  
33. one amendment.

2. Senator Moore.

3. SENATOR MOORE:  
4. I believe there were two amendments ... to that bill,

6. PRESIDENT:  
7. That is correct. There are two amendments.

8. SENATOR DON MOORE:  
9. ... In so far as Amendment No. 1 is concerned, I would  
10. ... move at this time to table Amendment No. 1, Mr. President.

11. PRESIDENT:  
12. Senator Moore has moved to table Committee Amendment No. 1.  
13. All in favor signify by saying aye. Contrary nay. The amend-  
14. ment is tabled. Senator Moore.

15. SENATOR MOORE:  
16. At this time Mr. ... President, I would move to ... move  
17. the adoption of Amendment No. 2 which is the Home Rule Amend-  
18. ment to ... SB 49.

19. PRESIDENT:  
20. Is there further discussion? On the motion to adopt Com-  
21. mittee Amendment No. 2. All in favor signify by saying aye.  
22. Contrary nay. Amendment No. 2 by the Committee is adopted.

23. SECRETARY:  
24. Amendment No. 3 by Senator Moore.

25. PRESIDENT:  
26. Senator Moore.

27. SENATOR DON MOORE:  
28. Thank you, Mr. President. Amendment No. 3, Mr. President,  
29. is the same as Amendment No. 1 insofar as it applies to  
30. cities and villages, but it was the ... feeling of the ... the  
31. fire protection district people in the State of Illinois that  
32. they also wanted to be included in this bill. Amendment No. 1  
33. took them out of the bill. Amendment No. 2 or ... excuse

1. Amendment No. 3 puts them back in. And at this time, I would  
2. move the adoption of Amendment of No. 3.

3. PRESIDENT:

4. All in favor of the adoption of Committee Amendment No. 3  
5. signify by saying aye. Contrary nay. The Amendment is adopted.  
6. Are there Amendments from the Floor? 3rd reading. SB 72.  
7. Senator Sours. SB 81. Senator Don Moore.

8. SECRETARY:

9. SB 81.

10. (Secretary reads title of bill)

11. 2nd reading of the bill. The Committee on Local Governmnet  
12. offers one Amendment.

13. PRESIDENT:

14. Senator Moore.

15. SENATOR MOORE:

16. Thank you, Mr. President. Amendment No. 1, Mr. President,  
17. inserts the word published after the word circulation so as to  
18. insure that the publication will be made in a newspaper that  
19. is circulated in the proposed enlargement of the dis ... or the  
20. Corporate Limits of the Metropolitan Sanitary District of Greater  
21. Chicago. And, I would move it's adoption at this time, Mr. Presi-  
22. dent.

23. PRESIDENT:

24. Is there further discussion? All in favor of the adoption  
25. of the amendment signify by saying aye. Contrary nay. The amend-  
26. ment is adopted. Any amendments from the Floor? 3rd reading.  
27. SB 104. Senator Sours. SB 118. Senator Don Moore. ... Did you  
28. want to call one of those Senator ... Senator Sours. I'm sorry, I  
29. thought you were asking for the series to be ... which ...

30. SENATOR SOURS:

31. ... Mr. President, Senators I have ... amendments in each  
32. of bills, 10 ... in each of the bills 105, 106 and 139. They're  
33. on the Secretary's desk. We'll take 105 first.

1. PRESIDENT:

2. All right. SB 105. Senator Sours.

3. SENATOR SOURS:

4. The amendment ...

5. SECRETARY:

6. Sen ... Senator Sours, I do not have any amendment for  
7. 105. I have three amendments here for ... for the next bill.

8. SENATOR SOURS:

9. All right. ... This amendment ... Mr. President and  
10. Senators, is an amendment suggested by Al Green. The bill, it-  
11. self, permits the summoning of a grand jury and a petit jury by  
12. letter. ... It appears that the practice was and is in Chicago  
13. to send a notice to serve on a grand jury or a petit jury by  
14. ordinary mail. That's all this amendment does. It permits  
15. single circuit counties such as Chicago and DuPage to ... to  
16. ... send it by ordinary mail. The ... the other counties such  
17. as Peoria will ... the courts will summon the grand jurors and  
18. the petit jurors by registered or certified mail. I move the  
19. adoption of the amendment.

20. PRESIDING OFFICER (SENATOR GRAHAM):

21. Secretary read the bill by title, please.

22. SECRETARY:

23. SB 105.

24. (Secretary reads title of bill)

25. 2nd reading of the bill. Amendment No. 1 by Senator Sours.

26. PRESIDING OFFICER (SENATOR GRAHAM):

27. You have heard the explanation of Senator Sours' Amendment.  
28. Will you read the amendment, please? Oh you ... you've heard  
29. the explanation of Senator Sours' Amendment. We're not going to  
30. read it. It's about ten pages. ... Is there any discussion on  
31. the amendment? Senator Sours moves the adoption of Amendment  
32. No. 1 to the SB 105. All in favor signify by saying aye. Opposed.  
33. Amendment is adopted. 3rd reading. SB 106.

1. SECRETARY:

2. SB 106.

3. (Secretary reads title of bill)

4. 2nd reading of the bill. No Committee Amendments. Amendment ...

5. PRESIDING OFFICER (SENATOR GRAHAM):

6. Senator Sours has an amendment.

7. SECRETARY:

8. Amendments 1, 2 and 3 by Senator Sours.

9. SENATOR SOURS:

10. Mr. President, Senators, I'll explain these amendments.  
11. Let's take the one, if you don't mind ... it's all on everybodys'  
12. desk. On page 1, line 32, it's a very short amendment. And it  
13. states that the party to be examined shall be free from Venereal  
14. Disease as indicated by the test ... by this test and examination.  
15. Now these details were gone over very carefully in the Committee  
16. and apparently this is a solution to some of the objections of-  
17. fered at the Committee. And I would move that ... that ... I

19. amendment ... on page 1, line 32. What ... what amendment number  
20. is that, Mr. Secretary?

21. SECRETARY:

22. By deleting the word request?

23. SENATOR SOURS:

24. Yes.

25. SECRETARY:

26. That'll ... that'll be Amendment No. 1.

27. SENATOR SOURS:

28. All right. I move the adoption, Mr. President and Senators.

29. PRESIDING OFFICER (SENATOR GRAHAM):

30. Senator Sours moves the adoption of Amendment No. 1 to

31. SB 106. Any discussion? All in favor will signify by saying

32. aye. Aye. Senator Partee ... I'm sorry.

19.          Now, just one question. You eliminate the word all, which

20.          will ... says all venereal disease and you eliminate all. What

21.          ... what is the purpose there Senator? Maybe I missed ...

22.          SENATOR SOURS:

23.          Senator, I don't know whether you were present the day we

24.          had ... we had two hearings on this by the way. But, it seems

25.          like ... the female participant to a prospective marriage is

26.          reluctant and often times refuses to have a pelvic examination.

27.          SENATOR PARTEE:

28.          A what?

29.          SENATOR SOURS:

30.          A pelvic examination.

31.          SENATOR PARTEE:

32.          Oh, pelvic, I see ... yes.

33.          SENATOR SOURS:

1. That's the medical term, Senator.

2. SENATOR PARTEE:

3. I ... I went to medical school one day, at my brother's  
4. place.

5. SENATOR SOURS:

6. ... And ... you see the any objections you might have would  
7. probably more ... be more appropriate on 3rd reading. I'm try-  
8. ing to get this bill in such a shape that it will be the best  
9. bill possible whether it's attractive to you is another matter.  
10. But, that's ... that's the reason we took out the word all.

31. SECRETARY:

32. Amendment No. 1 by Senator Sours.

33. SENATOR SOURS:

1. Mr. President, this was a bill in the Elections Committees  
2. ... presided over by Senator Moore and there was some ... question  
3. about its affecting existing tendencies. This is the bill that  
4. prohibits the trafficking in politics on Election Day ... to the  
5. extent that it ... it increases the distance ... from 100 feet to  
6. 500 feet. There was some con ... concern lest it might ... touch  
7. upon existing tendencies. So this bill ... the amendment simply  
8. says nothing in this Amendatory Act of 1973 shall affect any  
9. real estate tendencies in effect at the time. This Amendatory
