2. SENATOR BLOOM:

3. Thank you. Yeah, the amendment adds Chicago, apparently
4. it only dealt with downstate, now this takes care of Chicago.
5. I'd seek its adoption.

6. PRESIDENT:

7. Senator Bloom has moved the adoption of Amendment No. 1
8. to Senate Bill 566. Is there any discussion? If not, all
9. those in favor signify by saying Aye. All opposed. The Ayes
10. have it. The amendment is adopted. Further amendments?

11. SECRETARY:

12. No further amendments.

13. PRESIDENT:

14. 3rd reading. Senator Regner; for what purpose do you
15. arise?

16. SENATOR REGNER:

17. Mr. President, yesterday we skipped moving Senate Bill
18. 485 off of 2nd reading due to a problem with some amendments
19. and that. It is of an emergency nature, it's a transfer
20. under supplemental appropriation for the Department of Law
21. Enforcement. I'd ask leave of the Senate to return to Senate
22. Bill 485 for a consideration on 2nd reading at this time.

23. PRESIDENT:

24. You heard the request. Is leave granted? Leave is
25. granted. On the Order of Senate Bills 2nd reading, Senate
26. Bill 485. Read the bill, Mr. Secretary.

27. SECRETARY:

28. Senate Bill 485.

29. (Secretary reads title of bill)

30. 2nd reading of the bill. The Committee on...Appropriations II
31. offers one amendment.

32. PRESIDENT:

33. Senator Buzbee. He yields to Senator Regner. Committee
34. Amendment.

1. SENATOR REGNER:

2. Yes, Mr. President, I'm going to move that the committee
3. amendment be Tabled. During the hearing on this bill there
4. were many questions raised about the operations within the
5. department over the last year. They have not been totally
6. resolved as far as a solution other than to say that when they
7. do get this supplemental that amount of money will be reduced
8. under FY'80 Budget. There were some problems with...erroneous
9. appropriations in the original FY'79 Budget and there were
10. some problems with the hiring of various personnel. However,
11. if we don't give them the entire amount of money, we are going
12. to have problems in funding the State Trooper's salaries, the
13. Public Aid Fraud Unit and various other units and we also will
14. wind up in the Court of Claims with these problems. We've
15. met with the director and his aids numerous times and for
16. several hours and just this morning and we have agreed, in spite
17. of the various operations that we question, that we were going
18. to go ahead, Table this amendment and allow them the six hundred
19. and ninety thousand dollars supplemental appropriation they were
20. asking to alleviate any potential problems we'll have this year.

21. PRESIDENT:

22. Senator Regner has moved to Table Amendment No. 1 to Senate
23. Bill 485. Is there any discussion? Senator Buzbee.

24. SENATOR BUZBEE:

25. Thank you, Mr. President. Mr. President, in the Appropriation
26. Committee hearings that were held last spring for FY'79 budgetary
27. request, the Senate Appropriations II Committee made various
28. rearrangements, reallocations, cuts and so forth in...in
29. various agency budget requests. We made the smallest cut per-
30. centage wise in the Department of Law Enforcement of any agency
31. in State government. Out of approximately a seventy-two million
32. dollar budgetary request, we cut about six hundred and seventy
33. thousand dollars or nine tenths of one percent. We told the

1. department that they were to live within that budget. They
2. agreed that they could, but they didn't. And now we're in
3. the position with the new director coming in in January or
4. February to take over this department. He has the budgetary
5. deficiency of some six hundred and seventy or eighty thousand
6. dollars, ironically almost dollar for dollar the amount we
7. cut from them last spring. He's asked for a transfer authority
8. of some additional two million dollars from one line item to
9. the other. It was the...it was the feeling of the committee
10. that we should not allow all of those dollar amounts to be
11. the supplemental appropriation. However, the director says
12. that he absolutely cannot live without the supplemental appropria-
13. tion. My position is that I think that we have to make our
14. stance at some point or another and say that we, the General
15. Assembly, are fulfilling our constitutional obligation, which
16. is to appropriate and oversee the expenditure funds. There
17. comes a time that I sometimes think that maybe we're just
18. kidding ourselves by sitting here in the General Assembly
19. and appropriating dollars, because the bureaucrats seem
20. to go ahead and spend it regardless of what our intention is.
21. Once in a while we get somebody's attention, we think we're
22. about to start doing good things for the taxpayer and then
23. the Governor goes and signs contracts with labor organizations
24. which cost us an additional fifty-eight million dollars this
25. coming Fiscal Year and then presents us with the bill. Perhaps
26. we really ought to become a benevolent dictatorship in this
27. State, let the Governor and the bureaucrats run everything and
28. get the elected representatives, the people out of...out of
29. the business of trying to protect taxpayer dollars because
30. nobody seems to pay much attention anyhow. The time will come,
31. I think, when...when the taxpayers of this State are going
32. to start raising hell with...with the folks who...who make
33. these kinds of decisions, but in the meantime, we seem to be

1. the pawns in...in a huge big chess game over which we have
2. absolutely no control. I'm opposed to the move that Senator
3. Regner is making, however, I don't want to be one that is
4. charged with rape, pillage, plunder and murder being the
5. order of the day in the State of Illinois because the State
6. of Illinois because the General Assembly was not farsighted
7. enough to allow the additional seven hundred thousand dollars
8. in supplemental funds. So I'm going to...oppose Senator
9. Regner's position, but knowing that it, apparently is going to go
10. ahead and happen.

11. PRESIDENT:

12. Senator Martin.

13. SENATOR MARTIN:

14. Will the sponsor yield?

15. PRESIDENT:

16. Sponsor indicates he will yield. Senator Martin.

17. SENATOR MARTIN:

18. Are the people that were responsible for the advice given
19. to the old director still on the payroll after last week?

20. PRESIDENT:

21. Senator Regner.

22. SENATOR REGNER:

23. Yes, but not in the presence of the Senate.

24. PRESIDENT:

25. Senator Martin.

26. SENATOR MARTIN:

27. I do not know how...when those people remain on the payroll,
28. we...you can actually say that the director is acting in good faith.
29. And Senator Regner, it's my own party's department, I...I realize,
30. and certainly I don't think this is a...a vote for rape, pillage
31. and everything else. But if the director won't respond by that
32. obvious very basis first step, I...I think we're just being
33. fools. We're being taken advantage of. If you came in and said

1. they were gone, then I'd say, ah hah, he's moving, he understands.
2. But when you can say, no, they're still there and that by his
3. comment, he values their counsel, un huh.
4. PRESIDENT:
5. Any further discussion? Senator Regner's moved to Table
6. Amendment No. 1 to Senate Bill 485. Senator Rhoads.
7. SENATOR RHOADS:
8. Just to request a roll call on the motion.
9. PRESIDENT:
10. That request is in order. Senator Regner has moved to
11. Table Committee Amendment No. 1 to Senate Bill 485. Those
12. in favor of the motion to Table will vote Aye. Those opposed
13. will vote Nay. The voting is open. Have all voted who wish?
14. Have all voted who wish? Take the record. On that question
15. the Ayes are 32, the Nays are 21, the motion prevails, the
16. amendment is Tabled. Are there any further amendments?
