Senator Rock.

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Amendment No. 5 reflects the increase in the per diem allowance that we passed last week, and it is...it is an addition to the Comptroller's budget of some five hundred and sixty-four thousand dollars. I would move adoption of Amendment No...it's not No. 1, it's number something...5.

Amendment No. 1 offered by Senator Carroll.

SENATOR CARROLL:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. This is a normal Court of Claims awards bill. Amendment No. 1 would add the awards from April, the introduction date, through May, another nine hundred and seventy-eight thousand eight hundred, those that have been signed by the court, and I would move its adoption.

PRESIDING OFFICER: (SENATOR DEMUZIC)

Senator Carroll moves the adoption of Amendment No. 1 to Senate Bill 1546. Any discussion? Any discussion? If not, those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 1 is adopted. Any further amendments?

Amendment...Amendment No. 2 offered by Senator Kustra.

PRESIDING OFFICER: (SENATOR DEMUZIC)

All right, Senator Sommer has asked leave of the Body to handle the amendment in Senator Kustra's absence. Is leave granted? Leave is granted. Senator Sommer.

SENATOR SOMMER:

Mr. President and members, this provides fifty-one thousand five hundred and thirty-five dollars for WOO and Associates. WOO for architects who...who are not paid because the funds had...had lapsed or run out. It's a legitimate claim, and we...we recognize its legitimacy and we're placing it on the bill here. It originally it emanated from Senator Kustra.

PRESIDING OFFICER: (SENATOR DEMUZIC)

All right, Senator Kustra seeks...has moved the adoption of Amendment No. 2 to Senate Bill 1546. Is there any

discussion? Senator Kelly.

SENATOR KELLY:

I'd like to ask the gentleman a question.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Indicates he will yield, Senator Kelly.

SENATOR KELLY:

Yes, Senator, can you tell me, this architectural work...what is this fifty or fifty-one thousand dollars, what structure did they provide the architectural work for?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Sommer.

SENATOR SOMMER:

According to my notes, they provided it for three projects; the Washington Elementary School, Dixmore High School and King Elementary School.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Kelly.

SENATOR KELLY:

And as...after doing the work, they were...why wasn't...why were they not eligible to receive compensation for that?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Sommer.

SENATOR SOMMER:

Senator Carroll says he knows the answer.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Carroll.

SENATOR CARROLL:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Senator Kelly, the...the problem here was a court of claims award would have been made had there been lapsed funds, but that period had gone by. They had apparently received some of their money. The amount appropriated had run out by this amount. There was no lapse; therefore, the

court of claims by law cannot give the award but what we've been having them do and what they did in this case is give us an advisory opinion that the work was, in fact, performed, performed within the contract terms, and absent the jurisdictional issue there could have been a court of claims award and they recommended the payment. That's a new system we've developed for these kind of cases so they can act as a buffer for us to be a fact finder and that's what they did in this case.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Sommer moves the adoption of Amendment No. 2 to Senate Bill 1546. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 2 is adopted. Any further amendments?

PRESIDING OFFICER: (SENATOR DEMUZIO)

3rd reading. Top of page 6, Senate Bill 1547. Senator Rock seeks leave of the Body to return Senate Bill 1547 to the Order of 2nd Reading of the purpose of an amendment. Is leave granted? Leave is granted. On the Order of 2nd Reading, 1547, Mr. Secretary, please.

SECRETARY:

Amendment No. 2 offered by Senator Rock.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Rock.

SENATOR ROCK:

Thank you. Mr. Secretary, this is the amendment for fifty thousand additional dollars for the Printing line. As I'm sure everybody is well aware, the cost of living has...gone up, not the least of which is the Printing line for the Illinois General Assembly. We print everything for everybody, and I would move adoption of Amendment No. 2.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Is there any discussion? Any discussion? Senator Rock has moved the adoption of Amendment No. 2 to Senate Bill 1547. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 2 is adopted. Any further amendments?

SECRETARY:

Amendment No. 3, by Senator Rock.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Rock.

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Last week I indicated that when we adopted and approved the amendment to Senate Bill 1850 which called for the restructuring of the commissions that a certain amount of the four million dollar savings would, in fact, be put into the General Assembly line item for use of the standing committees. This amendment, Amendment No. 3, puts in two hundred and fifty thousand dollars for the express purpose of allowing the standing committees to exercise their rights and use consultants and make sure that the public has adequate input. I would move the adoption of Amendment No. 3.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Any discussion? Any discussion? Senator Rock moves the adoption of Amendment No. 3 to Senate Bill 1547. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 3 is adopted. Any further amendments?

SECRETARY:

No further amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

3rd reading. Senate Bill 1548. Senator Rock seeks leave of the Body to return Senate Bill 1548 to the Order of 2nd Reading for the purpose of an amendment. Is leave granted? Leave is granted. On the Order of 2nd Reading, Senate Bill 1548, Mr. Secretary.

SECRETARY:

Amendment No. 1 offered by Senator Rock.

PRESIDING OFFICER: (SENATOR DEMUZIC)

Senator Rock.

SENATOR ROCK:

Thank you, Mr. President. Amendment No. 1 is an additional one million dollar increase again reflecting what this Senate did last week. We increased our district allowance to the tune of twenty thousand additional dollars annually and gave the House a ten thousand dollar additional increase. This one million one reflects what we did last week, and I would move adoption of Amendment No. 1.

PRESIDING OFFICER: (SENATOR DEMUZIC)

Senator Rock...is there any discussion? Any discussion? Senator Rock moves the adoption of Amendment No. 1 to Senate Bill 1548. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 1 is adopted. Any further amendments?

SECRETARY:

No further amendments.

PRESIDING OFFICER: (SENATOR DEMUZIC)

3rd reading. Senate Bill 1549. Senator Rigney seeks leave of the Body to return Senate Bill 1549 to the Order of 2nd Reading for the purpose of an amendment. Is leave granted? Leave is granted. On the Order of 2nd Reading, Senate Bill 1549, Mr. Secretary.

SECRETARY:

Amendment No. 4 offered by Senator Bruce.

PRESIDING OFFICER: (SENATOR DEMUZIC)

Senator Rigney, I am told that Senator Bruce will be here momentarily. Is it...why don't we take this out of the record and proceed with it when he arrives on the Floor, if you like. Senator Rigney. Senator...Rigney, he's in...

SENATOR RIGNEY:

Mr. President, we will be opposed to that amendment. You do whatever you want to with it, but it's not our amendment.

PRESIDING OFFICER: (SENATOR DEMUZIC)

All right, Senator...Senator Rigney seeks leave of the Body to take Senate Bill 1549 out of the record. Is leave granted? Leave is granted. All right, Senate Bill 1550, Senator Schaffer. Senator Schaffer seeks leave of the Body to return Senate Bill 1550 to the Order of 2nd Reading for the purpose of an amendment. Is leave granted? Leave is granted. On the Order of 2nd Reading, Senate Bill 1550, Mr. Secretary.

SECRETARY:

Amendment No. 3 offered by Senator Carroll.

PRESIDING OFFICER: (SENATOR DEMUZIC)

Senator Carroll.

SENATOR CARROLL:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. This is an additional grant of seventy-five hundred for alcoholism treatment, is a matching grant to provide for bartender service to determine a...a better way of...of handling the problem at the source. The department is in agreement with this amendment, and I would move its adoption.

PRESIDING OFFICER: (SENATOR DEMUZIC)

All right, Senator Carroll moves the adoption of Amendment No. 3 to Senate Bill 1515. Any discussion? If not, those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 3 is adopted. Any further amendments?

SECRETARY:

No further amendments.

PRESIDING OFFICER: (SENATOR DEMUZIC)

3rd reading. Senate Bill 1552. Senator Sommer seeks leave of the Body to return Senate Bill 1552 to the Order of 2nd Reading for the purpose of an amendment. Is leave

granted? Leave is granted. On the Order of 2nd Reading, Senate Bill 1552, Mr. Secretary.

SECRETARY:

Amendment No. 5 offered by Senator Carrcll.

PRESIDING OFFICER: (SENATOR DEMUZIC)

Senator...Senator Carroll.

SENATOR CARROLL:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. This is the Department of Central Management Services. After discussion with the department, it was determined that we had cut a little bit too deep and this is the add-back of 1.2 million dollars to allow them to open the new buildings...the three new buildings on time. I would move its adoption.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Carroll moves the adoption of Amendment No. 5. Is there any discussion? If not, those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 5 to Senate Bill 1552 is...is adopted. Any further amendments?

SECRETARY:

Amendment No. 6 offered by Senator Sommer.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Sommer.

SENATOR SOMMER:

Mr. President and members, this creates twelve-month...funding for eighteen employees rather than nine-month funding because these positions at the Barker Building are ready to go, thought that they wouldn't be but they're now ready.

PRESIDING OFFICER: (SENATOR DEMUZIC)

Senator Sommer moves the adoption of Amendment No. 6 to Senate Bill 1552. Is there any discussion? If not, those in favor signify by saying Aye. Opposed Nay. The Ayes have

it. Amendment No. 6 is adopted. Any further amendments?

SECRETARY:

No further amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

3rd reading. Senate Bill 1554, Senator Donahue. Senator Donahue on the Floor? Senate Bill 1554. Senate Bill 1555, Senator Watson. Senator Watson seeks leave of the Body to return Senate Bill 1555 to the Order of 2nd Reading for the purpose of an amendment. Is leave granted? Leave is granted. On the Order of 2nd Reading, Senate Bill 1555, Mr. Secretary, please.

SECRETARY:

Amendment No. 3 offered by Senator Watson.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Watson.

SENATOR WATSON:

Thank you, Mr. President. This amendment reappropriates four million eight hundred and sixty-one thousand in general revenue to the Department of Corrections for development, operation and maintenance of community correctional centers. A total of five million three hundred and thirty-nine thousand five hundred dollars was appropriated for this purpose in Fiscal Year 1984, but to date, only four and seventy-eight thousand has been spent leaving an available balance of four million eight hundred and sixty-one thousand.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Watson moves the adoption of Amendment No. 3 to Senate Bill 1555. Is there any discussion? If not, those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Amendment is...No...3 is adopted...Amendment No. 3 is adopted. Any further amendments?

SECRETARY:

Amendment No. 4 offered by Senator Hall.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Hall.

SENATOR HALL:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. This amendment prohibits funds appropriated or reappropriated from being used for the expansion of buildings of a community correctional centers in Madison and St. Clair Counties. I move for its adoption.

PRESIDING OFFICER: (SENATOR DEMUZIC)

All right, is there any discussion? Senator Schaffer.

SENATOR SCHAFFER:

Mr. President, this appears to be substantive language in an appropriations bill; and while it's probably an interesting concept, I wonder if it's something we want to do and...or something we can do. I'd appreciate a ruling from the Chair on that.

PRESIDING OFFICER: (SENATOR DEMUZIC)

Senator Carroll.

SENATOR CARROLL:

Thank you. On the same parliamentary inquiry, maybe you ought to review Senator Davidson's suggestion last year for here in Sangamon County where the same type of language was used in...in the same department for the same or similar situation and it was passed by the Senate; not that necessarily consistency is the hobgoblin of a small mind, but it would not be the first time that this Senate has so rectified a situation for this department...in this Chamber.

PRESIDING OFFICER: (SENATOR DEMUZIC)

All right, further discussion? Senator Schaffer.

SENATOR SCHAFFER:

...if it worked for them, it ought to work here, I guess. I just kind of wondered.

PRESIDING OFFICER: (SENATOR DEMUZIC)

Well, the Chair rules that it will, in fact, comply with the Statutes, there is precedent before; in fact, it is in

order. Further discussion? Senator Hall.

SENATOR HALL:

Move for its adoption.

PRESIDING OFFICER: (SENATOR DEMUZIC)

All right, Senator Hall moves the...moves the adoption of Amendment No. 4 to Senate Bill 1555. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 4 is adopted. Any further amendments?

SECRETARY:

No further amendments.

PRESIDING OFFICER: (SENATOR DEMUZIC)

3rd reading. Senate Bill 1562, Senator Sommer. Whoops, Senator Vadalabene. Senator Vadalabene, for what purpose do you arise?

SENATOR VADALABENE:

Yes, I would like to be shown as a joint hyphenated sponsor of that amendment.

PRESIDING OFFICER: (SENATOR DEMUZIC)

All right, Senator Vadalabene seeks leave of the Body to be a hyphenated cosponsor of Senate Amendment...No. 4 to Senate Bill 1555. Is leave granted? Leave is granted. It's so ordered. Senate Bill 1562, Senator Sommer. Senator Sommer seeks leave of the Body to return Senate Bill 1562 to the Order of 2nd Reading for the purpose of an amendment. Is leave granted? Leave is granted. On the Order of 2nd Reading, Senate Bill 1564, Mr. Secretary.

SECRETARY:

Amendment No. 4 offered by Senator Carroll.

PRESIDING OFFICER: (SENATOR DEMUZIC)

Senator Carroll.

SENATOR CARROLL:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. This is seventy-five thousand add-back for legal fees for the Department of Insurance. The director has indi-

cated that they had to hold back this year because of one particular case and, therefore, the spending patterns were different than what they anticipate for the future year, and we've agreed to this add-back of legal fees for the Department of Insurance for specifications.

PRESIDING OFFICER: (SENATOR DEMUZIC)

All right, Senator Carroll moves the adoption of Amendment No. 4. Is there any discussion? Any discussion? If not, those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 4 is adopted. Any further amendments?

SECRETARY:

No further amendments.

PRESIDING OFFICER: (SENATOR DEMUZIC)

Senator Carroll.

SENATOR CARROLL:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. As a result of discussions with the department on...on specific problems they are having, most particularly with tourism and with the Office of Film Development, we had agreed to add back some two hundred and sixty-four thousand eight hundred. Senator Carroll.

SENATOR CARROLL:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. This is the oil and gas add-back of some forty-four thousand four hundred to get that program underway. I would move its adoption.

PRESIDING OFFICER: (SENATOR DEMUZIC)

Senator Carroll moves the adoption of Amendment No. 4 to Senate Bill 1570. Is there any discussion? Any discussion? If not, those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 4 is adopted. Any further

amendments?

SECRETARY:

No further amendments.

PRESIDING OFFICER: (SENATOR DEMUZZIC)

3rd reading. Senator Rock, for what purpose do you arise?

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. If I can have the attention of the membership, we will tomorrow, as you know, have a committee meeting on the Committee and Finance and Credit Regulation to discuss the situation with the Continental Illinois National Bank. Additionally, Appropriations II will meet tomorrow afternoon. Senate Bill 1451, Senator Johns. Senator Johns on the Floor? Senate Bill...well, Senate Bill...1510. With leave of the Body, Senator DeAngelis, you want to handle that bill for me? Is leave granted? Leave is granted. Senate Bill 1510, Mr. Secretary.

SECRETARY:

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator DeAngelis.

SENATOR DeANGELIS:

Yeah, I'll have Senator Carroll explain it.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Carroll.

SENATOR CARROLL:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. I'd make a comment but I won't. This is the ordinary and contingent expenses appropriation for the Office of the Auditor General at approximately nine million four hundred thousand, and I would move for a favorable roll

call...or request a favorable roll call.

PRESIDING OFFICER: (SENATOR DEMUZZIC)

All right, is there any discussion? Any discussion? Question is, shall Senate Bill 1510 pass. Those in favor vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish?...have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 48, the Nays are none, none voting Present. Senate Bill 1510 having received the required constitutional majority is declared passed. 1513, Senator Rock. Read the bill, Mr. Secretary, please.

PRESIDING OFFICER: (SENATOR DEMUZZIC)

Senator Rock.

SENATOR ROCK:

SENATOR GROTEBERG:

A...is the...bill that just went passed, Senator Rock, and in all future bills, I think the sponsor should mention the dollars involved in any given appropriation to the best of his or her ability so we don't have to ask questions about how much money is involved in an appropriation bill. I don't know what the Treasurer's appropriation was.

PRESIDING OFFICER: (SENATOR DEMUZIC)

All right,...Senator Rock, for what purpose do you arise?

SENATOR ROCK:

I beg you...the gentleman's pardon. It is four hundred and forty million; two million of which...or three hundred thousand of which represents the ordinary expenses for administration, the vast majority, as I indicated and I apologize, I should have given you the dollar amount.

PRESIDING OFFICER: (SENATOR DEMUZIO)

On the Order of 3rd Reading, Senate Bill 1533. Mr. Secretary, read the bill.

SECRETARY:

Senate Bill 1533.

(Secretary reads title of bill)

PRESIDING OFFICER: (SENATOR DEMUZIC)

Senator Savickas.

SENATOR SAVICKAS:

Yes, Mr. President and members of the Senate, Senate Bill 1533 appropriates two hundred and fifty-nine thousand dollars to the Department of Law Enforcement for a grant to the Chicago Police Department for the purpose of fingerprinting school children. Since September of 1983, over seventy thousand children in private and public schools and day-care programs in the city have been printed in effort to assist local

and Federal law enforcement officials in identifying lost and missing children and children who are victims of violent crimes. Prior to the fingerprint program, the only means of identification were dental records and many small...many of the small children have never been to the dentist. Due to the shortage of funds for this program, over four hundred thousand child remain to be printed, and Senate Bill 1533 provides the funding to hire back the twelve detention aides to assist in fingerprinting to a hundred and eighty thousand children by the end of the year. I would appreciate your favorable support.

PRESIDING OFFICER: (SENATOR DEMUZIC)

All right, is there any discussion? Any discussion? Senator Schaffer.

SENATOR SCHAPFER:

Well, I certainly can't speak against the cause, it certainly is a good cause. I would respectfully remind the Body that most of the communities outside of the City of Chicago have conducted this program and continue to conduct this program at their own expense. I'm not quite sure why we will provide State funds for one community and no other community in the State. I understand the City of Chicago has problems, but I would suggest to you, there are probably some of the towns that have already done this at their own expense have probably at least proportionately even greater problems in terms of finances and...and what have you. This is not in the budget, and I...I can't justify a vote for it unless we're going to make it a Statewide program and make it a high enough priority to get it in a...a balanced budget.

PRESIDING OFFICER: (SENATOR DEMUZIC)

All right, further discussion? Senator Savickas, may close.

SENATOR SAVICKAS:

Well, Mr. President, I think I will take it out of the

record, but I would like to remind Senator Schaffer that, yes, Chicago has printed more than seventy thousand of its children already at...at their own expense. Seventy thousand children is probably bigger than half the towns that you come from, and these are the children that he's printed. So when we talk about...the amounts and the...the cost, I would tend to disagree with you. I doubt if you...in your district you have many towns that are over seventy thousand, so I will take it out of the record until tomorrow.

On that question, the Ayes are 40, the Nays are...on that question, the Ayes are 39, the Nays are 6, 10 voting Present. Senate Bill 1610 having received the required constitutional majority is declared passed. Senate Bill 1611, Senator Buzbee. Okay. Senate Bill 1621, Senator Weaver. Read the bill, Mr. Secretary, please.

SECRETARY:

Senate Bill 1621.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Weaver.

SENATOR WEAVER:

Thank you, Mr. President. This is an appropriation of six hundred and forty-five thousand dollars to replace and repair buildings as a result of fire at the University of Illinois.

PRESIDING OFFICER: (SENATOR BRUCE)

Is there discussion? The question is, shall Senate Bill 1621 pass. Those in favor vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 55, the Nays are none, none voting Present. Senate Bill 1621 having received the required constitutional majority is declared passed. Senate Bill 1639, Senator D'Arco. Do you wish to call Senate Bill 1639? Read the bill, Mr. Secretary, please.

SECRETARY:

Senate Bill 1639.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator D'Arco.

SENATOR D'ARCO:

Mr. President, this bill...it's a grant to the Department of Public Health for seventy-five thousand dollars. Eisenbergal Town Boy's Club is one of the most prestigious boys clubs around and they do have eight dental chairs in a very depressed area. The problem is they don't have the drilling and pneumatic equipment that is needed to put these chairs into functioning condition in order to allow dentists who are going to donate their time free of charge to help the people in this community with free dental clinic work on

their teeth. I think it's a tremendous idea because the dentists are willing and able to give of their time and service to these people, and I would ask for a favorable vote.

PRESIDING OFFICER: (SENATOR BRUCE)

Discussion? Senator Schaffer.

SENATOR SCHAPFER:

It's not in the budget but I don't know why.

PRESIDING OFFICER: (SENATOR BRUCE)

Is there further discussion? The question is, shall Senate Bill 1639 pass. Those in favor vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 37, the Nays are 6, 6 voting Present. Senate Bill 1639 having received the required constitutional majority is declared passed. Yes. If I might have the attention of the Body, there are several bills on the Calendar presently which cannot be called and the Secretary was asked...we would gladly open business now to have members rerefer bills back to committee. If you have a Calendar...bill...or to Table or recommit. No, you must only rerefer your own bills, but...several of the...the House bills...the...Senator Chew, do you wish to recommit 1673? Senator Chew moves to recommit Senate Bill 1673 to committee. On the motion, those in favor say Aye. Opposed Nay. The Ayes have it. The bill is recommitted. Senator Hall, do you wish to recommit your...your...Senator Hall moves to recommit Senate Bill 1749. On the motion, those in favor say Aye. Opposed Nay. The Ayes have it. And Senate Bill 1749 is recommitted to the Committee on Executive. 1892 and 93 and 94 have been excluded by rule. Senator Nedza, do you wish to do anything with 1918? All right. Senator Becker, for what purpose do you arise?

SENATOR BECKER:

Recommit 1931 to committee.

PRESIDING OFFICER: (SENATOR BRUCE)

The motion is to recommit Senate Bill 1931 to the commit-

tee from whence it came. On the motion, those in favor say Aye. Opposed Nay. The Ayes have and the bill is recommitted. Senate Bill 1932, Senator Geo-Karis. Senator Geo-Karis, would you like to recommit that bill to committee so we can cleanup...1932. Insanity defense. All right. Senate Bill 1942, Senator Marovitz. Senator Marcvitz moves to recommit 1942 to the...committee from which it came. On the motion to recommit, those in favor say Aye. Opposed Nay. The Ayes have it and the bill is recommitted. All the House bills on 3rd reading are presently subject to Rule 5. If the Senate sponsors would so desire we could recommit those bills. Yes. On page 10 and 11 of your Calendar...on 1813...Senator Bruce would move to recommit that bill to committee. On the motion, those in favor say Aye. Opposed Nay. The Ayes have it and 1813, House Bill, is recommitted. Senator Berman, do you wish to recommit 257? Motion by Senator Berman to recommit...House Bill 257. On the...on page 10 of your Calendar. The motion is to recommit House Bill 257 by the sponsor. On the motion, those in favor say Aye. Opposed Nay. The Ayes have it and the bill is recommitted. On 1020, Senator Bruce moves to recommit. On the motion, those in favor say Aye. Opposed Nay. The Ayes have it, and House Bill 1020 is recommitted. House Bill 1029, Senator Buzbee is not on the Floor. Senator Jones, 1286. All right. 433, Senator Jeremiah Joyce, you wish to recommit that bill? No. 1830, Senator Welch. Motion by Senator Welch to recommit House Bill 1830. On the motion, those in favor say Aye. Opposed Nay. The Ayes have it, and the bill is recommitted to committee. Senator Coffey on 1927. Senator Coffey moves to recommit Senate Bill...House Bill 1927. On the motion, those in favor say Aye. Opposed Nay. The Ayes have it and the bill is recommitted. Senator Berman on 2312. Last bill. Yes. Senator Berman moves to recommit House Bill 2312 to...to committee. On the motion to recommit, those in favor

say Aye. Opposed Nay. The Ayes have it. The bill is recommitted. There are four House bills on page 11 on 2nd reading, all of those are also Rule 5 bills. Senator Smith. Senator Smith moves to recommit House Bill 207. Those in favor say Aye. Opposed Nay. The Ayes have it and the bill is recommitted. Senator Rigney on 717. The motion is to Table 717. On the motion to Table, those in favor say Aye. Opposed Nay. The Ayes have it and House Bill 717 is Tabled. Page 11. Page 11, House bills 2nd reading. Page 11. We have recommitted 207, Tabled 717. Senator D'Arco on 1405. Senator D'Arco still on the Floor? For what purpose does Senator Marovitz arise?

SENATOR MAROVITZ:

I would ask leave of the Body to be listed as the chief sponsor on House Bill 3218 with permission of Senator Degnan. The bill should read Marovitz-Degnan. Switch it around, Marovitz-Degnan.

PRESIDING OFFICER: (SENATOR BRUCE)

All right. Senator Marovitz...

SENATOR MAROVITZ:

3218.

PRESIDING OFFICER: (SENATOR BRUCE)

...will act as the Senate...principal Senate sponsor. Is there leave? Leave is granted. (Machine cutoff)...have the attention of the Body. If you will turn to page 2 of your Calendar, we are also still trying to cleanup our Calendar. Page 2 is Senate Bill 31. And, Senator Collins, would you like to recommit? Motion to recommit by the sponsor. On the motion, those in favor say Aye. Opposed Nay. The Ayes have it, and Senate Bill 31 is recommitted. Senator D'Arco on 612. Senate Bill...Senator Bloom, for what purpose do you arise?

SENATOR BLOOM:

I guess you could call it a point of personal privilege

or a parliamentary inquiry.

PRESIDING OFFICER: (SENATOR BRUCE)

State your point.

SENATOR BLOOM:

That is, there's only one Senate appropriations bill that has not been acted on, or shall I say that did not make it out of the appropriations process, and at the appropriate point...it is the ordinary and contingent expenses for the Arts Council. And at the appropriate time, today or tomorrow, I would like to go to the Order of taking it from the Table, putting it on the Calendar. We've made our...our point with the other Body and making the appropriate cuts and funding level which this Body deems best and sending it on its way at the appropriate time. Thank you.

PRESIDING OFFICER: (SENATOR BRUCE)

All right. We...we...we have your motion, Senator, and we will get...if we get to motions in writing. Senator Rock, for what purpose do you arise?

SENATOR ROCK:

Well, I was just going to suggest, we are about to, I hope, allow everybody to go to their office and...and work. This is not the appropriate time. If we're going to take bills off the Calendar...tomorrow is another day.

PRESIDING OFFICER: (SENATOR BRUCE)

All right. Senator Berman, for what purpose do you arise?

SENATOR BERMAN:

Thank you, Mr. President. I would ask leave to waive the appropriate...rules so that Senate Bill 1236, which was released by Rules on Friday, would be heard tomorrow in the Committee on Finance and Credit Regulations. I was supposed to make the motion on Friday but I forgot. The...this is a bill that may be the vehicle regarding the Continental Bank situation. So, I'd ask that we have leave to have it

posted...waive the appropriate rules so it could be heard tomorrow.

PRESIDING OFFICER: (SENATOR BRUCE)

The motion is by Senator Berman to suspend the schedule requirements of Rule 5 and the posting requirements and any other...rule that will allow the bill, Senate Bill 1236, to be heard in committee tomorrow. Is there leave to suspend the rules that the bill might be heard tomorrow? Leave is granted. Further...let's see, further announcements? Senator Zito.

SENATOR ZITO:

Thank you, Mr. President. I would ask leave of the Body to add Senator Nedza as a cosponsor to House Bill 2438.

PRESIDING OFFICER: (SENATOR BRUCE)

Is there leave? Leave is granted. Senator Geo-Karis.

SENATOR GEO-KARIS:

Mr. President, Ladies and Gentlemen of the Senate, what time are we having our annual Memorial Day program tomorrow?

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Rock is recognized.

SENATOR ROCK:

Thank you. I have spoken with former Senator Mitchler and he does have an extensive program. Senator Vadalabene will be Chairing that meeting. My suggestion was and is one o'clock.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Vadalabene. Did you have...Senator Carroll, for what purpose do you arise?

SENATOR CARROLL:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. I rise for purpose of asking that a bill be discharged from committee and advanced to the Order of 2nd Reading. It's House Bill 2389. Rules Committee has let the bill out, it is emergency in nature. It's to the Downstate

Teachers' Retirement Article to allow for the credit for the...unused accumulated sick leave. We passed the substantive law a year ago but, unfortunately, it applied a date of July 1, 1984; this moves that date up to June 1, since most of those teachers retiring would be retiring at the end of the school semester which will be within the month of June and I believe that was the intent. And we had asked that therefore the committee be discharged so we can advance the bill, it has to be signed as quickly as possible to be effective to those with whom we had wanted it enacted for.

PRESIDING OFFICER: (SENATOR BRUCE)

The motion is to suspend the appropriate rules, have the bill discharged from committee, have it read a second time today and placed on the Order of 3rd Reading. Is there leave...to suspend the rules? Leave is granted. And, Senator Carroll, as soon as we get the bill down here we will read it a second time today. Senator Berman, for what purpose do you arise?

SENATOR BERMAN:

I would like to call the attention of the members, Mr. President, those of you who are tennis or racket ball professionals...everybody is a racket ball professional, right. Wednesday, June 6th, that's a week from tomorrow, is our annual legislators, staff, former legislators and lobbyists tennis and racket ball tournament. PRESIDING OFFICER: (SENATOR BRUCE)

Senator Rock, for what purpose do you arise?

SENATOR ROCK:

Thank you, just for an announcement. The Senate Rules Committee will meet tomorrow in the Office of the Senate

President at 10:30 a. m. In the meantime, for the next twenty-one hours, the subcommittee, Senator's Weaver and Savickas', will meet on a continuing basis. But the Rules Committee will meet at ten-thirty tomorrow. Session will begin at twelve-thirty to afford the Committee on Finance the opportunity to hear all the witnesses who are coming. Twelve-thirty tomorrow for Session.

PRESIDING OFFICER: (SENATOR BRUCE)

Perhaps we can clear up a few more of the...Senator Davidson, do you wish...on page 2 of your Calendar. Senator Davidson, do you wish to recommit that bill? Senator Davidson indicates to the affirmative. On the motion to recommit Senate Bill 853, those in favor say Aye. Opposed Nay. The Ayes have it. The bill is recommitted. Senator D'Arco on the Barber Act? 1356, Senator Etheredge. Senator Etheredge indicates a desire to recommit that bill to committee. On the motion, those in favor say Aye. Opposed Nay. The Ayes have it. And Senate Bill 1356 is recommitted to the committee from whence it came. Senator Kustra.

SENATOR KUSTRA:

Thank you, Mr. President. With leave of the Senate, I'd like to be added as a hyphenated cosponsor to House Bill 2837. I've discussed this with Senator Rock, the major sponsor, he's consented.

PRESIDING OFFICER: (SENATOR BRUCE)

Is there leave? Leave is granted. On page 4 of your Calendar, page 4...Senate Bills 2nd reading. Senator...Bruce would...move to recommit 1906 to committee. On the motion, those in favor say Aye. Opposed Nay. The Ayes have it. The bill is recommitted. Senator Luft on 1912. Worker's Comp. self-insurers. 1952, Senator Rock. Senator Rock moves to recommit that bill to committee. On the motion, those in favor say Aye. Opposed Nay. The Ayes have it and the bill is recommitted. 1955, Senator Egan. Senator Egan moves to

recommit that bill to committee. On the motion, those in favor say Aye. Opposed Nay. The Ayes have it and Senate Bill 1955 is recommitted. Senator Jerome Joyce, do you wish to recommit? All right. Senate Bill 445, Senator Smith. Senator Smith, do you want to recommit 445? Senator Smith.

SENATOR SMITH:
