Senator Hudson, for what purpose do you arise?

SENATOR HUDSON:

Thank you, Mr. President. With the leave of the Body, I would like to add Senator Philip as a hyphenated cosponsor to Senate Bill 108.

PRESIDENT:

The gentleman has asked leave to show Senator Philip as the hyphenated cosponsor of Senate Bill 108. Is leave granted? Leave is granted. It's so ordered. 108. Senator Vadalabene, for what purpose do you arise?

SENATOR VADALABENE:

Yes, I want to be shown as a hyphenated sponsor on Senate Bill 101.

PRESIDENT:

The gentleman asks leave to be shown as a hyphenated cosponsor of Senate Bill 101. Is leave granted? Leave is granted. It's so ordered. Senator Netsch, for what purpose do you arise?

SENATOR NETSCH:

Thank you. Mr. President, I have been requested to ask leave of the Senate for permission for the Joint Committee on Public Utilities Regulation to hold its long-scheduled hearings both today and tomorrow in Chicago. These hearings involve lots of witnesses and it would be extremely disruptive if they were undone. Technically they ought not to be holding hearings and meeting while the Senate is in Session, but I think if the Senate will agree, we should permit them to go ahead even though obviously those of us who are Senate members of the joint committee will not be present. So, in any event, my request is for leave of the Senate to permit the Joint Committee on Public Utilities Regulation to hold its already scheduled hearings today and tomorrow in Chicago.

PRESIDENT:

All right. The lady has asked leave to allow the Joint Committee on Public Utility Regulation to hold their long-scheduled meeting, and I can tell you that the schedule

conflicts only because the House and Senate was as yet undetermined as to when they were going to meet. I think the request is reasonable and she asks leave that they go ahead. Leave is granted without objection. Resolutions.

All right. Senator Watson seeks leave of the Body to be added as a hyphenated cosponsor of Senate Bill 87. Without objection, leave is granted. Senator Kelly, for what purpose do you arise?

SENATOR KELLY:

Yes, Mr. President, I'd like to also have leave of the Body on Senate Bill 144 to have Senator Sangmeister added as a hyphenated sponsor.

PRESIDENT:

All right. The gentleman seeks leave to show Senator Sangmeister as a hyphenated cosponsor of Senate Bill...what's the number, Senator Kelly? 144. Is leave granted? Leave is granted. It's so ordered. 144. Resolutions, Mr. Secretary.

SENATOR SAVICKAS:

Yes, Mr. President and members of the Senate, we're putting this joint resolution in now because the Senate...House is not in Session, and I would move its adoption.

PRESIDENT:

All right. Senate Joint Resolution No. 10 is that resolution asking that we convene in joint session next week for the purpose of hearing the Governor. It was at the Governor's request. Senator Savickas has moved to suspend the rules for the immediate consideration and adoption of Senate Joint Resolution 10. All in favor of the motion to suspend the rules indicate by saying Aye. All opposed. The Ayes have it. The rules are suspended.
