The Senate will come to order, please. The hour of twelve o'clock having arrived, the Senate will resume its Session. Please stand for the opening prayer from the Reverend Frank J. O'Hara of the St. Peter and Paul Catholic Church of Springfield.

GOVERNOR THOMPSON:

The results of the roll call are as follows, Senator Philip 26 votes, Senator Rock 30 votes. Senator Rock having received the necessary votes is hereby declared elected as President of the Senate of the 85th General Assembly. Before the presiding officer leaves the Podium, I'd like a point of personal privilege simply to say what I believe I said last time I was in this position. In my ten years as Governor and in my twenty-seven years as public life, at all levels of

government, county, state and Federal, Philip J. Rock is one of the best men that I've ever met in public life and I think he will bring honor and credit to the Senate as its President and I wish to congratulate him. Congratulations. The Chair will now ask Supreme Court Justice Ben J. Miller to administer the oath to President Rock.

SUPREME COURT JUSTICE BEN J. MILLER:

(Justice Miller administers Oath of Office to President Rock)

PRESIDENT:

Your Excellency the Governor, to my devoted wife who has waited to these many hours and to my colleagues in the Senate, I wish to thank, obviously, those who were kind enough to place my name in nomination and second that nomination and thank my colleagues on the Democratic side of the aisle for again placing their faith and trust in me and my ability. This is my fifth opportunity to shoulder this responsibility and I do not take it lightly. I will again assure you all as members of the Illinois Senate of my best effort. I have a great deal of love and respect for this institution and this Body and the people who serve in it. And I will never do anything to bring anything but honor and credit to all of us. We are in this together. And as the Governor indicated on...in his inaugural remarks, this is not going to be a particularly easy time for the people that had enough faith and confidence in us to send us here to act on their behalf. We have some very difficult days, some difficult decisions to make. I am confident that the Illinois Senate will, as it has in the past,...itself well. And again, I thank you, I am almost overwhelmed. This is really a nice day. Thank you, very much. And beside that, the hour is late, let's get moving so everybody can get going. I would like to ask the following Senators, Senators Netsch, Demuzio, Luft, Geo-Karis, Dudycz and Dunn to escort the

Governor from the Chamber and I thank him again for his patience and forbearance. Thank you, very much, Jim. I would ask...I would ask Senators Carroll and D'Arco and Jerome Joyce, Senators Hawkinson, Fawell and Barkhausen to please be kind enough to escort Justice Ben Miller from the Chamber. The Chair, on behalf of the majority, will name the following individuals as assistant leaders and whips: Senator Frank Savickas from Chicago, Senator Vince Demuzio from Carlerville, Senator Richard Newhouse from Chicago, Senator John D'Arco from Chicago and Senator Richard Luft of Pekin. Congratulations to you all. And, obviously, the Caucus Chairman will be Senator Sam Vadalabene who unfortunately is not with us but hopes to return very shortly. Senator Hudson, for what purpose do you arise, sir?

SENATOR HUDSON:

Thank you, Mr. President. Regrettably and unavoidably I missed my vote today, but had I been there, for the record, I would have cast my vote for James "Pate" Philip.

PRESIDENT:

The record will so reflect. The next order of business is the election of the minority leader. The Chair will recognize Senator Weaver.

SENATOR WEAVER:

Thank you, Mr. President. I would like to ask...request unanimous consent on behalf of the Republican members of the Senate to declare Senator James "Pate" Philip as Minority Leader of the...Senate of the 85th General Assembly.

PRESIDENT:

You've heard the request of Senator Weaver. Is leave granted? Leave is granted. It is so ordered. Congratulations to Senator James "Pate" Philip. Senator Philip.

SENATOR PHILIP:

Thank you, President Rock and my fellow Senators. First of all, I'd like to congratulate Phil Rock for being

reelected the President of the Illinois Senate. And I once again pledge my cooperation and help. I think that most people around the legislative process would have to say that Senator Rock and I, with the other legislative leaders, try to work reasonable solutions to tough problems. We may be of the opposite party but I think we're of the same philosophy, what's good for the State of Illinois is good for the people, all the people. So we will be here, we'll be a strong, loud minority, but when it gets down to solving problems you know that we'll be there and we'll try to work things out. I'd also like to thank my leaders and my members on this side of the aisle for giving me the opportunity once again to serve as your spokesman and your leader. I appreciate that and you know I will work hard at it, and hopefully come around the next election, maybe we will have two more on this side or three more on this side and we once again will return this Senate to where it should be, Republican. I also want to congratulate the three new Senators that I have on the other side of the aisle...on our side of the aisle, Senator Hawkinson, Senator Madigan, Senator Raica. Look forward to working with them. I know that you'll learn to love and respect the Senate the way I have and the way we have and I think that you'll enjoy your term of office. And it's always very difficult to sit down and figure out your leadership because we have so many deserving and well-qualified people who, quite frankly, deserve leadership and you know we can't put everybody in leadership. At this time, I would like to make my announcements, Assistant Minority Leader, Senator Weaver, Senator Davidson, Senator DeAngelis; Minority Whip, Senator Jack Schaffer, and for the first time, I think, in the history of this Body, we're going to have a lady Senator as our Caucus Chairman, Senator Geo-Karis. Thank you.

PRESIDING OFFICER: (SENATOR DEMUZIO)

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Rock.

SENATOR ROCK:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. I rise obviously to support the adoption of Senate Resolution No. 1 which will elect and appoint the officers for the 85th General Assembly. But before I place that motion and ask for a roll call, I think for all of us who have served here, and I have been here sixteen years, for all of us who have served on both sides of the aisle for whatever amount of time, I think we ought to pay tribute to and congratulate both Ken Wright and Ed Fernandes for their years of devoted service to this institution and this process. They have helped us all and we appreciate it. Now, Mr. President, I would ask that Senate Resolution No. 1 be adopted and it will require a roll call vote. It will call for Linda Hawker to be installed as the Secretary of the Senate, Danny Day as sergeant-at-arms and Tracy Sidles as his assistant and I would ask for a roll call.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Rock...indicates that we, in fact, can use the board if...if you wish. Senator Rock has moved the adoption of Senate Resolution No. 1. Discussion? Senator...Senator Geo-Karis.

SENATOR GEO-KARIS:

Point of personal privilege. Mr. President, Ladies and Gentlemen of the Senate, I want to thank my Minority Leader, Senator Philip, Senator Weaver, Senator DeAngelis, Senator Schaffer, Senator Davidson for the honor accorded to me and I appreciate being selected as the caucus chairman. I guess it's the first time in the history of Illinois that a woman

is in that position of leadership and I'm very grateful and I will do my best and, Democrats, watch out.

PRESIDING OFFICER: (SENATOR DEMUZZIO)

All right. Senator...Senator Rock has moved the adoption of Senate Resolution No. 1. The Secretary will call the roll.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Discussion? If not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Senate Resolution No. 2 is adopted. Further resolutions?

What this Senate resolution does is forms a select committee of seven, four appointed by the majority, three by the minority, to do a study by June 1 of 1987, whether there is a possibility of a dual-purpose sports' facility in the Chicagoland area. I know when I went back to my district I had a lot of people making inquiries; I've gotten a lot of letters, telephone calls, some of our members also are interested. Why are we just doing a single facility? Why aren't we thinking about maybe basketball, baseball, football? And all I'm...what we're suggesting is we do a study on it, report back to the General Assembly.

PRESIDING OFFICER: (SENATOR DEMUZIO)
