PRESIDENT ROCK:

The First Special Session of the Eighty-seventh General Assembly will come to order. Reading of the Journal, Madam Secretary. Senator Kelly.

SENATOR KELLY:

Thank you, Mr. President. I move that reading and approval of the Journal of Wednesday, June 19th; and Thursday, June 20th, in the year 1991, be postponed, pending arrival of the printed Journal.

PRESIDENT ROCK:

You've heard the motion as placed by Senator Kelly. Any discussion? If not, all in favor, indicate by saying Aye. All opposed. The Ayes have it. The motion carries, and it is so ordered. Resolutions.

SECRETARY HAWKER:

Senate Joint Resolution 12 offered by Senator Demuzio.

PRESIDENT ROCK:

Senator Demuzio.

SENATOR DEMUZIO:

Joint Resolution 12 is the adjournment resolution. It calls for us to come back Monday, June 24th, at the hour of 12:05 <sic>. I'd move to suspend the rules for immediate consideration and adoption.

PRESIDENT ROCK:

Senator Demuzio has moved to suspend the rules for the immediate consideration and adoption of Senate Joint Resolution 12. Discussion? If not, all in favor of the Motion to Suspend, indicate by saying Aye. All opposed. The Ayes have it. The rules are suspended. Senator Demuzio now moves the adoption of Senate Joint Resolution 12. Calls for us to return Monday. All in favor of the resolution, indicate by saying Aye. All opposed.
