I mean, that's -- something seems to be kind of wrong about that, contradictory to -- to existing law.

So, Senator Demuzio, being a Member of the Rules Committee, as I am, had ample opportunity to -- to file under the Senate rules - specifically under Senate Rule 7-9 - he had an opportunity to file a motion in the Rules Committee, and he failed to do so. I don't know whether he's -- whether he's sincere in his effort in this -- in this -- this rhetoric that he's come across, or whether he's just grandstanding, Mr. President. I'd just like to briefly -- briefly -- no, Mr. -- I'd like to briefly quote Senate Rule 7-9 says, "Upon concurrence of a majority of those appointed, the Rules Committee may advance any legislative measure pending before it to the Senate without referral to another committee..." Senator Demuzio failed to do so. This late hour, he's attempting - I don't know what - but he had opportunities earlier.

PRESIDING OFFICER: (SENATOR WEAVER)

Senator Cullerton, on 2182? State your point, Senator Demuzio.

SENATOR DEMUZIO:

You know, I -- I just heard that -- that speech by my friend, Walter Dudycz, who is also a Member of the Rules Committee, with respect to grandstanding. Let me just tell you: You kept a hundred and forty substantive bills in the Rules Committee. Those bills deserve a hearing in the Illinois Senate. They passed the House. You could have sent them to committee so that they could have had a hearing. You could have made whatever distribution

that you wanted to make in committee after the hearing, and you didn't do it. We asked for a discharge motion, that those bills, in fact, could be re-referred from Rules for a ample hearing. That's all we asked for. So it is not grandstanding. It is a matter of procedure here in this Body. And the fact of the matter is -- is that a hundred and forty substantive bills did not receive a hearing in the Illinois Senate. That's the matter.

Your comments will be duly noted, Senator. Senator Cullerton, do you wish 2182? Read the motion, Mr. Secretary.

SECRETARY HARRY:

I hereby move to suspend any applicable Senate rules and move to discharge House Bill 2182 from the Executive Committee to the full Senate.

We had a lot of questions -- questions, a lot of speeches, and we did have a vote. And I would recommend not passing this motion.

SENATOR CULLERTON:

Well, had I had the right to open, what I would have said, first off, was to compliment Senator Karpziel. She's absolutely right. She conducted the committee with a great deal of respect for all of the witnesses. It was a very full hearing. The bill had, I think, three of four witnesses in favor, a couple opposed. She -- I really want to extend my thanks to her for the way in which she conducted that -- that committee hearing. I just thought -- if I had a chance to open, I would have explained what the bill did, so we'd know what we were voting on. That -- the bill is House Bill 2182, which adds sexual orientation to the currently protected categories in the Illinois Human Rights Act and makes discrimination based on sexual orientation a human rights violation. Currently, protected categories in the Human Rights Act include race, religion, color, national origin, ancestry, age, gender, disability, marital status and military discharge status. Discrimination is prohibited in housing, employment, credit and public accommodations. As I said, the hearing was a full one. The bill fell one vote short in coming out of the committee. The reason why I'm filing the motion is simply that I think the subject matter is something that ought to be debated on the full Senate Floor. It is a subject matter that is very sensitive; that, as you could tell from -- if you were at the committee, people did a lot of soul-searching in deciding how to vote for it. I think that everyone on the Senate Floor ought to have that -- that right. It is a bill that is supported by a whole variety of organizations, and I think it's something that really requires education. And the best way to do that is to have a full debate on the Senate Floor, and for that reason, I filed the motion, and ask for your support.

This issue, this bill, should be heard by this Body. The vote on this motion is whether or not you, as a Body, believe the best interests of the child should be heard by this Chamber, and I ask for affirmative vote.
