## HOUSE RESOLUTION 136

Offered by Representative Ness:

WHEREAS, Breast cancer is among the most commonly diagnosed types of cancer and the second leading cause of cancer death among women in the United States; and

WHEREAS, Approximately 297,790 women will be diagnosed with breast cancer, and more than 43,000 will die with this malignancy in 2023; and

WHEREAS, Triple-Negative Breast Cancer (TNBC) is one of many forms of breast cancer and accounts for approximately 15 to 20% of all diagnosed invasive breast cancer cases in the United States; and

WHEREAS, In 2019, more than 53,700 new breast cancer cases in the United States were diagnosed as TNBC, with higher prevalence among younger women, Black and Hispanic women, women with type 2 diabetes or carrying excess weight in the abdomen area, and those with BRCA1 mutations; and

WHEREAS, Due to its aggressive behavior, TNBC grows quickly, is more likely to have spread at the time it is found, and is more likely to come back after treatment than other types of breast cancer; and

WHEREAS, People diagnosed with metastatic TNBC have a less than 30% chance of surviving past five years; and

WHEREAS, TNBC cells do not contain, or are "negative for", three key receptors that medicines typically target in other types of breast cancer; therefore, limited treatment options that can be used to treat the cancer; and

WHEREAS, Patients with an early diagnosis can often be treated with chemotherapy, radiation, and surgery; however, the limited therapies available, which specifically address the management of TNBC, have made treating this disease a challenge for clinicians; and

WHEREAS, Recent innovation in targeted therapies have fueled advances in the fight against TNBC; and

WHEREAS, Studies have shown that TNBC disease-specific mortality rates are often higher if patients have Medicaid or Medicare or come from a lower socioeconomic status; compared with non-Hispanic white women, Black women are 48% less likely to receive guideline adherent care and have an approximate two-fold higher mortality incidence, resulting in a disproportionately higher risk of death from TNBC; and

WHEREAS, Advances in breast cancer screening and treatment over the last few decades have reduced the overall breast cancer mortality rate, yet the disproportionate impact of TNBC on racial and ethnic minority communities raises considerations about the underlying determinants driving the disparities; and

WHEREAS, It is necessary to promote TNBC education to raise awareness about disease-related disparities and to tackle inequities within health care delivery, such as inadequate access to screening, diagnostic testing, and care to improve early detection and survival; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the month of March 2023 as Triple-Negative Breast Cancer Awareness Month in the State of Illinois; and be it further

RESOLVED, That we support legislation to reduce Triple-Negative Breast Cancer (TNBC) disparities in early detection and survival by improving education and awareness through health promotion initiatives targeting underserved communities that are disproportionately impacted, which will help in ensuring equitable access and affordability of breast cancer screening, genetic counseling, and diagnostic testing, promoting cultural sensitivity and workforce diversity policies in health care provider training, and guaranteeing timely patient access to clinically appropriate treatment options identified in the National Comprehensive Cancer Network (NCCN) guidelines; and be it further

RESOLVED, That additional legislative provisions should be examined to safeguard affordable, continuous, and equitable patient access to TNBC-related care, services, and medicines along the entire continuum of care.

WHEREAS, Multiple sclerosis (MS) can impact individuals of all ages, races, and ethnicities but is at least two to three times more common in women than in men; and

WHEREAS, There are approximately 2,300,000 individuals worldwide who have been diagnosed with MS; and

WHEREAS, In a study presented in October 2017 by the European Committee for Treatment and Research in Multiple Sclerosis, preliminary results from leading experts estimate that nearly one million people are living with MS in the United States alone, which is more than twice the previously reported number of 400,000; and

WHEREAS, The Greater Illinois Chapter of the National Multiple Sclerosis Society shows 18,365 persons living with MS, and, as not all people register with the Society, the true number of persons living with MS in this area is higher; and

WHEREAS, The Illinois Department of Public Health collaborates with community partners to improve the health of people at risk for, or affected by, MS; and



WHEREAS, MS is typically diagnosed in individuals between the ages of 20 and 50, but it is estimated that between 8,000 and 10,000 children and adolescents are living with MS in the United States; and

WHEREAS, MS is an unpredictable and often disabling disease of the central nervous system that disrupts the flow of information within the brain and between the brain and the body; and

WHEREAS, Symptoms of MS range from numbness and tingling to vision problems and paralysis, but the progress, severity, and specific symptoms of MS in any one person cannot yet be predicted; and

WHEREAS, While there is no evidence that MS is directly inherited, studies show that there are genetic and environmental factors that give certain individuals a higher risk of developing MS; and

WHEREAS, The exact cause of MS is still unknown, and there is no cure for MS; and

WHEREAS, The Multiple Sclerosis Coalition is a national network of independent MS organizations dedicated to the enhancement of the quality of life of individuals affected by MS; and

WHEREAS, The mission of the Multiple Sclerosis Coalition is to increase opportunities for cooperation and to provide a greater opportunity to leverage the effective use of resources for the benefit of the MS community; and

WHEREAS, In 2012, the National Multiple Sclerosis Society was a founding member of the International Progressive MS Alliance, which coordinates research to accelerate the development of treatments for progressive MS by removing international scientific and technological barriers and, as of 2018, includes 17 MS organizations from 17 countries, nine foundation and trust members, and seven pharmaceutical partners; and

WHEREAS, The Multiple Sclerosis Coalition recognizes and supports Multiple Sclerosis Awareness Week and Day during March of every calendar year; and

WHEREAS, The goals of Multiple Sclerosis Awareness Week and Day are to invite people to join the movement to end MS, to encourage everyone to do something to demonstrate a commitment to moving toward a world free of MS, and to acknowledge those who have dedicated time and talent to help promote MS research and programs; and

WHEREAS, Building awareness is a year-round effort, and MS Awareness Week and Day serve as a platform for everyone affected by MS across the country to share strategies and experiences to live their best lives in the belief that together we are stronger; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the week of March 12 through March 18, 2023 as Illinois Multiple Sclerosis Awareness Week, and we declare March 18, 2023 as Illinois Multiple Sclerosis Awareness Day; and be it further

RESOLVED, That we support the goals and ideals of Multiple Sclerosis Awareness Week and Day and encourage municipalities to support the goals and ideals of Multiple Sclerosis Awareness Week and Day by issuing proclamations designating Multiple Sclerosis Awareness Week and Day; and be it further

### HOUSE JOINT RESOLUTIONS CONSTITUTIONAL AMENDMENTS FIRST READING

Representative Meier introduced the following:

### HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 14

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Article IV of the Illinois Constitution by changing Sections 2 as follows:

#### ARTICLE IV THE LEGISLATURE

(ILCON Art. IV, Sec. 2)

#### SECTION 2. LEGISLATIVE COMPOSITION

(a) One Senator shall be elected from each Legislative District. Immediately following each decennial redistricting, the General Assembly by law shall divide the Legislative Districts as equally as possible into three groups. Senators from one group shall be elected for terms of four years, four years and two years; Senators from the second group, for terms of four years, two years and four years; and Senators from the third group, for terms of two years, four years and four years. The Legislative Districts in each group shall be distributed substantially equally over the State.

(b) Each Legislative District shall be composed of three contiguous counties, with a separate additional Legislative District for each municipality with a population over one million ~~divided into two Representative Districts~~. In 1982 and every two years thereafter one Representative shall be elected from each Representative District for a term of two years. Representative Districts shall be drawn independently of Legislative Districts.

(c) To be eligible to serve as a member of the General Assembly, a person must be a United States citizen, at least 21 years old, and for the two years preceding his election or appointment a resident of the district which he is to represent. In the general election following a redistricting, a candidate for the General Assembly may be elected from any district which contains a part of the district in which he resided at the

time of the redistricting and reelected if a resident of the new district he represents for 18 months prior to reelection.

(d) Within thirty days after a vacancy occurs, it shall be filled by appointment as provided by law. If the vacancy is in a Senatorial office with more than twenty-eight months remaining in the term, the appointed Senator shall serve until the next general election, at which time a Senator shall be elected to serve for the remainder of the term. If the vacancy is in a Representative office or in any other Senatorial office, the appointment shall be for the remainder of the term. An appointee to fill a vacancy shall be a member of the same political party as the person he succeeds.

(e) No member of the General Assembly shall receive compensation as a public officer or employee from any other governmental entity for time during which he is in attendance as a member of the General Assembly.

No member of the General Assembly during the term for which he was elected or appointed shall be appointed to a public office which shall have been created or the compensation for which shall have been increased by the General Assembly during that term.
