Huynh: "Thank you. On behalf of the Asian American Caucus, eight strong, I rise to present House Resolution 590, which is to celebrate the Lunar New Year, which is happening this Saturday, February 17... no, 10. So, I'm going to read the Resolution.

WHEREAS, The members of the Illinois House of Representatives wish to recognize the celebration of the Lunar New Year as a major holiday celebrated by Asian American communities in Illinois and the United States as well as Asian communities around the globe (sic-world); and

WHEREAS, The Lunar New Year marks the beginning of the year using the traditional Chinese lunisolar calendar or a variant; and

WHEREAS, The Lunar New Year starts on the second new moon after the winter solstice, falling between January 21 and February 19 on the Gregorian calendar used in the United States; and

WHEREAS, The Lunar New Year began being celebrated in East Asia and Southeast Asia more than 4,000 years ago; today, it is observed worldwide among people of Chinese, Korean, and Vietnamese heritage; and

WHEREAS, The Lunar New Year is known as the Spring Festival in China, Seollal in Korea, and Tet in Vietnam; and

WHEREAS, While Lunar New Year celebrations vary in length from culture to culture, ranging from three days to three (sic-two) weeks, celebration commonalities include gathering with family and friends, honoring ancestors and elders, watching

WHEREAS, The Lunar New Year occurs in a 12-year cycle, with each year being represented by one of 12 animals from the zodiac; and

WHEREAS, In Chinese, Korean, and Vietnamese Lunar New Year celebrations, the 2024 Lunar New Year is the Year of the Dragon, symbolizing courage, good fortune, honor, prosperity, and success; and

WHEREAS, This year, the Lunar New Year will begin on February 10, 2024; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the cultural and historical significance of the Lunar New Year to Asian American communities, express our deepest respect for Asian Americans and people throughout Illinois and the globe (sic-world) who celebrate the Lunar New Year, and wish those who celebrate a happy and prosperous new year. Ozinga: "Members of the House, I want to draw your attention to House Bill 4866 that Representative Ugaste and I filed this week. It has the power to transform lives of millions of individuals and families for generations to come. Before I talk about HB4866, I'd like to share a piece of my personal story. My grandparents were Greek immigrants who boarded a ship across the Atlantic with little more than a dream to start a family in America, the land of opportunity. I vividly remember the early stories grandma would tell me of her and grandpa digging the ditches for the sewer and water for their house while she was pregnant with a child, working odd jobs to make ends meet, and wondering how they were going to put food on the table for a Thanksgiving meal. My grandpa's passion was to... to ministry, where he served as a megaphone touting street preacher on the streets of Chicago. It was not uncommon for him to come home injured because he had gotten roughed up on the streets. One time, someone threw a glass bottle at his head, causing him to bleed, but he never stopped preaching. It was also not uncommon for him to surprise my grandma with guests that he met out on the streets of Chicago and bring them home for dinner, which she loved. Thankfully, my grandma was an early female entrepreneur and supported grandpa in his mission of ministry. She started a local day care business that supported the family and showed them the way to keep on dreaming the American dream. Through hard work and determination, they were able to raise three children. My two uncles both enlisted in the service, attended college,

and later started their own business, a dental practice in Oak Lawn. Mom also went on to college and became an interior designer. Each of their three children went on to have six kids of their own, and I am proud to be a grandson of these Greek immigrants. Many of you echo similar stories as mine. Many of those that have come before us have had the opportunity to accomplish the American dream. Unfortunately, there is a great injustice occurring in our state today, an injustice that we have the power to fix. This injustice is the growing chasm of the haves and the have-nots in our state. Many communities across our state are struggling just to catch their breath, let alone dream of the future. Why are some struggling communities across our state paying four times the effective tax rate than more affluent communities in the very same county? This is wrong, and we can do better. Why are struggling communities afforded the right to safe streets, quality education, and good paying jobs? This is wrong, and we can do better. Why are struggling communities' ability to believe and achieve the American dream being suffocated by a lack of opportunity? This is wrong, and we must do better. Many families, communities, and businesses in Illinois are struggling to survive under our state's property tax burden. That is why Rep. Ugaste and I have introduced House Bill 4866. This is groundbreaking legislation that will establish the Education Property Tax Relief Fund. Once established, this fund will not only finance our schools the way they should be, but it will also reduce the property tax bill for some schools by up to 15 percent by awarding property tax grants to local school districts. All this can be done without the

Together, we can stand up and lead the way to transform lives of millions of individuals and families for generations to come. Please join us in supporting House Bill 4866."

Unfortunately, what I'm seeing in the news are not just how our actions affect people throughout the State of Illinois, but our lack of action. Because we have something left over from the end of last year that we've yet to accomplish, and that is re-upping the Invest in Kids Act. Nine thousand five hundred underprivileged children are about to lose their best chance at a bright future because we are not taking action. I'm reading story

after story day after day in the press about schools having to close and the students are being affected and how the families are being affected. Unfortunately, today, the *Tribune's* story was about a single mother that has two young sons that are directly going to be impacted by this, as the Catholic school one of them was attending, and one was probably about to attend, is going to close because we did not re-up the Invest in Kids Act, a tax credit that helps the disadvantaged. We still have time. Pretty soon, we are going to be out of time. Once these schools start on their process of closing, there will be no turning this back. They will close. These kids will lose this opportunity. And not just the kids who are getting credit, but if these schools have to close because the credit isn't there, then guess what, folks? We've just impacted more than those 9,500 kids who are betting their futures on this type of education. We have the Bills. We have 40 votes we're willing to put on it. You have the power to have the Bills called. Please work together with us and help the children of Illinois. Thank you."

Buckner: "Point of personal privilege, please."

Morris: "Good afternoon to my esteemed colleagues and those watching in the gallery. For today's moment in black history, I bring to you a fellow health care worker, labor supporter, and activist, Brenetta Howell Barrett. Barrett was born in Chicago in 1932. She grew up in a home on 43rd in St. Lawrence in the Kenwood neighborhood. She was the first joined activism after a school assembly led by legendary activist and actor Paul Robeson. After graduating from DuSable High School, she moved to North Lawndale, which she would call home for the rest of her life. During this time, she began fighting for workers... for working people as a journalist and reporter for papers such as the *Lawndale Booster*, *Muhammad Speaks*, and the *West Side Gazette*. While serving as a regional director of the NAACP, she directly challenged racist systems of power by working with fellow activist Timuel Black, Jesse Jackson, and others to organize the Chicago Freedom Movement, which helped her to spur the passage of the Fair Housing Act of 1968. In 1976, she helped the State Senator Harold Washington organize his first mayoral campaign and later served in his administration. In the 1990s, Barrett fought to address... fought to address the HIV/AIDS epidemic during the time of great ignorance and stigma around the conditions, working to help black LGBT youth receive care, counseling, and drug... drug addiction treatment. Today, at 91 years of age, Barrett is a living legend. Let's give a round of applause and a

heartfelt thanks for this phenomenal woman, West Sider, fierce shero. Thank you."

Speaker Hernandez, B.: "Representative McLaughlin, for what reason do you seek recognition?"

McLaughlin: "Thank you, Madam Speaker. Rise for a point of personal privilege."

Speaker Hernandez, B.: "Please proceed."

McLaughlin.: "I... before we leave the chamber today and head home, I just wanted to acknowledge my appreciation of the Governor, Cook County president, and the mayor meeting, I believe, earlier this week as it relates to the greatest humanitarian crisis this state has ever faced, which is the immigrant, illegal alien, asylum seekers. Not really sure what quite sure the excepted vernacular is. And frankly, I'm not as interested in that as I am in the Governor's comments when he came out of a press conference and stated that his staff has been working on this problem for some time. As someone that sits on the Revenue & Finance Committee, I believe that we should know the number that the Governor's Office, the mayor, and Toni Preckwinkle believe that our state can accept and, more importantly, afford. Last year, to remind this Body, at 1:30 in the morning, we were handed a budget that allocated up to \$1.2 billion of the state \$5.1 billion budget to go to the illegal migrant crisis. My interest and my hope is that the Governor and his staff will be transparent and bring these numbers forward so that we can understand where the money's is going to be spent, who's going to receive it, where the contracts are going, and who is going to be benefitting from those contracts, in addition to the services that we will be

So, please, my friends on the other side of the aisle, join me in demanding and expecting transparency to know the number of migrants, illegal aliens, or whatever you would like to qualify them as, how many, how many we can afford, and what services we'll be taking from current citizen programs in the state. Let's be transparent, let's ask our people in our districts what they want, and let's represent them properly. Thank you, Madam Speaker."
