### PRESENTATION OF RESOLUTIONS

Senator Lightford offered the following Senate Resolution, which was referred to the Committee on Assignments:

#### SENATE RESOLUTION NO. 74

WHEREAS, Burn injuries continue to be one of the leading causes of accidental death and injury in our nation; tragically, children, the elderly, and the disabled are especially vulnerable to burn injuries, and almost one-third of all burn injuries occur in children under the age of 15; and

WHEREAS, In the United States, the Centers for Disease Control and Prevention (CDC) reported 276,086 people received medical care for treatment of unintentional burn injuries in 2020 with 3,028 deaths resulting from fire and smoke inhalation; according to information gathered from the American Burn Association registry from 87 different hospitals, 91,875 people were treated in hospitals for burn-related injuries with 32% of those being for scalds; and

WHEREAS, Compared to the overall population, children under five were two times as likely to be seen for burn injuries at a hospital emergency department; young adults from the ages of 20 to 29 had 1.4 times the risk, and those in the 30-39 age group had 1.3 times the risk of the general population; and

WHEREAS, The primary causes of burn injury include fire-flame, scalds, and coming into contact with hot objects, electricity, and chemicals; most of the injuries occur in the home; today, 96.8% of those who suffer burn injuries will survive; unfortunately, many of those survivors will sustain serious scarring, lifelong physical disabilities, and adjustment difficulties; and

WHEREAS, National Burn Awareness Week, an initiative of the American Burn Association, is a coming together of burn, fire, and life safety educators to make the public aware of the frequency, devastation, and causes of burn injury as well as the consistent and authoritative measures to prevent these injuries and how to best care for those that are injured; and

WHEREAS, The theme for 2023 National Burn Awareness Week is "Scalds: Hot Liquids Burn Like Fire" due to a common risk of burn injury existing from hot liquids, steam, and hot bath water; and

WHEREAS, Significant research and medical advances have dramatically improved burn care and treatment, aided rehabilitation, shortened hospital stays, and increased burn survival rates; aftercare support for the physical and emotional effects of burns has also played a key role in the successful reintegration of burn survivors into our communities; furthermore, burn safety education and prevention efforts continue to reduce the number of people who suffer burns each year; and

WHEREAS, Many people devote their lives and careers to treating, caring for, and supporting rehabilitating burn injury survivors, including those performing vital work in burn research and development, the dedicated firefighters who risk their own lives every day to protect others, burn foundations, and other life safety professionals who promote burn injury awareness and prevention; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare February 5 through February 11, 2023 as Burn Awareness Week in the State of Illinois; and be it further

RESOLVED, That we urge all government agencies, fire, life safety, and health care organizations, communications media, and the people of Illinois to observe this week with the appropriate ceremonies and

**SENATE JOINT RESOLUTION NO. 26**

WHEREAS, It is highly fitting that the Illinois General Assembly pays honor and respect to the truly great individuals who have served their country; and

WHEREAS, Kenny Kays joined the U.S. Army in 1969 to serve as a medic; as of May 7, 1970, he was serving as a private in the Headquarters Company of 1st Battalion, 506th Infantry Regiment, 101st Airborne Division; and

WHEREAS, During a firefight on that day in Thua Thien–Hue Province, Republic of Vietnam, Pfc. Kays repeatedly allowed himself to be the target of enemy fire in order to treat wounded soldiers; even after losing his lower left leg to an explosion, he treated the wounds of his fellow soldiers before allowing his injuries to be addressed; these actions resulted in the saving of numerous lives and inspired others in his company to repel the enemy; and

WHEREAS, In November of 1973, Pfc. Kays was promoted to private first class and awarded the Medal of Honor for conspicuous gallantry intrepidity in action at the risk of his life above and beyond the call of duty; and

WHEREAS, Pfc. Kays' heroism at the risk of his life are in keeping with the highest traditions of the service and reflect great credit on him, his unit, and the U.S. Army; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we designate Illinois Route 15 from the western edge of Fairfield west to the intersection with County Highway 10 as the "Pfc. Kenny Kays Memorial Highway"; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of the name the "Pfc. Kenny Kays Memorial Highway"; and be it further

RESOLVED, That suitable copies of this resolution be presented to the family of Pfc. Kays, the mayor of Fairfield, and the Secretary of Transportation.

**SENATE RESOLUTION NO. 66**

WHEREAS, It is appropriate to remember the many sacrifices and contributions to the cause of freedom made by the outstanding men and women who have served in the United States Armed Forces; and

WHEREAS, From 1946 to 1962, the United States conducted approximately 200 atmospheric nuclear tests, more than all other nuclear states combined at that time; and

WHEREAS, Approximately 400,000 servicemen in the U.S. Army, Navy, and Marines were present during these atmospheric tests, whether as witnesses to the tests themselves or as post-test cleanup crews; and

WHEREAS, The Manhattan Project was the code name for the American-led effort to develop a functional atomic weapon during World War II; and

WHEREAS, Two types of atomic bombs were developed concurrently during the war, a relatively simple gun-type fission weapon and a more complex implosion-type nuclear weapon; the Thin Man gun-type design proved impractical to use with plutonium, and therefore, a simpler gun-type called Little Boy was developed that used uranium-235, an isotope that makes up only 0.7 percent of natural uranium; since it was chemically identical to the most common isotope, uranium-238, and had almost the same mass, separating the two proved difficult; three methods were employed for uranium enrichment, electromagnetic, gaseous, and thermal; most of this work was performed at the Clinton Engineer Works at Oak Ridge, Tennessee; and

WHEREAS, In parallel with the work on uranium was an effort to produce plutonium, which was discovered by researchers at the University of California, Berkeley, in 1940; after the feasibility of the world's first artificial nuclear reactor, the Chicago Pile-1, was demonstrated in 1942 at the Metallurgical Laboratory in the University of Chicago, the project designed the X-10 Graphite Reactor at Oak Ridge and the production reactors at the Hanford Site in Washington state, in which uranium was irradiated and transmuted into plutonium and the plutonium was then chemically separated from the uranium, using the bismuth phosphate process; the Fat Man plutonium implosion-type weapon was developed in a concerted design and development effort by the Los Alamos Laboratory; and

WHEREAS, Illinois played an important part in the Manhattan Project; and

WHEREAS, Argonne National Laboratory is a science and engineering research national laboratory operated by the University of Chicago for the United States Department of Energy; the facility is located in Lemont, outside of Chicago, and is the largest national laboratory by size and scope in the Midwest; and

WHEREAS, On July 1, 1946, the laboratory was formally chartered as Argonne National Laboratory to conduct cooperative research in nucleonics; at the request of the U.S. Atomic Energy Commission, it began developing nuclear reactors for the nation's peaceful nuclear energy program; in the late 1940s and early 1950s, the laboratory moved to a larger location in Lemont and established a remote location in Idaho called "Argonne-West" to conduct further nuclear research; and

WHEREAS, Code-named the "Metallurgical Lab", the team constructed Chicago Pile-1, which achieved criticality on December 2, 1942 underneath the stands at the University of Chicago's Stagg Field; because the experiments were deemed too dangerous to conduct in a major city, the operations were moved to a spot in nearby Palos Hills and renamed "Argonne" after the surrounding forest; and

WHEREAS, Red Gate Woods is a forest preserve within the Palos Division of the Forest Preserve District of Cook County and is located near where the Cal-Sag Channel meets the Chicago Sanitary and Ship Canal; the original site of Argonne National Laboratory and the Site A/Plot M Disposal Site is in the woods, which contains the buried remains of Chicago Pile-1, the world's first artificial nuclear reactor; and

WHEREAS, It is important to remember and honor the achievements and sacrifices of the men and women of this nation who during their time of service experienced exposure to nuclear radiation while on active duty and served so valiantly in the cause of freedom; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare July 16, 2023 as Atomic Veterans Day in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Atomic Heritage Foundation as a symbol of our esteem and respect.

WHEREAS, Currently, all part-time/contingent/adjunct Illinois public teachers, librarians, counselors, and educational support personnel are not equitably compensated, have no access to health benefits, and lack full and fair pension reporting and accountability; and

WHEREAS, Student learning is directly related to part-time/contingent/adjunct working conditions; it follows that college and university student learning is negatively impacted by the inequities and unfairness embedded in the system of higher education; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge that adjuncts/non-tenure/part-time instructors in institutions of higher education be treated with the same respect, recognition, value, and standards as full-time instructors and no longer be second class citizens within the ranks of higher education professionals as has been the practice within these institutions of higher learning; and be it further

RESOLVED, That we affirm that these professionals, who have the same credentials as the full-time instructors, are being underpaid to do the same job; and be it further

RESOLVED, That we pledge to seek solutions that include, but are not limited to, legislated salary parity, mandated access to health benefits, and full and fair pension reporting and accountability for all part-time/contingent/adjunct Illinois public teachers, librarians, counselors, and educational support personnel; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Higher Education Council of the Illinois Education Association.
