At the hour of 8:52 o'clock a.m., the House convened perfunctory session.

**HOUSE RESOLUTIONS**

The following resolutions were offered and placed in the Committee on Rules.

**HOUSE JOINT RESOLUTION 82**

Offered by Representative Crespo:

WHEREAS, The State Board of Education has filed its Report on Waivers of School Code Mandates, dated September 28, 2017, with the House of Representatives, the Senate, and the Secretary of State of Illinois as required by Section 2-3.25g of the School Code; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the General Assembly is encouraged to promptly review and evaluate any waiver requests transmitted to the General Assembly and determine whether to disapprove, in whole or in part, any transmitted waiver requests.

**HOUSE RESOLUTION 648**

Offered by Representative Ford:

WHEREAS, House Resolution 550 of the 97th General Assembly created the Firearm Public Awareness Task Force; and

WHEREAS, The Firearm Public Awareness Task Force was charged with finding and analyzing data from states that have concealed carry laws and the types and number of crimes involving handguns before and after the date that a concealed carry law went into effect; and

WHEREAS, Every week there continue to be reports of tragedies and crimes involving firearms; illegal guns continue to flow into Illinois from other states; individuals who are not legally authorized to possess firearms continue to find ways to acquire them and utilize them in crimes; and

WHEREAS, Since the Firearm Public Awareness Task Force completed its work in March of 2012, gun crimes continue to proliferate and mass shootings are increasing in number and severity: on December 14, 2012, 28 elementary school children were killed and two others wounded in Newtown, Connecticut; on December 2, 2015, 16 people were killed and 24 wounded in San Bernardino, California; on June 12, 2016, 49 people were killed and over 58 wounded in Orlando, Florida; and on October 1, 2017, 58 people were killed and over 515 were wounded in Las Vegas, Nevada; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Firearm Public Awareness Task Force is reconstituted; and be it further

RESOLVED, The Firearm Public Awareness Task Force is charged with gathering data and studying the following:

- (1) Reviewing the previous report compiled by the task force and discussing the effects that concealed carry might have had on the proliferation of crimes involving firearms; and
- (2) Shootings in Illinois by regions and what might be contributing to more shootings in one area of the State compared to others; and
- (3) Gun dealers and gun sales that may have led to illegal usage or straw purchases; this should include the number of guns and ammunition sold and any registry concerning ammunition purchases; and
- (4) The transportation of firearms, especially newly manufactured firearms as they are

transported through Illinois; this should include the study of the repeated gun thefts at the Norfolk Southern Rail Yard; and

(5) Mental health laws and treatments for those individuals who have access to firearms; and

(6) Current laws on handguns and rifles and the states with the best practices; and be it further

RESOLVED, That the Firearm Public Awareness Task Force shall be comprised of the following members, all of whom shall serve without compensation:

(1) five representatives appointed by the Speaker of the House of Representatives;

(2) five representatives appointed by the Minority Leader of the House of Representatives;

(3) a representative of the Department of State Police appointed by the Director of the Department;

(4) a representative of the Cook County Sheriff's office appointed by the Cook County Sheriff;

(5) a representative of the Illinois State's Attorneys' Association appointed by the head of that organization;

(6) a representative of the Illinois Fraternal Order of Police appointed by the head of that organization;

(7) a representative of the Illinois Sheriffs Association appointed by the head of that organization;

(8) a representative of the National Rifle Association of America appointed by the head of that organization;

(9) a representative of the Illinois State Rifle Association appointed by the head of that organization;

(10) a representative of the Illinois Council Against Handgun Violence appointed by the head of that organization; and

(11) a representative from the Illinois Firearms Manufacturers Association appointed by the head of that organization; and be it further

(12) a representative from the Cook County State's Attorney's office appointed by the Cook County State's Attorney; and

(13) an individual who advocates for victims of gun violence appointed by the Speaker of the House of Representatives; and be it further

RESOLVED, That the Speaker shall designate a member of the task force to serve as the chairperson; and be it further

RESOLVED, That the Department of State Police shall provide administrative and other support to the task force; and be it further

RESOLVED, That the task force shall hold public hearings and shall issue a written report of its findings and recommendations to the General Assembly before the end of the 100th General Assembly, and upon filing its report, the task force is dissolved.

#### HOUSE RESOLUTION 651

Offered by Representative Thapedi:

WHEREAS, A secure, reliable, and resilient power grid integrating generation resources serves as a foundation of a growing economy and is critical to national security; and

WHEREAS, Regulators, policymakers, and consumers expect generating resources and the grid to perform extremely reliably; and

WHEREAS, A significant portion of the nation's transmission facilities is aged and urgently requires replacement and substantial upgrading; and

WHEREAS, Environmental regulations, state renewable and clean energy portfolio standards with mandated deadlines, state and federal tax policies, other economic factors, and technology developments are causing some electric generation resources to retire, while substantial replacement generation, some of it fueled by intermittent resources, is being or is planned to be sited at other locations on the electric grid; and

WHEREAS, The risk of natural disasters threatens the network of power transmission and distribution lines, and strengthening the nation's grid with advanced technology can increase the grid's resiliency and reliability; and

WHEREAS, New innovative, cost-effective transmission technologies, including, but not limited to, high-capacity and high-efficiency conductors and compact transmission towers, are commercially available with revolutionary, extraordinarily high-performance levels compared to other technologies to address aged circuit and new generation issues, including much greater increases in grid capacity, much greater improvements in energy transfers, significantly greater stability and resiliency, much greater efficient use of existing and new rights-of-way, substantial reduction in transmission line losses, streamlining siting and construction activities, and more rapidly bringing new and replacement circuits into service; and

WHEREAS, New and advanced replacement transmission facilities can be designed and deployed to enable a wide variety of new generating resources and can address technical, environmental, and aesthetic issues that could impede or limit the development and operation of resources so states can achieve public policy goals on set schedules; and

WHEREAS, Crowded utility corridors often allow little room for expansion; and

WHEREAS, Some states have established minimal requirements for approving transmission projects that use existing corridors with de minimis impacts; and

WHEREAS, At least one state has established a policy that encourages regulators and grid operators to support and encourage consideration of advanced transmission line technologies to cost-effectively deliver benefits; and

WHEREAS, Substantial benefits will flow from advanced technologies on a cost-per-energy-unit-delivered or other basis, so state legislators, electric utilities, grid operators, and state public service commissions are encouraged to optimize investment decisions around the cost-effective use of technologies to yield extraordinarily high performance from them; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we encourage the State of Illinois to support the following:

- (1) the investigation and consideration of new advanced transmission technologies that offer revolutionary performance benefits when replacing aged transmission infrastructure;
- (2) the evaluation of new advanced transmission technologies to determine whether they are best able to cost-effectively ensure the continued reliable delivery of electricity while providing revolutionary greater capacity and revolutionary enhanced efficiency on schedules required to meet the state's public policy objectives;
- (3) the consideration of the ability of these technologies to greatly reduce environmental and visual impacts to communities; and
- (4) the consideration of the ability of these and other technologies to greatly reduce the overall cost of energy delivery; and be it further

RESOLVED, That we encourage efforts to work with regional transmission organizations, independent system operators, and other planning authorities to compare the cost-effective, revolutionary performance of advanced electric transmission infrastructure options to the performance of other technologies for increasing grid capacity, reducing transmission line losses, improving energy transfers, making more efficient use of rights-of-way, improving energy efficiency, and encouraging the shortest timeframes be put in service by streamlining siting and construction activities in their planning, evaluation, and oversight of transmission grid development, especially by utilizing existing transmission corridors; and be it further

RESOLVED, That we encourage the inclusion of supplemental or new policies of transmission facilities that promote revolutionary, rather than incremental, performance and the benefits of the appropriate use of cost-effective advanced electric transmission technologies in support of their interest in the continued, timely provision of affordable, reliable electricity to consumers; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Governor Rauner, all members of the Illinois Commerce Commission, all members of the Illinois Congressional Delegation, Exelon, Dynege, ComEd, Ameren, Mid-American Energy, Illinois Electrical Cooperatives, the Electric Power Research Institute, National Labs (Department of Energy), and the IEE.

Mr. Speaker -- I am directed to inform the House of Representatives that the Senate has passed a bill of the following title, the veto of the Governor to the contrary notwithstanding, in the passage of which I am instructed to ask the concurrence of the House, to-wit:

Senate Bill No. 1905

A bill for AN ACT concerning government.

I am further directed to transmit to the House of Representatives the following copy of the Governor's veto message to the Senate:

Passed by the Senate, October 24, 2017, by a three-fifths vote.

To the Honorable Members of  
The Illinois Senate,  
100th General Assembly:

Today I veto Senate Bill 1905 from the 100th General Assembly, which prohibits local communities from allowing individual workers a choice in whether or not they want to pay a union as a condition of

employment. This legislation would damage the economic health of Illinois' communities by removing their freedom to determine the best interests of their workforces and employers.

Illinois lags behind its neighbors' economic and job growth despite our many advantages. Our State's workforce is fleeing and aging, losing 250,000 people and having the worst personal income growth in the country over the last decade. Individuals, families, and businesses who should be eager to come to Illinois stay away. Manufacturers too often leave across our borders or never even consider investing in new job creation here. Many businesses will only expand in communities that offer employee freedom of choice.

Part of our struggle is that every state that shares a border with Illinois has already enacted true worker freedom, allowing individuals in those states to determine whether they want to contribute to a labor union. Many states around us are growing union jobs as well as non-union jobs faster than Illinois because more of their communities give workers choice while not preventing employees from joining unions if they choose.

By contrast, Senate Bill 1905 would move Illinois in the opposite direction by destroying the freedom of Illinois' local communities to choose reforms that can make their economies more competitive, help their businesses grow, and give the freedom to individual workers to support a union at their own discretion.

This legislation forces local communities to follow a one-size-fits-all model of government, no matter how detrimental they believe it is to them. Our goal should not be to limit workers' ability to join a union but rather to give communities the freedom to embrace new tools to compete economically and to recruit businesses and talent rather than have their choices dictated by Springfield.

Therefore, pursuant to Section 9(b) of Article IV of the Illinois Constitution of 1970, I hereby return Senate Bill 1905, entitled "AN ACT concerning government", with the foregoing objections, vetoed in its entirety.

WHEREAS, During the fiscal situation that began with the worldwide economic downturn of 2008-09, the work of COGFA has become increasingly vital as it has provided nonpolitical guidance to policymakers in and out of the Illinois General Assembly on the somber trends facing the State and its revenues; and

WHEREAS, During this challenging time, the Illinois General Assembly and the 12 legislative members of the Commission have been fortunate to have the services of COGFA's longtime Executive Director, Dan Long; and

WHEREAS, Dan Long graduated from the University of Illinois in 1975 and immediately began working for the office of Illinois State Comptroller, George W. Lindberg; the office of Comptroller was created by election in 1972 following ratification of the Constitution of 1970; when Dan started work for the State of Illinois, our State's new constitutional fiscal structure was less than two and a half years old; and
