Senator Crowe offered the following Senate Resolution, which was referred to the Committee on Assignments:

# **SENATE RESOLUTION NO. 1588**

WHEREAS, Pursuant to Section 7 of the Illinois Emergency Management Agency Act (20 ILCS 3305/7), the Governor of the State of Illinois has issued a proclamation declaring that a public health emergency exists related to the COVID-19 outbreak in the State of Illinois; and

WHEREAS, As the Governor of the State of Illinois, pursuant to Sections 7(1), 7(2), 7(8), and 7(12) of the Illinois Emergency Management Agency Act, 20 ILCS 3305, ordered during the duration of the Gubernatorial Disaster Proclamations, the requirement in the Section 2105-400 of the Civil Administrative Code, 20 ILCS 2105-400, and its accompanying regulations, authorizing the Secretary of the Department of Financial and Professional Regulation (IDFPR) to take certain actions to increase the number of licensed professionals responding to the disaster, is suspended to the extent it limits the Secretary's authority to those persons working under the direction of the Illinois Emergency Management Agency (IEMA) and the Illinois Department of Public Health (IDPH) pursuant to a declared disaster by the Governor; and

WHEREAS, The Governor further ordered that the requirement that the Secretary shall only exercise this authority "in coordination with the Illinois Emergency Management Agency and the Department of Public Health" remains in effect and that in exercising this authority, the Secretary shall work closely with the Directors of the IEMA and the IDH to ensure any impacted licensed professionals are aiding in the response to the disaster; and

WHEREAS, Section 2105-400(a)(l) of the Civil Administrative Code (20 ILCS 2105) authorizes the Secretary of the IDFPR to suspend the requirements for permanent licensure of persons who are licensed in another state and modify the scope of practice restrictions under any licensing act administered by the Department; and

WHEREAS, The Secretary of IDFPR has coordinated a response to the declared public health emergency with IEMA and IDPH, including expanding the scope of practice of dentists in order to respond to the COVID-19 pandemic; and

WHEREAS, Under the Illinois Dental Practice Act, dentists are authorized to administer influenza (inactivated influenza vaccine and live attenuated influenza intranasal vaccinations) to patients 18 years of age and older pursuant to a valid prescription or standing order by a physician licensed; and

WHEREAS, Under the Illinois Dental Practice Act Administrative Rules section 1220.240(g)(2), dental hygienists may administer local anesthetics upon successful completion of a 32-hour course that covers pharmacology, anatomy, techniques in the use of mandibular block and infiltration injections, and post-operative instructions; and

WHEREAS, There are currently two vaccines approved under the Emergency Use Authorization (EUA), and more approvals are expected in the coming months; and

WHEREAS, There is a shortage of healthcare providers available to administer the millions of vaccines needed to reach a level of herd immunity; and

WHEREAS, The inability to provide this needed vaccine due to a lack of healthcare providers trained to administer the necessary vaccinations will possibly contribute to unnecessary sickness and death; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Governor and the Secretary of the IDFPR to issue an Amended Emergency Proclamation to include an amended version that allows dentists to receive, store, and administer the COVID-19 vaccine and a second provision allowing Just in Time (JIT) training for both dentists and dental hygienists in order to participate in mass vaccination efforts throughout the State of Illinois; and be it further

RESOLVED, That we urge the Illinois licensed dentist's and dental hygienist's scope of practice under the Dental Practice Act, 225 ILCS 25, to be expanded to allow them to administer COVID-19 vaccinations to persons 16 years of age and older pursuant to a standing order and pursuant to the following requirements:

(1) The vaccine must be FDA-authorized or FDA-licensed;

(2) The vaccination must be ordered and administered according to the Advisory Committee on Immunization Practices' (ACIP) standard immunization schedule;

(3) The dentist must complete a practical training program of at least 4 hours that is

approved by an Illinois approved sponsor pursuant to 68 Ill. Adm. Code 1220.440(b)(2); this training program must include a review of hands-on injection techniques, clinical evaluation of indications and contraindications of vaccines, the recognition and treatment of adverse reactions to vaccines including anaphylactic shock symptoms and treatment, the appropriate method of storage, handling and disposal of vaccines and all used supplies or contaminated equipment, and the proper administration and maintenance of written policies and procedures pursuant to Section 1220.403 of the Administrative Rules;

(4) The dentist must have a current certificate in basic cardiopulmonary resuscitation; and

(5) The dentist must comply with record-keeping and reporting requirements of the

jurisdiction in which he or she administers vaccines, including informing the patient's primary-care provider within 30 days after administration of a vaccine, submitting the required immunization information to the State or local immunization information system (vaccine registry), complying with requirements with respect to reporting adverse events, and complying with requirements whereby the person administering a vaccine must review the vaccine registry or other vaccination records prior to administering a vaccine; and be it further

RESOLVED, That we also urge that the scope of practice for a licensed dentist or a dental hygienist who has completed prior training in mandibular block and infiltration injection techniques and for those dentists and dental hygienists who wish to only volunteer as part of a mass vaccination effort for the administration of COVID-19 vaccinations to persons 16 years of age and older pursuant to a standing order be additionally expanded to allow, as an alternative to the training provisions in (3), (4) and (5) above, administration of vaccines under a Just in Time (JIT) training model, if provided, under the coordination and supervision of a medical facility or local health mass vaccination plan pursuant to the following requirements:

(1) The dentist or dental hygienist must complete a Just in Time (JIT) training program

of at least 1 hour that is approved by an Illinois approved continuing education sponsor pursuant to 68 Ill Adm Code 1220.440(b)(2); this training program must include instruction on hands-on intramuscular injection techniques, medication dosage, clinical evaluation of indications and contraindications of vaccines, and the recognition and treatment of adverse reactions to vaccines including anaphylactic shock symptoms and treatment;

(2) Proper handling of vaccines and all supplies or contaminated equipment and proper record-keeping policies and procedures required by the facility;

(3) The dentist and dental hygienist volunteering under this section must have a current

proof of license and a certificate in basic cardiopulmonary resuscitation; and (4) Complete an orientation at the medical facility or public health facility on workstation requirements and protocol; and be it further

RESOLVED, That suitable copies of this resolution should be delivered to the Governor of the State of Illinois, the Secretary of the IDFPR, and the Director of the IDPH.

### ARTICLE XIII

# SESSION DURING TIMES OF PESTILENCE OR PUBLIC DANGER

(Senate Rule 13-1 new)

13-1. Applicability and construction. The meetings and actions of the Senate, including all of its committees, on session days where the President has declared times of pestilence or public danger shall be governed by the Senate Rules adopted by the Senate of the 101st General Assembly, together with the provisions contained in this Article. Where there is a conflict between the Senate Rules adopted by the Senate of the 101st General Assembly and the provisions contained in this Article, the provisions contained in this Article shall be controlling.

(Senate Rule 13-2 new)

13-2. Public access to proceedings.

(a) The Presiding Officer shall designate a process for the public to observe the meetings and actions of the Senate, including all of its committees, via video or other electronic means.

(b) The Presiding Officer shall designate a process for the committees of the Senate to receive testimony from members of the public via electronic means.

(Senate Rule 13-3 new)

13-3. Floor debate and personal privilege.

(a) Prior to floor debate, the President, in consultation with the Minority Leader, may establish the total number of speakers and number of speakers for each caucus who shall be recognized for debate for any legislative measure. If such a debate protocol is established, then the Presiding Officer shall announce prior to debate: (1) the total number of speakers; (2) number of speakers for each caucus; and (3) the member designated as floor manager by the respective caucus leader to manage the number of speakers for that caucus.

(b) Members may not introduce guests or make points of personal privilege during session covered by this Article.

(Senate Rule 13-4 new)

13-4. Verification of attendance.

(a) At the beginning of each day of session covered by this Article, the President, or his or her designee, and the Minority Leader, or his or her designee, shall provide to the Secretary the names of those members of his or her respective caucus who are excused from attendance for that day. All members not so excused or participating remotely under Rule 4-1(e) shall be counted as present for the purposes of determining a quorum or voting in the Senate or its committees.

(b) The name of any member not already excused from attendance for a session day covered by this Article who leaves the State Capitol prior to adjournment of the session for that day shall be added to names of those members of that caucus who are excused from attendance for that day, and his or her name shall be provided by the President, or his or her designee, or the Minority Leader, or his or her designee, as the case may be, to the Secretary. Once a member's name has been provided to the Secretary under this paragraph, that member shall not be counted as present for the purposes of determining a quorum or voting in the Senate or its committees for the remainder of that day or until that member's presence is reestablished under subsection (c).

(c) If a member who has left the State Capitol as described in paragraph (b) returns prior to adjournment of a session day covered by this Article, his or her name shall be provided by the President, or his or her designee, or the Minority Leader, or his or her designee, as the case may be, to the Secretary who shall remove it from the names of those members of that caucus who are excused from attendance for that day. Once a member's name has been provided to the Secretary under this paragraph, that member shall be counted as present for the purposes of determining a quorum or voting in the Senate or its committees.

(d) If a member who was excused from attendance as described in paragraph (a) thereafter arrives at the State Capitol prior to adjournment of session covered by this Article for that day, his or her name shall be provided by the President, or his or her designee, or the Minority Leader, or his or her designee, as the case may be, to the Secretary who shall remove it from the names of those members of that caucus who are excused from attendance for that day. Once a member's name has been provided to the Secretary under this paragraph, that member shall be counted as present for the purposes of determining a quorum or voting in the Senate or its committees.

(e) No Senator may request verification of the results of any roll call in the Senate or its committees during the session covered by this Article.

On motion of Senator Cunningham, **House Bill No. 1559** was taken up, read by title a second time. Committee Amendment No. 1 was held in the Committee on Assignments. There being no further amendments, the bill was ordered to a third reading.

On motion of Senator Castro, **House Bill No. 2461** was taken up, read by title a second time. Floor Amendment No. 1 was approved for consideration by the Committee on Assignments, and Senator Castro chose not to move forward with the amendment at this time.

Floor Amendment No. 2 was referred to the Committee on Assignments earlier today.

There being no further amendments, the bill was ordered to a third reading.

On motion of Senator Belt, House Bill No. 2519 was taken up, read by title a second time and ordered to a third reading.

On motion of Senator Sims, House Bill No. 3653 was taken up, read by title a second time and ordered to a third reading.

#### HOUSE BILL RECALLED

On motion of Senator Bush, House Bill No. 2488 was recalled from the order of third reading to the order of second reading.

Floor Amendment Nos. 1 and 2 were held in the Committee on Assignments.

Senator Bush offered the following amendment and moved its adoption:

### AMENDMENT NO. 3 TO HOUSE BILL 2488

AMENDMENT NO. <u>3</u>. Amend House Bill 2488 by replacing everything after the enacting clause with the following:

"Section 5. The Illinois Controlled Substances Act is amended by changing Section 102 and by adding Section 220 as follows:

(720 ILCS 570/102) (from Ch. 56 1/2, par. 1102)

Sec. 102. Definitions. As used in this Act, unless the context otherwise requires:

(a) "Addict" means any person who habitually uses any drug, chemical, substance or dangerous drug other than alcohol so as to endanger the public morals, health, safety or welfare or who is so far addicted to the use of a dangerous drug or controlled substance other than alcohol as to have lost the power of self control with reference to his or her addiction.

(b) "Administer" means the direct application of a controlled substance, whether by injection, inhalation, ingestion, or any other means, to the body of a patient, research subject, or animal (as defined by the Humane Euthanasia in Animal Shelters Act) by:

(1) a practitioner (or, in his or her presence, by his or her authorized agent),

(2) the patient or research subject pursuant to an order, or

(3) a euthanasia technician as defined by the Humane Euthanasia in Animal Shelters Act.

(c) "Agent" means an authorized person who acts on behalf of or at the direction of a manufacturer, distributor, dispenser, prescriber, or practitioner. It does not include a common or contract carrier, public warehouseman or employee of the carrier or warehouseman.

(c-1) "Anabolic Steroids" means any drug or hormonal substance, chemically and pharmacologically related to testosterone (other than estrogens, progestins, corticosteroids, and dehydroepiandrosterone), and includes:

(i) 3[beta],17-dihydroxy-5a-androstane,

(ii) 3[alpha],17[beta]-dihydroxy-5a-androstane,

(iii) 5[alpha]-androstan-3,17-dione,

(iv) 1-androstenediol (3[beta],

17[beta]-dihydroxy-5[alpha]-androst-1-ene),

(v) 1-androstenediol (3[alpha],

17[beta]-dihydroxy-5[alpha]-androst-1-ene),

(vi) 4-androstenediol

(3[beta],17[beta]-dihydroxy-androst-4-ene),

(vii) 5-androstenediol

(3[beta],17[beta]-dihydroxy-androst-5-ene),

(viii) 1-androstenedione

'17-[alpha]-methyl-1-testosterone'),

(xlii) nandrolone (17[beta]-hydroxyestr-4-en-3-one), (xliii) 19-nor-4-androstenediol (3[beta], 17[beta]dihydroxyestr-4-ene), (xliv) 19-nor-4-androstenediol (3[alpha], 17[beta]dihydroxyestr-4-ene), (xlv) 19-nor-5-androstenediol (3[beta], 17[beta]dihydroxyestr-5-ene), (xlvi) 19-nor-5-androstenediol (3[alpha], 17[beta]dihydroxyestr-5-ene), (xlvii) 19-nor-4,9(10)-androstadienedione (estra-4,9(10)-diene-3,17-dione), (xlviii) 19-nor-4-androstenedione (estr-4en-3,17-dione), (xlix) 19-nor-5-androstenedione (estr-5en-3,17-dione), (l) norbolethone (13[beta], 17a-diethyl-17[beta]hydroxygon-4-en-3-one), (li) norclostebol (4-chloro-17[beta]hydroxyestr-4-en-3-one), (lii) norethandrolone (17[alpha]-ethyl-17[beta]hydroxyestr-4-en-3-one), (liii) normethandrolone (17[alpha]-methyl-17[beta]hydroxyestr-4-en-3-one), (liv) oxandrolone (17[alpha]-methyl-17[beta]-hydroxy-2-oxa-5[alpha]-androstan-3-one), (lv) oxymesterone (17[alpha]-methyl-4,17[beta]dihydroxyandrost-4-en-3-one), (lvi) oxymetholone (17[alpha]-methyl-2-hydroxymethylene-17[beta]-hydroxy-(5[alpha]-androstan-3-one), (lvii) stanozolol (17[alpha]-methyl-17[beta]-hydroxy-(5[alpha]-androst-2-eno[3,2-c]-pyrazole), (lviii) stenbolone (17[beta]-hydroxy-2-methyl-(5[alpha]-androst-1-en-3-one), (lix) testolactone (13-hydroxy-3-oxo-13,17secoandrosta-1,4-dien-17-oic acid lactone), (lx) testosterone (17[beta]-hydroxyandrost-4-en-3-one), (lxi) tetrahydrogestrinone (13[beta], 17[alpha]diethyl-17[beta]-hydroxygon-4,9,11-trien-3-one), (lxii) trenbolone (17[beta]-hydroxyestr-4,9, 11-trien-3-one).

Any person who is otherwise lawfully in possession of an anabolic steroid, or who otherwise lawfully manufactures, distributes, dispenses, delivers, or possesses with intent to deliver an anabolic steroid, which anabolic steroid is expressly intended for and lawfully allowed to be administered through implants to livestock or other nonhuman species, and which is approved by the Secretary of Health and Human Services for such administration, and which the person intends to administer or have administered through such implants, shall not be considered to be in unauthorized possession or to unlawfully manufacture, distribute, dispense, deliver, or possess with intent to deliver such anabolic steroid for purposes of this Act.

(d) "Administration" means the Drug Enforcement Administration, United States Department of Justice, or its successor agency.

(d-5) "Clinical Director, Prescription Monitoring Program" means a Department of Human Services administrative employee licensed to either prescribe or dispense controlled substances who shall run the clinical aspects of the Department of Human Services Prescription Monitoring Program and its Prescription Information Library.

(d-10) "Compounding" means the preparation and mixing of components, excluding flavorings, (1) as the result of a prescriber's prescription drug order or initiative based on the prescriber-patient-pharmacist

relationship in the course of professional practice or (2) for the purpose of, or incident to, research, teaching, or chemical analysis and not for sale or dispensing. "Compounding" includes the preparation of drugs or devices in anticipation of receiving prescription drug orders based on routine, regularly observed dispensing patterns. Commercially available products may be compounded for dispensing to individual patients only if both of the following conditions are met: (i) the commercial product is not reasonably available from normal distribution channels in a timely manner to meet the patient's needs and (ii) the prescribing practitioner has requested that the drug be compounded.

(e) "Control" means to add a drug or other substance, or immediate precursor, to a Schedule whether by transfer from another Schedule or otherwise.

(f) "Controlled Substance" means (i) a drug, substance, immediate precursor, or synthetic drug in the Schedules of Article II of this Act or (ii) a drug or other substance, or immediate precursor, designated as a controlled substance by the Department through administrative rule. The term does not include distilled spirits, wine, malt beverages, or tobacco, as those terms are defined or used in the Liquor Control Act of 1934 and the Tobacco Products Tax Act of 1995.

(f-5) "Controlled substance analog" means a substance:

(1) the chemical structure of which is substantially similar to the chemical structure

of a controlled substance in Schedule I or II;

(2) which has a stimulant, depressant, or hallucinogenic effect on the central nervous

system that is substantially similar to or greater than the stimulant, depressant, or hallucinogenic effect on the central nervous system of a controlled substance in Schedule I or II; or

(3) with respect to a particular person, which such person represents or intends to have

a stimulant, depressant, or hallucinogenic effect on the central nervous system that is substantially similar to or greater than the stimulant, depressant, or hallucinogenic effect on the central nervous system of a controlled substance in Schedule I or II.

(g) "Counterfeit substance" means a controlled substance, which, or the container or labeling of which, without authorization bears the trademark, trade name, or other identifying mark, imprint, number or device, or any likeness thereof, of a manufacturer, distributor, or dispenser other than the person who in fact manufactured, distributed, or dispensed the substance.

(h) "Deliver" or "delivery" means the actual, constructive or attempted transfer of possession of a controlled substance, with or without consideration, whether or not there is an agency relationship.

(i) "Department" means the Illinois Department of Human Services (as successor to the Department of Alcoholism and Substance Abuse) or its successor agency.

(j) (Blank).

(k) "Department of Corrections" means the Department of Corrections of the State of Illinois or its successor agency.

(1) "Department of Financial and Professional Regulation" means the Department of Financial and Professional Regulation of the State of Illinois or its successor agency.

(m) "Depressant" means any drug that (i) causes an overall depression of central nervous system functions, (ii) causes impaired consciousness and awareness, and (iii) can be habit-forming or lead to a substance abuse problem, including but not limited to alcohol, cannabis and its active principles and their analogs, benzodiazepines and their analogs, barbiturates and their analogs, opioids (natural and synthetic) and their analogs, and chloral hydrate and similar sedative hypnotics.

(n) (Blank).

(o) "Director" means the Director of the Illinois State Police or his or her designated agents.

(p) "Dispense" means to deliver a controlled substance to an ultimate user or research subject by or pursuant to the lawful order of a prescriber, including the prescribing, administering, packaging, labeling, or compounding necessary to prepare the substance for that delivery.

(q) "Dispenser" means a practitioner who dispenses.

(r) "Distribute" means to deliver, other than by administering or dispensing, a controlled substance.

(s) "Distributor" means a person who distributes.

(t) "Drug" means (1) substances recognized as drugs in the official United States Pharmacopoeia, Official Homeopathic Pharmacopoeia of the United States, or official National Formulary, or any supplement to any of them; (2) substances intended for use in diagnosis, cure, mitigation, treatment, or prevention of disease in man or animals; (3) substances (other than food) intended to affect the structure of any function of the body of man or animals and (4) substances intended for use as a component of any article specified in clause (1), (2), or (3) of this subsection. It does not include devices or their components, parts, or accessories.

(t-3) "Electronic health record" or "EHR" means an electronic record of health-related information on an individual that is created, gathered, managed, and consulted by authorized health care clinicians and staff.

(t-3.5) "Electronic health record system" or "EHR system" means any computer-based system or combination of federally certified Health IT Modules (defined at 42 CFR 170.102 or its successor) used as a repository for electronic health records and accessed or updated by a prescriber or authorized surrogate in the ordinary course of his or her medical practice. For purposes of connecting to the Prescription Information Library maintained by the Bureau of Pharmacy and Clinical Support Systems or its successor, an EHR system may connect to the Prescription Information Library directly or through all or part of a computer program or system that is a federally certified Health IT Module maintained by a third party and used by the EHR system to secure access to the database.

(t-4) "Emergency medical services personnel" has the meaning ascribed to it in the Emergency Medical Services (EMS) Systems Act.

(t-5) "Euthanasia agency" means an entity certified by the Department of Financial and Professional Regulation for the purpose of animal euthanasia that holds an animal control facility license or animal shelter license under the Animal Welfare Act. A euthanasia agency is authorized to purchase, store, possess, and utilize Schedule II nonnarcotic and Schedule III nonnarcotic drugs for the sole purpose of animal euthanasia.

(t-10) "Euthanasia drugs" means Schedule II or Schedule III substances (nonnarcotic controlled substances) that are used by a euthanasia agency for the purpose of animal euthanasia.

(u) "Good faith" means the prescribing or dispensing of a controlled substance by a practitioner in the regular course of professional treatment to or for any person who is under his or her treatment for a pathology or condition other than that individual's physical or psychological dependence upon or addiction to a controlled substance, except as provided herein: and application of the term to a pharmacist shall mean the dispensing of a controlled substance pursuant to the prescriber's order which in the professional judgment of the pharmacist is lawful. The pharmacist shall be guided by accepted professional standards including, but not limited to the following, in making the judgment:

(1) lack of consistency of prescriber-patient relationship,

(2) frequency of prescriptions for same drug by one prescriber for large numbers of patients,

(3) quantities beyond those normally prescribed,

(4) unusual dosages (recognizing that there may be clinical circumstances where more or less than the usual dose may be used legitimately).

(5) unusual geographic distances between patient, pharmacist and prescriber,

(6) consistent prescribing of habit-forming drugs.

(u-0.5) "Hallucinogen" means a drug that causes markedly altered sensory perception leading to hallucinations of any type.

(u-1) "Home infusion services" means services provided by a pharmacy in compounding solutions for direct administration to a patient in a private residence, long-term care facility, or hospice setting by means of parenteral, intravenous, intramuscular, subcutaneous, or intraspinal infusion.

(u-5) "Illinois State Police" means the State Police of the State of Illinois, or its successor agency. (v) "Immediate precursor" means a substance:

(1) which the Department has found to be and by rule designated as being a principal

compound used, or produced primarily for use, in the manufacture of a controlled substance;

(2) which is an immediate chemical intermediary used or likely to be used in the manufacture of such controlled substance: and

(3) the control of which is necessary to prevent, curtail or limit the manufacture of

such controlled substance.

(w) "Instructional activities" means the acts of teaching, educating or instructing by practitioners using controlled substances within educational facilities approved by the State Board of Education or its successor agency.

(x) "Local authorities" means a duly organized State, County or Municipal peace unit or police force.

(y) "Look-alike substance" means a substance, other than a controlled substance which (1) by overall dosage unit appearance, including shape, color, size, markings or lack thereof, taste, consistency, or any other identifying physical characteristic of the substance, would lead a reasonable person to believe that the substance is a controlled substance, or (2) is expressly or impliedly represented to be a controlled substance or is distributed under circumstances which would lead a reasonable person to believe that the substance is a controlled substance. For the purpose of determining whether the representations made or the circumstances of the distribution would lead a reasonable person to believe the substance to be a

controlled substance under this clause (2) of subsection (y), the court or other authority may consider the following factors in addition to any other factor that may be relevant:

(a) statements made by the owner or person in control of the substance concerning its nature, use or effect;

(b) statements made to the buyer or recipient that the substance may be resold for profit;

(c) whether the substance is packaged in a manner normally used for the illegal distribution of controlled substances;

(d) whether the distribution or attempted distribution included an exchange of or demand

for money or other property as consideration, and whether the amount of the consideration was substantially greater than the reasonable retail market value of the substance.

Clause (1) of this subsection (y) shall not apply to a noncontrolled substance in its finished dosage form that was initially introduced into commerce prior to the initial introduction into commerce of a controlled substance in its finished dosage form which it may substantially resemble.

Nothing in this subsection (y) prohibits the dispensing or distributing of noncontrolled substances by persons authorized to dispense and distribute controlled substances under this Act, provided that such action would be deemed to be carried out in good faith under subsection (u) if the substances involved were controlled substances.

Nothing in this subsection (y) or in this Act prohibits the manufacture, preparation, propagation, compounding, processing, packaging, advertising or distribution of a drug or drugs by any person registered pursuant to Section 510 of the Federal Food, Drug, and Cosmetic Act (21 U.S.C. 360).

(y-1) "Mail-order pharmacy" means a pharmacy that is located in a state of the United States that delivers, dispenses or distributes, through the United States Postal Service or other common carrier, to Illinois residents, any substance which requires a prescription.

(z) "Manufacture" means the production, preparation, propagation, compounding, conversion or processing of a controlled substance other than methamphetamine, either directly or indirectly, by extraction from substances of natural origin, or independently by means of chemical synthesis, or by a combination of extraction and chemical synthesis, and includes any packaging or repackaging of the substance or labeling of its container, except that this term does not include:

(1) by an ultimate user, the preparation or compounding of a controlled substance for

his or her own use; or

(2) by a practitioner, or his or her authorized agent under his or her supervision, the

preparation, compounding, packaging, or labeling of a controlled substance:

(a) as an incident to his or her administering or dispensing of a controlled

substance in the course of his or her professional practice; or

(b) as an incident to lawful research, teaching or chemical analysis and not for

sale.

(z-1) (Blank).

(z-5) "Medication shopping" means the conduct prohibited under subsection (a) of Section 314.5 of this Act.

(z-10) "Mid-level practitioner" means (i) a physician assistant who has been delegated authority to prescribe through a written delegation of authority by a physician licensed to practice medicine in all of its branches, in accordance with Section 7.5 of the Physician Assistant Practice Act of 1987, (ii) an advanced practice registered nurse who has been delegated authority to prescribe through a written delegation of authority by a physician licensed to practice medicine in all of its branches or by a polyaician licensed to practice medicine in all of its branches or by a polyaician function of authority by a physician licensed to practice medicine in all of its branches or by a poliatric physician, in accordance with Section 65-40 of the Nurse Practice Act, (iii) an advanced practice registered nurse certified as a nurse practitioner, nurse midwife, or clinical nurse specialist who has been granted authority to prescribe by a hospital affiliate in accordance with Section 65-45 of the Nurse Practice Act, (iv) an animal euthanasia agency, or (v) a prescribing psychologist.

(aa) "Narcotic drug" means any of the following, whether produced directly or indirectly by extraction from substances of vegetable origin, or independently by means of chemical synthesis, or by a combination of extraction and chemical synthesis:

(1) opium, opiates, derivatives of opium and opiates, including their isomers, esters,

ethers, salts, and salts of isomers, esters, and ethers, whenever the existence of such isomers, esters, ethers, and salts is possible within the specific chemical designation; however the term "narcotic drug" does not include the isoquinoline alkaloids of opium;

(2) (blank);

(3) opium poppy and poppy straw;

(4) coca leaves, except coca leaves and extracts of coca leaves from which substantially

all of the cocaine and ecgonine, and their isomers, derivatives and salts, have been removed;

(5) cocaine, its salts, optical and geometric isomers, and salts of isomers;

(6) ecgonine, its derivatives, their salts, isomers, and salts of isomers;

(7) any compound, mixture, or preparation which contains any quantity of any of the

substances referred to in subparagraphs (1) through (6).

(bb) "Nurse" means a registered nurse licensed under the Nurse Practice Act.

(cc) (Blank).

(dd) "Opiate" means any substance having an addiction forming or addiction sustaining liability similar to morphine or being capable of conversion into a drug having addiction forming or addiction sustaining liability.

(ee) "Opium poppy" means the plant of the species Papaver somniferum L., except its seeds.

(ee-5) "Oral dosage" means a tablet, capsule, elixir, or solution or other liquid form of medication intended for administration by mouth, but the term does not include a form of medication intended for buccal, sublingual, or transmucosal administration.

(ff) "Parole and Pardon Board" means the Parole and Pardon Board of the State of Illinois or its successor agency.

(gg) "Person" means any individual, corporation, mail-order pharmacy, government or governmental subdivision or agency, business trust, estate, trust, partnership or association, or any other entity.

(hh) "Pharmacist" means any person who holds a license or certificate of registration as a registered pharmacist, a local registered pharmacist or a registered assistant pharmacist under the Pharmacy Practice Act.

(ii) "Pharmacy" means any store, ship or other place in which pharmacy is authorized to be practiced under the Pharmacy Practice Act.

(ii-5) "Pharmacy shopping" means the conduct prohibited under subsection (b) of Section 314.5 of this Act.

(ii-10) "Physician" (except when the context otherwise requires) means a person licensed to practice medicine in all of its branches.

(jj) "Poppy straw" means all parts, except the seeds, of the opium poppy, after mowing.

(kk) "Practitioner" means a physician licensed to practice medicine in all its branches, dentist, optometrist, podiatric physician, veterinarian, scientific investigator, pharmacist, physician assistant, advanced practice registered nurse, licensed practical nurse, registered nurse, emergency medical services personnel, hospital, laboratory, or pharmacy, or other person licensed, registered, or otherwise lawfully permitted by the United States or this State to distribute, dispense, conduct research with respect to, administer or use in teaching or chemical analysis, a controlled substance in the course of professional practice or research.

(ll) "Pre-printed prescription" means a written prescription upon which the designated drug has been indicated prior to the time of issuance; the term does not mean a written prescription that is individually generated by machine or computer in the prescriber's office.

(mm) "Prescriber" means a physician licensed to practice medicine in all its branches, dentist, optometrist, prescribing psychologist licensed under Section 4.2 of the Clinical Psychologist Licensing Act with prescriptive authority delegated under Section 4.3 of the Clinical Psychologist Licensing Act, podiatric physician, or veterinarian who issues a prescription, a physician assistant who issues a prescription for a controlled substance in accordance with Section 303.05, a written delegation, and a written collaborative agreement required under Section 7.5 of the Physician Assistant Practice Act of 1987, an advanced practice registered nurse with prescriptive authority delegated under Section 65-40 of the Nurse Practice Act and in accordance with Section 303.05, a written delegation, and a written collaborative agreement under Section 65-35 of the Nurse Practice Act, an advanced practice registered nurse midwife, or clinical nurse specialist who has full practice registered as a nurse practice Act and in accordance with Section 303.05, of the Nurse Practice Act and in accordance with Section 303.05, of the Nurse Practice Act and in accordance with Section 303.05, or an advanced practice registered nurse certified as a nurse practice in accordance with Section 65-43 of the Nurse Practice Act and in accordance with section 303.05, or an advanced practice registered nurse certified as a nurse practice nurse specialist who has full practice authority pursuant to Section 65-43 of the Nurse Practice Act.

(nn) "Prescription" means a written, facsimile, or oral order, or an electronic order that complies with applicable federal requirements, of a physician licensed to practice medicine in all its branches, dentist, podiatric physician or veterinarian for any controlled substance, of an optometrist in accordance with Section 15.1 of the Illinois Optometric Practice Act of 1987, of a prescribing psychologist licensed under Section 4.2 of the Clinical Psychologist Licensing Act with prescriptive authority delegated under Section 4.3 of the Clinical Psychologist Licensing Act, of a physician assistant for a controlled substance in accordance with Section 303.05, a written delegation, and a written collaborative agreement required under

Section 7.5 of the Physician Assistant Practice Act of 1987, of an advanced practice registered nurse with prescriptive authority delegated under Section 65-40 of the Nurse Practice Act who issues a prescription for a controlled substance in accordance with Section 303.05, a written delegation, and a written collaborative agreement under Section 65-35 of the Nurse Practice Act, of an advanced practice registered nurse certified as a nurse practitioner, nurse midwife, or clinical nurse specialist who has been granted authority to prescribe by a hospital affiliate in accordance with Section 65-45 of the Nurse Practice Act and in accordance with Section 303.05 when required by law, or of an advanced practice registered nurse certified as a nurse practitioner, nurse midwife, or clinical nurse specialist who has full practice authority pursuant to Section 65-43 of the Nurse Practice Act.

(nn-5) "Prescription Information Library" (PIL) means an electronic library that contains reported controlled substance data.

(nn-10) "Prescription Monitoring Program" (PMP) means the entity that collects, tracks, and stores reported data on controlled substances and select drugs pursuant to Section 316.

(oo) "Production" or "produce" means manufacture, planting, cultivating, growing, or harvesting of a controlled substance other than methamphetamine.

(pp) "Registrant" means every person who is required to register under Section 302 of this Act.

(qq) "Registry number" means the number assigned to each person authorized to handle controlled substances under the laws of the United States and of this State.

(qq-5) "Secretary" means, as the context requires, either the Secretary of the Department or the Secretary of the Department of Financial and Professional Regulation, and the Secretary's designated agents.

(rr) "State" includes the State of Illinois and any state, district, commonwealth, territory, insular possession thereof, and any area subject to the legal authority of the United States of America.

(rr-5) "Stimulant" means any drug that (i) causes an overall excitation of central nervous system functions, (ii) causes impaired consciousness and awareness, and (iii) can be habit-forming or lead to a substance abuse problem, including but not limited to amphetamines and their analogs, methylphenidate and its analogs, cocaine, and phencyclidine and its analogs.

(rr-10) "Synthetic drug" includes, but is not limited to, any synthetic cannabinoids or piperazines or any synthetic cathinones as provided for in Schedule I.

(ss) "Ultimate user" means a person who lawfully possesses a controlled substance for his or her own use or for the use of a member of his or her household or for administering to an animal owned by him or her or by a member of his or her household.

Sec. 220. Electronic health record systems. The Bureau of Pharmacy and Clinical Support Systems shall establish a form to allow EHR systems to certify the identity of a third party that will provide access to the Prescription Information Library for the EHR system using all or part of a computer program or system that is a federally certified Health IT Module for the EHR system. Before the Health IT Module is permitted to connect to the Prescription Information Library, it must enter into a business associate agreement with the EHR system by the laws of this State, including data privacy and security obligations that the Bureau otherwise imposes on EHR systems."
