Haas, that JCAR recommend the Board pursue filling vacancies on the Board, engage industry stakeholders at its quarterly Board meetings, and report back to the Committee at its June 2024 meeting regarding if the elimination of the Temporary Certificate of Operation has impacted the public's access to elevators within this State. The motion passed unanimously (10-0-0).

State Fire Marshal – Fire Sprinkler Contractor Licensing Act (41 Ill. Adm. Code 109; 47 Ill. Reg. 6614)

Sen. Cunningham: Can you please explain the agreement struck between OSFM and the stakeholders?

Ms. Nunes: OSFM and stakeholders have agreed to language similar to what was proposed at 1st Notice with other technical clarifications.
