1 HOUSE RESOLUTION

12 Party since 1996, serving as party chairman; and

14 being named Ambassador of the Year by the Glendale Heights
15 Chamber of Commerce in 2009, Business Person of the Year by the
16 Roselle Chamber of Commerce & Industry in 2010, and Member of
17 the Year by the Chicagoland Italian American Charitable
18 Organization (CIACO) in 2021; and
