### SYNOPSIS AS INTRODUCED:

805 ILCS 180/50-10

Amends the Limited Liability Company Act. Reduces various filing fees payable to the Secretary of State by 50%. Effective immediately.

1 AN ACT concerning business.

2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 5. The Limited Liability Company Act is amended by  
5 changing Section 50-10 as follows:

6 (805 ILCS 180/50-10)

7 Sec. 50-10. Fees.

8 (a) The Secretary of State shall charge and collect in  
9 accordance with the provisions of this Act and rules  
10 promulgated under its authority all of the following:

11 (1) Fees for filing documents.

12 (2) Miscellaneous charges.

13 (3) Fees for copies of any documents.

14 (b) The Secretary of State shall charge and collect for  
15 all of the following:

16 (1) Filing articles of organization (domestic),  
17 application for admission (foreign), and restated articles  
18 of organization (domestic), \$75 ~~\$150~~. Notwithstanding the  
19 foregoing, the fee for filing articles of organization  
20 (domestic), application for admission (foreign), and  
21 restated articles of organization (domestic) in connection  
22 with a limited liability company with a series or the  
23 ability to establish a series pursuant to Section 37-40 of

1 this Act is \$200 ~~\$400~~.

2 (2) Filing amendments (domestic or foreign), \$25 ~~\$50~~.

3 (3) Filing a statement of termination or application  
4 for withdrawal, \$5.

5 (4) Filing an application to reserve a name, \$25.

6 (5) Filing a notice of cancellation of a reserved  
7 name, \$5.

8 (6) Filing a notice of a transfer of a reserved name,  
9 \$25.

10 (7) Registration of a name, \$25 ~~\$50~~.

11 (8) Renewal of registration of a name, \$25 ~~\$50~~.

12 (9) Filing an application for use of an assumed name  
13 under Section 1-20 of this Act, \$75 ~~\$150~~ for each year or  
14 part thereof ending in 0 or 5, \$60 ~~\$120~~ for each year or  
15 part thereof ending in 1 or 6, \$45 ~~\$90~~ for each year or  
16 part thereof ending in 2 or 7, \$30 ~~\$60~~ for each year or  
17 part thereof ending in 3 or 8, \$15 ~~\$30~~ for each year or  
18 part thereof ending in 4 or 9, and a renewal for each  
19 assumed name, \$75 ~~\$150~~.

20 (9.5) Filing an application for change of an assumed  
21 name, \$12 ~~\$25~~.

22 (10) Filing an application for cancellation of an  
23 assumed name, \$5.

24 (11) Filing an annual report of a limited liability  
25 company or foreign limited liability company, \$37 ~~\$75~~, if  
26 filed as required by this Act, plus a penalty if

1 delinquent. Notwithstanding the foregoing, the fee for  
2 filing an annual report of a limited liability company or  
3 foreign limited liability company is \$37 ~~\$75~~ plus \$25 ~~\$50~~  
4 for each series for which a certificate of designation has  
5 been filed pursuant to Section 37-40 of this Act and is in  
6 effect on the last day of the third month preceding the  
7 company's anniversary month, plus a penalty if delinquent.

8 (12) Filing an application for reinstatement of a  
9 limited liability company or foreign limited liability  
10 company, \$100 ~~\$200~~.

11 (13) Filing articles of merger, \$50 ~~\$100~~ plus \$25 ~~\$50~~  
12 for each party to the merger in excess of the first 2  
13 parties.

14 (14) (Blank).

15 (15) Filing a statement of change of address of  
16 registered office or change of registered agent, or both,  
17 or filing a statement of correction, \$12 ~~\$25~~.

18 (16) Filing a petition for refund, \$5.

19 (17) Filing a certificate of designation of a limited  
20 liability company with a series pursuant to Section 37-40  
21 of this Act, \$25 ~~\$50~~.

22 (18) (Blank).

23 (19) Filing, amending, or cancelling a statement of  
24 authority, \$25 ~~\$50~~.

25 (20) Filing, amending, or cancelling a statement of  
26 denial, \$5 ~~\$10~~.

1 (21) Filing any other document, \$5.

2 (22) For furnishing a copy or certified copy of any  
3 document, instrument, or paper relating to a limited  
4 liability company or foreign limited liability company, or  
5 for a certificate, \$12 ~~\$25~~.

6 (c) (Blank).
