A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 ARTICLE 1

5 OPERATIONAL EXPENSES

6 Section 5. In addition to other amounts appropriated, the
7 amount of \$17,107,000, or so much thereof as may be necessary,
8 respectively, is appropriated from the General Revenue Fund to
9 the Department of Commerce and Economic Opportunity for
10 operational expenses, awards, grants and permanent
11 improvements for the fiscal year ending June 30, 2027,
12 including prior years' costs.

13 Section 10. The following named amounts, or so much
14 thereof as may be necessary, respectively, are appropriated to
15 the Department of Commerce and Economic Opportunity:

 23 grants Pursuant to Section 7-10 and Section 7-15 of the
 24 Cannabis Regulation and Tax Act.

1 Section 25. The sum of \$2,060,100, or so much thereof as
 2 may be necessary, is appropriated to the Department of
 3 Commerce and Economic Opportunity from the Cannabis Regulation
