Makes appropriations for the ordinary and contingent expenses of the Illinois State Police for the fiscal year beginning July 1, 2026, as follows:

A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much thereof
6 as may be necessary, respectively, are appropriated to the
7 Illinois State Police for the following purposes:

8 DIVISION OF JUSTICE SERVICES

9 Payable from General Revenue Fund:

10	For Payment of Tort Claims.....	50,000
11	For Refunds.....	<u>2,000</u>
12	Total	\$52,000

13 Payable from the State Police Vehicle Fund:

14	For purchase of vehicles and accessories,	
15	including prior years' costs	30,000,000

16 Section 10. The sum of \$4,000,000, or so much thereof as
17 may be necessary, is appropriated from the State Asset
18 Forfeiture Fund to the Illinois State Police for payment of
19 their expenditures as outlined in the Drug Asset Forfeiture
20 Procedure Act, the Cannabis Control Act, and the Illinois
21 Controlled Substances Act.

1 Section 15. The sum of \$2,500,000, or so much thereof as
 2 may be necessary, is appropriated from the Federal Asset
 3 Forfeiture Fund to the Illinois State Police for payment of
 4 their expenditures in accordance with the Federal Equitable
 5 Sharing Guidelines.

6 Section 20. The following named amounts, or so much
 7 thereof as may be necessary, respectively, are appropriated to
 8 the Illinois State Police for the following purposes:

6 Section 25. The sum of \$26,550,000, or so much thereof as
 7 may be necessary, is appropriated from the State Police
 8 Operations Assistance Fund to the Illinois State Police for
 9 the ordinary and contingent expenses incurred by the Illinois
 10 State Police.

11 Section 30. The sum of \$25,000,000, or so much thereof as
 12 may be necessary, is appropriated from the State Police
 13 Operations Assistance Fund to the Illinois State Police for
 14 the ordinary and contingent expenses of state funded program
 15 expenses.

16 Section 35. The sum of \$28,550,000, or so much thereof as
 17 may be necessary, is appropriated from the State Police Law
 18 Enforcement Administration Fund to the Illinois State Police,
 19 Division of Operations, for all costs associated with a cadet
 20 program for the Illinois State Police.

21 Section 40. The sum of \$25,000,000, or so much thereof as
 22 may be necessary, is appropriated from the Illinois State

1 Police Federal Projects Fund to the Illinois State Police for
 2 costs related to federal awards and grants, including prior
 3 years' costs.

4 Section 45. The sum of \$35,000,000, or so much thereof as
 5 may be necessary, is appropriated from the Illinois State
 6 Police Federal Projects Fund to the Illinois State Police for
 7 costs related to the Motor Carrier Safety Assistance Program.

8 Section 50. The following named amounts, or so much
 9 thereof as may be necessary, respectively, are appropriated to
 10 the Illinois State Police for the following purposes:

11 DIVISION OF FORENSIC SERVICES AND IDENTIFICATION

12 Payable from the General Revenue Fund:

13	For Administration of a Statewide Sexual

18 Payable from the State Crime Laboratory Fund:

21 Section 55. The sum of \$2,250,000, or so much thereof as
 22 may be necessary, is appropriated from the Mental Health
 23 Reporting Fund to the Illinois State Police, Division of

1 Forensic Services and Identification, for expenses as outlined
2 in the Firearm Concealed Carry Act and the Firearm Owners
3 Identification Card Act.

4 Section 60. The sum of \$31,500,000, or so much thereof as
5 may be necessary, is appropriated from the State Police
6 Firearm Services Fund to the Illinois State Police for
7 expenses as outlined in the Firearm Concealed Carry Act and
8 the Firearm Owners Identification Card Act.

9 Section 65. The sum of \$230,000,000, or so much thereof as
10 may be necessary, is appropriated from the Statewide 9-1-1
11 Fund to the Illinois State Police, Division of Justice
12 Services, for costs pursuant to the Emergency Telephone System
13 Act.

14 Section 70. The sum of \$1,000,000, or so much thereof as
15 may be necessary, is appropriated from the General Revenue
16 Fund to the Illinois State Police, for the ordinary and
17 contingent expenses of the Safe2Help Program.

18 Section 75. The sum of \$4,000,000, or so much thereof as
19 may be necessary, is appropriated from the State Facility
20 Repair and Maintenance Fund to the Department of Illinois
21 State Police for repairs, maintenance, and other permanent
22 improvements.

1 Section 80. No contract shall be entered into or
2 obligation incurred or any expenditure made from any
3 appropriation herein made in Section 75 of this Article until
4 after the purpose and amounts have been approved in writing by
5 the Governor.

6 Section 99. Effective date. This Act takes effect July 1,
7 2026.
