#### HOUSE RESOLUTION

The following resolution was offered and placed in the Committee on Rules.

**HOUSE JOINT RESOLUTION 142** 

Offered by Representative Carroll:

WHEREAS, The massacre at the Tree of Life Synagogue in Pittsburgh shocked the world; and

WHEREAS, A peaceful sabbath service turned into a massacre of Jewish life; families were gathered for weekly Shabbat prayer and to welcome a child into the Jewish community when an armed intruder opened fire inside the synagogue with an assault rifle, slaughtering 11 Jewish congregants and wounding six brave law enforcement officers; and

WHEREAS, The Jewish Caucus of the Illinois Legislature condemns this anti-Semitic act and will continue to fight against the hatred and violence directed at their community; and

WHEREAS, This is not only a Jewish issue; it also affects the African-American, Latino, LGBTQ, Muslim, and immigrant communities, and everyone who has been the victim of white nationalist violence; and

WHEREAS, Children must know that evil begets evil, and that violence begets violence; therefore, be it RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we stand in solidarity with the Jewish community in Pittsburgh, and we condemn these acts of terror, whether they take place in a house of worship in Pittsburgh, a parking lot in Kentucky, a nightclub, a schoolyard, or a playground; and be it further

RESOLVED, That we must seek to build a safe and inclusive community, we must reject terrorism in all its forms, and we must pass laws to protect our communities from violence and fear; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Tree of Life Synagogue as a symbol of our solidarity.
