SENATE BILL ON SECOND READING

SENATE BILL 1298. Having been read by title a second time on October 24, 2017, and held on the order of Second Reading, the same was again taken up.

Amendment No. 1 was offered in the Committee on Executive, adopted and reproduced.

SENATE BILL ON THIRD READING

On motion of Representative Currie, SENATE BILL 1298 was taken up and read by title a third time. And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote: 100, Yeas; 6, Nays; 1, Answering Present.

(ROLL CALL 2)

SENATE BILL ON SECOND READING

SENATE BILL 3531. Having been read by title a second time on May 29, 2018, and held on the order of Second Reading, the same was again taken up.

Floor Amendment No. 1 remained in the Committee on Rules.

Representative Greg Harris offered and withdrew Amendment No. 2.

The foregoing motion prevailed and the amendment was adopted.

And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote: 68, Yeas; 37, Nays; 2, Answering Present.

(ROLL CALL 3)
