WHEREAS, Buddy Guy opened his own nightclub, Buddy Guy's Legends, in Chicago in 1989, where he has played annual residencies and acted as a host for other blues musicians; and

WHEREAS, Buddy Guy was inducted into the Blues Hall of Fame in 1985 and the Rock and Roll Hall of Fame in 2005; he was awarded the National Medal of Arts in 2003 and was a Kennedy Center honoree in 2012; that same year, he performed the song Sweet Home Chicago at the White House, where he was joined by President Obama for the chorus; he won the Grammy Award for lifetime achievement in 2015; therefore, be it

WHEREAS, The American Society of Civil Engineers (ASCE) stated in its 2021 report card that the United States received a grade of C- regarding the current state of infrastructure and that more than six trillion dollars is needed to restore the nation's infrastructure to a state of good repair; over two trillion dollars is currently not funded, and the remainder is inadequately funded; new, 21st Century projects are also unfunded; and

WHEREAS, The Illinois ASCE 2022 Report Card assigned the State's systems a cumulative grade of "C-"; the report analyzes 11 categories of infrastructure pertinent to Illinois, including aviation (C+), bridges (C), dams (C+), drinking water (D+), inland waterways (D), ports (C-), rail (C+), roads (D+), storm water (D+), transit (D+), and wastewater (C-); and

WHEREAS, Out of four million total water service lines, over 675,000 have been identified as lead and almost 380,000 as copper with lead solder services; and

WHEREAS, Illinois' aging drinking water infrastructure is leading to leaking pipelines, costing taxpayers money and critical resources; in 2017, a total of 106 million gallons per day (MGD) were lost among Lake Michigan allocation permittees, or 13% of total water supplied; additional funding is needed for aging storm water infrastructure that must keep up with increasing rainfall trends from climate change; and

WHEREAS, Illinois needs at least 300,000 new units of affordable housing for the most housing insecure; and

WHEREAS, There are 2,405 bridges in poor condition, or 9% of all bridges in the State that are crossed by motorists every day; approximately 70% of Illinois bridges in poor condition are owned by counties, towns, or cities, suggesting the local maintenance backlog is a significant challenge; and

WHEREAS, U.S. Reps. Danny Davis and Jesus "Chuy" Garcia introduced H.R. 4052 (The National Infrastructure Bank Act) on June 13, 2023 in the 118th U.S. Congress; this would create a \$5 trillion bank to finance all infrastructure requirements to bring the system to a state of good repair and build new projects; and

WHEREAS, The new national infrastructure bank is modeled on previous banks that helped build much of the country's infrastructure under Presidents George Washington, James Madison, Abraham Lincoln, and Franklin D. Roosevelt; the last such bank helped bring us out of the Great Depression and win World War II; and

WHEREAS, The new national infrastructure bank will create 25 million new jobs, pay Davis-Bacon wages, and enforce Buy America provisions; Disadvantaged Business Enterprises will receive significant disbursements, and the bill mandates large-scale minority hiring; the bank will require no new federal spending or federal taxes; according to experts, the bank will grow the economy by 5% per year as did its predecessors; and

WHEREAS, Many organizations are in support of a new national infrastructure bank, including the National Black Caucus of State Legislators, the National Hispanic Caucus of State Legislators, the National Asian-Pacific American Caucus of State Legislators, the Council of State Governments-East, the National Association of Counties, the National Association of Development Organizations, the US High Speed Rail Association, the National Latino Farmers and Ranchers Trade Association, the American Sustainable Business Council, the National Association of Minority Contractors, and the United Association of Plumbers and Steamfitters International Union; in addition, 26 state legislatures have introduced or passed resolutions of support, as have county and city councils, including the Chicago City Council; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the United States Congress to pass H.R. 4052 to create a new national infrastructure bank to finance urgently needed infrastructure projects; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President of the United States, the U.S. Senate Majority Leader, the U.S. Senate Minority Leader, the U.S. Speaker of the House, the U.S. House of Representatives Minority Leader, all members of the Illinois Congressional Delegation, and the Governor.

## **HOUSE RESOLUTION 524**

WHEREAS, National History Day's core program is its competition in which students in grades 6 through 12 choose a historical topic that they then dive deeply into by conducting extensive research in libraries, archives, and museums before presenting their conclusions and evidence through papers, exhibits,

performances, documentaries, or websites, moving through a series of contest levels where they are evaluated by professional historians and educators; and

WHEREAS, The knowledge of history is the birthright of all individuals from every walk of life, and the study of history allows us to learn and grow from the past in order to advance towards a brighter, happier, and more peaceful future where we can live life to the fullest; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare June 15, 2024 as History Day in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the National History Day organization as a symbol of our respect and esteem.

## **HOUSE RESOLUTION 526**

Offered by Representative Miller:

WHEREAS, The members of the Illinois House of Representatives are disappointed to learn of the price fixing real estate scandal that took place in Missouri, Kansas, and Illinois over an unknown amount of time; and

WHEREAS, The National Association of Realtors (NAR) is at the forefront of this scandal; founded as the National Association of Real Estate Exchanges in 1908, the NAR has grown to be America's largest trade association and is responsible for representing 1.5 million members, including National Association of Realtors's institutes, societies, and councils that are involved in all aspects of the residential and commercial real estate industries; and

WHEREAS, Home sellers have been awarded \$1.8 billion in damages following a ruling by a jury in Kansas City, Missouri that found a conspiracy by the NAR existed to follow and enforce the Cooperative Compensation Rule, meaning home sellers would have to pay more for real estate brokerage services; and

WHEREAS, The NAR has a code of ethics stating that the group aims to serve consumers in a way that encourages cooperation with each other while furthering their clients' best interests; this scandal is a direct violation of the association's own code and has led many consumers who put their trust in the NAR to be worse off; and

WHEREAS, The NAR has great power throughout the real estate field, which needs to be respected by its own members; the association is relied on for important steps in citizens' livelihoods in the home selling process and should not abuse this power as it hurts those who it claims to help, the people who are key contributors to their markets; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we condemn the actions taken by the National Association of Realtors that increased profits while hurting consumers; and be it further

WHEREAS, These medicolegal death investigation professionals pursue further training and education through the Illinois Coroner Training Board, the Illinois Coroners and Medical Examiners Association, the International Association of Coroners and Medical Examiners, the American Board of Medicolegal Death Investigators, the National Association of Medical Examiners, and a host of other related organizations to continue their professional development as skilled, qualified, ethical, and knowledgeable investigators, fiercely loyal to the mission they serve that so often goes without recognition or accolade; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the week of January 21 through January 27, 2024 as Medicolegal Death Investigation Professionals Week in honor of the coroners, deputy coroners, medical examiners, support and ancillary staff, forensic pathologists, and medicolegal death investigators for their ongoing commitment of service to the citizens of Illinois and their communities; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Illinois Coroners and Medical Examiners Association as a symbol of our esteem and respect.

# **HOUSE RESOLUTION 535**

Offered by Representative Caulkins:

WHEREAS, The recent congressional investigation that unearthed a pattern of behavior by law enforcement agencies seeking access to patient prescription records through pharmacies without a warrant is alarming; and

WHEREAS, Of the eight major pharmacy chains surveyed by Congress, only Amazon Pharmacy stated it had a policy of informing customers when law enforcement requested the customer's records; and

WHEREAS, Three of the eight pharmacy chains reported staff facing extreme pressure from law enforcement to provide an immediate response; and

WHEREAS, The people of these United States, and of the great State of Illinois, enjoy a broad array of privacy rights; and

WHEREAS, Prescription records are among the most private pieces of information the government can obtain about an individual; and

WHEREAS, The people of the U.S. are protected from warrantless search and seizure by the 4th Amendment of the Constitution of the United States; and

WHEREAS, Pharmacies can and should insist on a warrant and can and should invite law enforcement agencies that insist on demanding patient medical records with solely a subpoena to go to court to enforce that demand; and

WHEREAS, Due to the state of the third-party doctrine in the federal courts, it is necessary for the Congress of the United States to pass further positive legislation to reinforce Americans' reasonable expectations of privacy in medical data, regardless of where this data is held or by whom it is owned; and

WHEREAS, With the foregoing in mind, Senator Wyden and Congresswomen Jayapal and Jacobs concluded that the federal Department of Health and Human Services (HHS) must consider further strengthening its HIPAA regulations to more closely align them with Americans' reasonable expectations of privacy and constitutional principles; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge pharmacies in the State of Illinois to insist on a warrant or court order prior to releasing patient information to protect Americans' reasonable expectations of privacy and constitutional principles; and be it further

RESOLVED, That we urge the Congress of the United States to pass further positive legislation to reinforce Americans' reasonable expectations of privacy in medical data and to protect Americans' reasonable expectations of privacy and constitutional principles; and be it further

RESOLVED, That we urge the federal Department of Health and Human Services (HHS) to consider further strengthening its HIPAA regulations to more closely align them with Americans' reasonable expectations of privacy and constitutional principles; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Speaker of the House of Representatives of the United States, Mike Johnson, the President Pro Tempore of the United States Senate, Patty Murray, the Secretary of Health and Human Services, Xavier Becerra, and the Illinois Pharmacists Association.

#### **HOUSE RESOLUTION 536**

WHEREAS, Over 100 million operations and procedures are performed every year with anesthesia, and physician anesthesiologists play a critical role, before, during, and after procedures, making patient safety their top priority; and

WHEREAS, Anesthesia is safer than ever before, but there is always potential for complications and side effects; physician anesthesiologists have the training and expertise to help minimize risks, monitor for any problems, and take quick action; and

WHEREAS, Physician anesthesiologists are required to complete 12 or more years of post-secondary education, at least 12,000 hours of clinical training, and additional months of training in intensive care and subspecialty units; and

WHEREAS, When seconds count and when emergencies or complications occur unexpectedly, physician anesthesiologists draw on their extensive medical education and years of clinical training and experience to make critical decisions that save lives; and

WHEREAS, Physician anesthesiologists are committed to high quality and safe patient care and to educating patients to make their anesthesia even safer, to reduce risk of complication, and to improve recovery from surgery; and

WHEREAS, Physician anesthesiologists are recognized leaders uniquely suited to prevent opioid abuse and misuse by employing opioid-minimizing techniques while ensuring patients have access to appropriate pain treatments; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare January 28 through February 3, 2024 as Physician Anesthesiologists Week in the State of Illinois and ask all citizens to join us in recognizing physician anesthesiologists, who have developed the techniques and protocols that have greatly improved the safety of anesthesiology and the well-being of surgical patients each day; and be it further

#### **HOUSE RESOLUTION 538**

Offered by Representative Buckner:

WHEREAS, The United States government, led by former President Dwight D. Eisenhower, in collaboration with state governments created an immense network of interstate highways that linked the vast majority of the nation in meaningful ways through the Federal-Aid Highway Act of 1956; and

WHEREAS, The construction of the interstate highway system was declared completed in 1992 after 36 years of construction and \$114 billion spent, which is equivalent to \$558 billion in 2021; and

WHEREAS, The United States government paid for 90% of the expressways while states provided the remaining 10%; and

WHEREAS, In exchange for providing the vast majority of the funding, the United States government dictated the route of the interstate highway system; and

WHEREAS, With this control of the layout, the United States government focused the route through dense metropolitan and urban areas; and

WHEREAS, Although the interstate highway system radically connected populations, underprivileged communities have been bifurcated and isolated by its creation and the route placement; and

WHEREAS, The federal Department of Transportation estimates that 475,000 households and more than one million people were displaced nationwide because of federally funded roadway construction; and

WHEREAS, This separation has resulted in a long list of unintended consequences, including, but not limited to, the creation of gang turfs, loss of community spaces, the separation of families, negative economic impacts, and a profound emotional footprint; and

WHEREAS, Illinois played a role in the funding of the interstate highway system; and

WHEREAS, Illinois has the mandate to rectify inequity when it presents itself; and

WHEREAS, Numerous cities across the nation have successfully employed expressway lids to correct the unfairness of the placement of the interstate highway system and capture its many benefits; and

WHEREAS, Expressway lids provide a cost efficient way to reconnect communities healthily and efficiently; and

WHEREAS, Expressway lids also provide an opportunity to create more space for the construction of parks, community centers, water storage, and housing while reducing both air and noise pollution; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the need to reunite these communities split by the creation of the interstate highway system; and be it further

RESOLVED, That we recognize the importance of expressway lids as a partial solution to that problem; and be it further

RESOLVED, That the State of Illinois should utilize federal resources, in partnership with state agencies and local entities, to begin reconnecting these communities with, among other things, expressway lids.

#### **HOUSE RESOLUTION 540**

WHEREAS, Turner Syndrome (TS) is a chromosomal abnormality that randomly affects those born female; it occurs when the secondary X chromosome is partially or completely missing; many have mosaic Turner Syndrome, for which the number of X chromosomes can vary; and

WHEREAS, Most fetuses (98-99%) with Turner Syndrome will die before birth, resulting in approximately 10% of all first-trimester miscarriages, and one in 2,000 live female births has Turner Syndrome; those who do survive often face lifelong physical, emotional, cognitive, and/or psychological challenges that can be mitigated with early diagnosis and treatment; and

WHEREAS, More than 30% of individuals born with Turner Syndrome are not diagnosed until they are 15 years of age, and only 3.5% receive adequate care; however, with increased awareness, the livelihoods of those affected can be greatly improved; there are over 85,337 individuals living with this condition in the U.S.; and

WHEREAS, An increase in awareness for Turner Syndrome can help those with the condition and can lead to earlier diagnosis and better treatment; and

WHEREAS, People living with Turner Syndrome deserve the resources, education, and support that they need for a healthy and fulfilling life; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare February of 2024 as "Turner Syndrome Awareness Month" in the State of Illinois; and be it further

RESOLVED, That we urge Turner Syndrome Awareness Month to be used to increase awareness of the condition and urge that funding and support for awareness events, educational initiatives, increased research, and support groups be increased.

# **HOUSE RESOLUTION 545**

WHEREAS, Fire fighters serve communities across Illinois by putting our safety above their own; and WHEREAS, Fire fighters often work in a toxic environment filled with smoke, soot, and other carcinogens; and

WHEREAS, All 50 states in the United States recognize cancer as a presumptive workers' compensation claim for fire fighters; and

WHEREAS, Early detection of cancer through routine screening leads to earlier treatment and better disease outcomes, including improved survival and reduced morbidity; and

WHEREAS, The International Association of Fire Fighters (IAFF) and the Firefighter Cancer Support Network (FCSN) have declared January as Fire Fighter Cancer Awareness Month; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the month of January 2024 as Fire Fighter Cancer Awareness Month in the State of Illinois; and be it further

RESOLVED, That suitable copies of this resolution be presented to the International Association of Fire Fighters (IAFF) and the Firefighter Cancer Support Network (FCSN) with our sincere appreciation for their efforts.

## **HOUSE RESOLUTION 546**

Offered by Representative Buckner:

WHEREAS, The Heisman Trophy is awarded annually by the Heisman Trophy Trust to recognize the best college football player in the United States and was first awarded to Jay Berwanger, representing the University of Chicago Maroons; and

WHEREAS, Reggie Bush, representing the University of Southern California (USC) Trojans, was awarded the Heisman Trophy in 2005 amidst consecutive National Championship Game appearances for the Trojans and after having what is regarded as one of the greatest seasons by a player in college football history; and

WHEREAS, In 2006, the National Collegiate Athletic Association (NCAA) began investigating the Trojans' football program for alleged violations of NCAA rules and regulations, culminating in a report alleging that Reggie Bush's family received impermissible benefits related to a potential future marketing agreement but not that Reggie Bush himself had received benefits for participating in athletics; and

WHEREAS, In 2010, the NCAA declared that Reggie Bush's statistics and the wins of the Trojans' football program would be vacated for the 2005 season, leading to the revocation of his Heisman Trophy award; and

WHEREAS, California courts at the trial and appellate level later found that the NCAA's report was false, misleading, and unreliable; and

WHEREAS, Laws across the country, including in Illinois, and updated NCAA rules now allow the type of marketing agreements that were previously at question in alleged rules violations by Reggie Bush and USC; and

WHEREAS, Under the rules of the Heisman Trophy Trust, Reggie Bush's Heisman Trophy award cannot be restored until the NCAA reinstates his statistics for the 2005 season; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the NCAA to admit the flaws in its investigation of Reggie Bush and restore his statistics for the 2005 season; and be it further

RESOLVED, That we urge the Heisman Trophy Trust to restore Reggie Bush's Heisman Trophy award; and be it further

RESOLVED, That suitable copies of this resolution be presented to NCAA President Charlie Baker, Heisman Trophy Trust President Michael Comerford, and Reggie Bush.

## **HOUSE RESOLUTION 547**

Offered by Representative LaPointe:

WHEREAS, Wetlands, including marshes, swamps, and bogs, play a critical role in reducing flooding, recharging groundwater supplies, and filtering pollutants and nutrients; and

WHEREAS, Illinois has a goal of reducing phosphorus and nitrogen levels by 30% by 2035; and

WHEREAS, Illinois landowners are taking proactive steps to protect and install wetlands and buffer habitats; and

WHEREAS, The State of Illinois has a responsibility to protect its remaining wetlands and reduce pollution; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare February 2, 2024 as "World Wetlands Day" in the State of Illinois; and be it further

RESOLVED, That we urge state agencies, local governments, and other organizations to work together to preserve and protect wetlands.

WHEREAS, Cholangiocarcinoma (bile duct cancer) is a rare form of cancer that originates from the cells lining the bile ducts that play a key role in digestion; there are three types of this cancer, intrahepatic, extrahepatic, and perihilar; and

WHEREAS, Approximately 12,000 Americans are diagnosed each year with cholangiocarcinoma, with numbers increasing yearly, and the mortality rate has increased dramatically in the last decade; and

WHEREAS, Patients are typically diagnosed at a late stage due to the lack of a validated early method of detection; symptoms of jaundice, abdominal pain, itchy skin, and weight loss are symptoms that do not usually present until advanced disease progression; and

WHEREAS, Cholangiocarcinoma is a rare cancer; of the top eight deadliest cancers, seven are rare; rare cancers have a five-year survival rate under 50%, with the cholangiocarcinoma five-year survival rate being approximately 20%; and

WHEREAS, There is currently no cure for cholangiocarcinoma/bile duct cancer; and

WHEREAS, Kelly green is the color representing cholangiocarcinoma/bile duct cancer awareness; and WHEREAS, Foundations, research and teaching hospitals, rare cancer advocate groups, and patient advocate groups from around the globe have joined together to recognize February 18, 2024 as World Cholangiocarcinoma Day; and

WHEREAS, Increased cholangiocarcinoma advocacy, awareness, research, and education will bring improved outcomes for patients in earlier detection and treatment and potential curative methods; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize February 18, 2024 as being World Cholangiocarcinoma Day.

# **HOUSE JOINT RESOLUTION 46**

Offered by Representative Ammons:

WHEREAS, The State of Illinois developed the world's first juvenile court in 1899 out of concern that children be removed from adult prison and receive a second chance and has consistently been a leader in protecting children and promoting their rights; and

WHEREAS, The Illinois legal innovation of a juvenile court was rapidly adopted throughout the world; and

WHEREAS, The State of Illinois, based on its history and tradition of human rights and responsibilities, is committed to the human rights of children, including those children in conflict with the law; and

WHEREAS, In the 1980s, the United States participated in a working group, along with nearly 80 other nations, to draft a Convention on the Rights of the Child, which was written with the specific purpose of promoting and protecting the well-being of all children, including those in conflict with the law; and

WHEREAS, On November 20, 1989, the United Nations General Assembly unanimously adopted the Convention on the Rights of the Child; and

WHEREAS, The United States formally signed the Convention on the Rights of the Child in 1995, signifying its intent to ratify the Convention; and

WHEREAS, The Convention on the Rights of the Child has been ratified by all of the world's nations, except the United States, making it the most widely ratified human rights document in history; and

WHEREAS, The Illinois 99th General Assembly adopted HR 1143 in 2010, with bi-partisan sponsorship, urging the ratification of the Convention on the Rights of the Child and urging all Illinois agencies to ensure their policies and practices comply with the Convention on the Rights of the Child; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we urge all agencies in the State of Illinois, in particular those concerned with the economic opportunity, education, health care, housing, justice, nutrition, protection, and recreation of children, to ensure their policies and programs comply with the Convention on the Rights of the Child; and be it further

RESOLVED, That we urge the President of the United States, Joe Biden, to submit the Convention on the Rights of the Child to the Senate Foreign Relations Committee for review; and be it further

RESOLVED, That we urge the Senate of the United States to ratify the Convention on the Rights of the Child; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President of the United States, the Minority Leader of the United States Senate, the Majority Leader of the United States Senate, and the United States Senators from Illinois.

#### **HOUSE JOINT RESOLUTION 47**

WHEREAS, It is highly fitting that the Illinois General Assembly pays honor and respect to the truly great individuals who have served our country and State and, in doing so, have made the ultimate sacrifice; and

WHEREAS, Chief Arthur L. Weston was born to Leo and Dorothy Weston in Milwaukee, Wisconsin on February 1, 1925; he graduated from West High School in 1943; he served with the U.S. Army during World War II; and

WHEREAS, Chief Weston started his career as a patrolman for the Loves Park Police Department; he was the former police chief and organizer of the Rock Valley security force; he also served as the Byron and Roscoe police chief as well as deputy coroner for Winnebago County and deputy in the Winnebago County Sheriff's Department; and

WHEREAS, Chief Weston married Marion Weston on August 21, 1947; he was a loving husband and father to Marion and his five children, Cindy Gau, Vickey Robert, Debbie Pasch, Wanda Vertterlli, and William Weston; and

WHEREAS, Chief Weston was a proud member of the Illinois Police Association, the Rockton Rotary Club, and the Rockton American Legion; and

WHEREAS, On October 27, 1977, Chief Weston responded to a burglary-in-progress call and located the suspect in an upstairs bedroom; after an intense struggle, he was able to place the suspect into custody; as he was transporting the suspect to jail, he began to have chest pains and called for backup; he was taken to a local hospital, where he died approximately one hour later; and

WHEREAS, Chief Weston gave his life in the line of duty; and

WHEREAS, At the time of his passing, Chief Weston was survived by his wife, Marion, and his children, Cindy, Vickey, Debbie, Wanda, and William; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we designate the section of Illinois Route 2 in Rockton as the "Chief Arthur L. Weston Memorial Highway"; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of the name "Chief Arthur L. Weston Memorial Highway"; and be it further

RESOLVED, That suitable copies of this resolution be presented to the family of Chief Weston and the Secretary of Transportation.
