Perfunctory Session

TUESDAY, FEBRUARY 6, 2024

At the hour of 1:06 o'clock p.m., the House convened perfunctory session.

HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 555

Offered by Representative Halbrook:

WHEREAS, Each year the President of the United States declares January 16th as Religious Freedom Day and calls upon Americans to observe this day through appropriate events and activities in homes, schools, and places of worship; and

WHEREAS, Our Founding Fathers knew the importance of freedom of religion, and the U.S. Constitution protects an individual's right to worship as they so choose with the First Amendment; and

WHEREAS, Declaring such a day for religious freedom is part of our American foundation and heritage; and

WHEREAS, January 16th was the chosen date for celebration as it is the anniversary of the exact date in 1786 when the Virginia Statute on Religious Freedom was passed; and

WHEREAS, This statute restrained the practice of taxing people to pay for the support of the local clergy and protected the civil rights of people to express their religious beliefs without suffering discrimination; and

WHEREAS, In Illinois, this date was observed by former Governor Rauner, and this important day of freedom should be brought into our chamber and State; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare January 16, 2024 as "Religious Freedom Day" in the State of Illinois and encourage our citizens to reflect on our proud tradition of religious freedom so that it may be preserved for future generations.

HOUSE RESOLUTION 556

Offered by Representative Nichols:

WHEREAS, The members of the Illinois House of Representatives wish to recognize and celebrate the birthdate of the late Gene "Coach Ping" Pingatore on October 25, 2023; and

WHEREAS, Gene Pingatore was born on October 25, 1936 and passed away on June 26, 2019; he was raised in Cicero; he graduated from St. Mel's High School in 1954; he earned his Bachelor of Arts in History from Loyola University of Los Angeles, known today as Loyola Marymount University, in 1958; and

WHEREAS, Following his college graduation, Gene Pingatore returned home and began working as a freshman boys basketball coach at St. Joseph High School in Westchester in 1960, the school's first academic year; he became the head varsity coach of the St. Joseph High School boys basketball team, the Chargers, in 1969; he served as head coach for 51 years and was the most successful basketball coach in Illinois High School Association (IHSA) history; he further served the school in a number of roles, including as a social studies teacher, the director of recruitment, the assistant principal, the dean of students,

the director of development, the acting principal, the director of building and grounds, the special events coordinator, and the alumni director; and

WHEREAS, Under Gene Pingatore's guidance, the St. Joseph High School boys basketball team was one of the best in the State, winning 34 regional championships and 13 sectionals, advancing to the state finals six times, and winning two state championships, Class 2A in 1999 and Class 3A in 2015; he possessed a record of 1,035-383, becoming the only coach in Illinois to accomplish 1,000 wins, making him one of only 15 coaches in the nation; and

WHEREAS, Gene Pingatore received many accolades for his work, including being named Educator of the Year by the Illinois State Crime Commission/Police Athletic League of Illinois in 2008, Coach of the West for the McDonald All-American Game in Chicago in 2011, Coach of the Year by the Central Officials Association in 2016, and Coach of the Year by Pioneer Press and Suburban Life in 1978, 1979, and 1999, and again by Suburban Life in 1981, 1987, 1988, 1992, 1995, 1999, and 2004; he also received the Ellie Hasan Award from the Central Officials Association in 2010, and the 2018 Morgan Wootten Award for Lifetime Achievement in Coaching High School Basketball from the Naismith Memorial Basketball Hall of Fame; and

WHEREAS, Gene Pingatore was affectionately known as "Coach Ping", and he became nationally known for his starring role in the critically acclaimed 1994 documentary Hoop Dreams; his leadership and guidance positively impacted an immeasurable number of students; and

WHEREAS, Gene Pingatore coached many talented student athletes who played professionally in the U.S. and abroad, including Indiana All-American and NBA's Isiah Thomas, Indiana All-American Daryl Thomas who played in Europe, Kansas State All-American and CBA's Deryl Cunningham who played in Europe, Clifford Scales who played in Finland, Carl Hayes who played in Europe, Marty Clark who played in South America, NBA's Amal McCaskill, Gerald Eaker who played in Europe and Mexico, Marlon London who played in Europe and Latin America, Brandon Watkins who played in Europe, and 2010 College Player of the Year and NBA's Evan Turner, as well as Dallas Cowboys and Chicago Bears offensive lineman Andy Fredrick and Chicago Bears wide receiver Cameron Meredith; and

WHEREAS, Gene Pingatore also coached several players who led rich collegiate careers, including Robert Morris' Kenny Williams, Marquette's Tony Reeder, University of Illinois at Chicago's Tony Freeman, Northern Illinois' Brian Molis, Marquette's William Gates, Dayton's Rodney Horton, Bowling Green's Jabari Mattox, Iowa and Southern Illinois' Tony Freeman Jr., Notre Dame's Jonathan Peoples, Illinois' Demetri McCamey, Nebraska's Glynn Watson, Northwestern's Jordan Ash, and University of Southern California's Nick Rakocevic; and

WHEREAS, Gene Pingatore was the son of the late Frank and Annette Pingatore; the brother of the late Sandra Pingatore; the father of Lisa; the grandfather of Erin, Kelli, and Jack; the fiance of Jill Oakley; the uncle of Frank, Nick, and the late Robert; and the great-uncle, godfather, cousin, and friend of many; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare October 25, 2023 as Gene "Coach Ping" Pingatore Day in the State of Illinois; and be it further

RESOLVED, That we remember the legacy Gene Pingatore created and the many lives he touched during his lifetime; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the family of Gene Pingatore as an expression of our esteem and respect.

HOUSE RESOLUTION 561

Offered by Representative Kelly:

WHEREAS, Home fires are the leading cause of fires in the U.S., affecting civilians and first responders; and

WHEREAS, According to data complied by the National Fire Protection Association (NFPA), of all civilian structure fire deaths, 78% occur in one- and two-family homes, with home fires causing \$8.6 billion in direct property damage each year; and

WHEREAS, According to the NFPA, residential structure fires account for 63.7% of firefighter injuries; and

WHEREAS, According to the NFPA, regarding firefighter fatalities, 53% occur while fighting structure fires, and 82% occur while fighting fires at a residential dwelling; and

WHEREAS, Home fires are deadlier today than in the past as a result of an increase in the use of unprotected lightweight construction material, open floor plans, and abundant synthetic furnishings, and these dangers are amplified when the properties contain lithium ion batteries and other emerging technologies, making homes burn faster and causing them to become deadly in two minutes or less; and

WHEREAS, The U.S. Fire Administration estimates that home fire sprinklers could save thousands of lives each year if more were installed in homes; and

WHEREAS, Fire sprinklers are a proven and cost-effective means of protecting lives and property from the threat of fire; and

WHEREAS, Fire sprinklers offer the highest degree of fire protection and are critical in saving lives and property; and

WHEREAS, A room can be engulfed in flames in less than three minutes; however, fire sprinklers can control fire and deadly smoke, saving the lives of occupants and first responders; and

WHEREAS, Residential fires without a sprinkler system have caused 3,667 injuries and 967 fatalities in Illinois since 2007; and

WHEREAS, There have been only seven injuries and zero fatalities in residential fires with sprinkler systems in Illinois since 2007; and

WHEREAS, The inclusion of fire sprinklers in local building codes and in community risk reduction plans helps support fire service resources, staffing, and budgets; when new housing stock includes sprinklers, those homes become safer, improving communities and allowing fire service resources to be directed to those at highest risk; and

WHEREAS, Stronger state and federal support of home fire sprinkler education will help address confusion and anti-code negativity and will encourage fire service advocacy in support of home fire sprinkler installation; and

WHEREAS, More installation of fire sprinklers in new homes will directly and indefinitely protect and improve communities of every size; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the week of May 12 through May 18, 2024 as Home Fire Sprinkler Week in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to State Coordinator James Brown of the Illinois Chapter of the National Fire Sprinkler Association.

HOUSE RESOLUTION 563

Offered by Representative Ugaste:

WHEREAS, Variants of the SCN2A gene are the leading single-gene cause of neurodevelopmental disorders such as autism, childhood seizures, and intellectual disabilities; and

WHEREAS, SCN2A disorders are also associated with a spectrum of syndromes ranging from severe, life-threatening conditions to developmental delays, including sleep disturbances, gastrointestinal dysfunctions, movement disorders, pain, and dysautonomia; and

WHEREAS, Research predicts that approximately one in 9,000 people will be diagnosed with SCN2A-related disorders; and

WHEREAS, While SCN2A-related disorders can be easily identified by DNA testing, SCN2A-related disorders frequently go undetected due to a lack of awareness, even within the medical community; and

WHEREAS, The field of study of SCN2A-related disorders is growing, but additional studies are needed to develop therapies and treatments; and

WHEREAS, International SCN2A Awareness Day is held annually on February 24th; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare February 24, 2024 as SCN2A Awareness Day in the State of Illinois; and be it further

RESOLVED, That we encourage all residents of Illinois to support any related activities and wear purple, blue, or green on this day to bring awareness of these disorders and the need for treatment.

HOUSE RESOLUTION 564

Offered by Representative Mason:

WHEREAS, Diaper need is the lack of enough diapers to keep a baby or toddler clean, dry, and healthy and is a recognized public health issue that impacts the physical, mental, and economic well-being of U.S. children and families; and

WHEREAS, Diaper need can result from poverty, unexpected life hardships, natural disasters, and so much more; and

WHEREAS, One in two U.S. families reported experiencing diaper need; and

WHEREAS, Nearly one in four families experiencing diaper need reported missing work or school due to lack of access to clean diapers needed for childcare services; and

WHEREAS, Families reporting diaper need encompass a wide array of ages, racial groups, and income levels; of those in diaper need, 96 percent are under 45 years of age with the majority between 25 to 34 years of age; and

WHEREAS, Of those in need, two in five families said they stretch the use of diapers by keeping a child in the same diaper longer, which can increase a child's risk for skin irritation and other serious side effects; and

WHEREAS, Research shows that a lack of access to clean diapers leads to negative and long-lasting impacts on a child's physical and mental health; and

WHEREAS, The National Diaper Bank Network (NDBN) has more than 225 member diaper banks that have reported on average an 86% increase in the number of diapers distributed to families compared to the previous year, with spikes of up to 800% more in some cities; in 2022, the NDBN distributed more than 140 million diapers to families in need; no federal support programs for children cover diapers, which can cost approximately \$80-\$100 a month per child; and

WHEREAS, Diapers are a basic necessity for every baby and toddler; there are many people who do not have enough money to meet their basic needs, and diaper need can be a window into poverty; and

WHEREAS, A lack of access to clean diapers can also have long lasting impacts on caregiver's mental health, with over half of parents experiencing diaper need reported feeling judged for lacking diapers and 70 percent feeling stressed or anxious about their parental responsibilities; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the week of September 23-29, 2024 as "Diaper Need Awareness Week" in the State of Illinois; and be it further

RESOLVED, That suitable copies of this resolution be presented to the National Diaper Bank Network Illinois affiliates.

HOUSE RESOLUTION 571

Offered by Representative Stuart:

WHEREAS, School counselors are employed in public and private schools to help students reach their full potential; and

WHEREAS, School counselors are actively committed to helping students explore their abilities, strengths, interests, and talents as these traits relate to career awareness and development; and

WHEREAS, School counselors help parents focus on ways to further the educational, personal, and social growth of their children; and

WHEREAS, School counselors seek to identify and utilize community resources that can enhance and complement comprehensive school counseling programs and help students become productive members of society; and

WHEREAS, Comprehensive developmental school counseling programs are considered an integral part of the educational process that enable students to achieve success in school; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare February 5 through February 9, 2024 as School Counseling Week in the State of Illinois; and be it further

RESOLVED, That we encourage all Illinoisans to join us in recognizing our school counselors who have worked diligently to ensure all students in the State are afforded more equal opportunities in their education and personal growth; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Illinois School Counselor Association as a symbol of our respect and esteem.

HOUSE RESOLUTION 572

Offered by Representative Davis, Will:

WHEREAS, In 1992, the State of Illinois established a sister-state relationship with Taiwan, the Republic of China (R.O.C.); since that time, Illinois and Taiwan have enjoyed strong bilateral trade, educational and cultural exchanges, and tourism; and

WHEREAS, Taiwan shares the same values of freedom, democracy, human rights, the rule of law, peace, and prosperity with the State of Illinois and the United States; and

WHEREAS, The United States ranks as Taiwan's second-largest trading partner; Taiwan is the ninth-largest trading partner of the United States, with bilateral trade reaching more than US\$ 160 billion in 2022; and

WHEREAS, Taiwan imported nearly US\$ 4.4 billion worth of U.S. farm products in 2022, making it the seventh largest market for U.S. agricultural products overall, the fourth largest market on a per capita basis among the top 10 U.S. agricultural export destinations, and the seventh largest market for U.S. soybeans and corn individually; and

WHEREAS, Due to its high quality produce, the U.S. remains one of Taiwan's largest sources of agricultural products, supplying more than one-fifth of the country's major agricultural imports; and

WHEREAS, Taiwan and the State of Illinois have enjoyed a long and mutually beneficial relationship with the prospect of future growth; Taiwan was Illinois' fifth-largest export market in Asia in 2022, with US\$ 876 million worth of Illinois goods exported to Taiwan; and

WHEREAS, To strengthen the Taiwan-Illinois bilateral economic relationship, it is essential to support Illinois businesses to enhance their economic engagement with Taiwan based on the 1979 Taiwan Relations Act (TRA, Public Law 96-8, 22 U.S.C. 3301); Article 4, Section b of the TRA stipulates that "wherever the laws of the United States refer or relate to foreign countries, nations, states, governments, or similar entities, such terms shall include and such laws shall apply with respect to Taiwan"; it is legitimate for Illinois businesses to refer to Taiwan, R.O.C. as Taiwan in conducting their business ties with Taiwan; and

WHEREAS, Negotiations for a Bilateral Trade Agreement (BTA), the Avoidance of Double Taxation Agreement (ADTA), and the Indo-Pacific Economic Framework for Prosperity (IPEF) between Taiwan and the United States are an important step toward further strengthening bilateral trade between our countries, thereby increasing Illinois' exports to Taiwan and creating bilateral investment and technical collaboration through tariff reduction and other trade facilitation measures; and

WHEREAS, Taiwan has undertaken a policy of "steadfast diplomacy" in its international relations; Taiwan is capable of fulfilling, and willing to fulfill, its responsibilities and to collaborate with the world to deal with the challenges of humanitarian aid, disease control, and so forth; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we reaffirm our commitment to the strengthening and deepening of the sister ties between the State of Illinois and Taiwan, R.O.C.; and be it further

RESOLVED, That we reaffirm our support for the Taiwan Relations Act (TRA) and support Illinois businesses to refer to Taiwan, R.O.C. as Taiwan; and be it further

RESOLVED, That we endorse Taiwan's efforts to secure the signing of a Bilateral Trade Agreement (BTA), the Avoidance of Double Taxation Agreement (ADTA), and the Indo-Pacific Economic Framework

for Prosperity (IPEF) with the United States, and we reiterate our support for a closer economic and trade partnership between the State of Illinois and Taiwan; and be it further

RESOLVED, That we continue to support Taiwan's meaningful participation in international organizations, such as the United Nations (UN), the World Health Organization (WHO), the International Civil Aviation Organization (ICAO), the United Nations Framework Convention on Climate Change (UNFCCC), the International Criminal Police Organization - INTERPOL (ICPO-INTERPOL), which impact the health, safety, and well-being of the people of Taiwan, and we support Taiwan's aspiration to make more contributions in international societies.

RESOLVED, That we encourage the citizens of Illinois to join in appreciation and celebration of the BSA for the organization's work on behalf of young people across the State and the country.

HOUSE RESOLUTION 577

Offered by Representative Severin:

WHEREAS, Recycling reduces waste sent to landfills, conserves natural resources, and reduces pollution; and

WHEREAS, The State of Illinois, like any large entity, produces waste; and

WHEREAS, To reduce the amount of waste created by the State, the General Assembly created the State agency materials recycling program; and

WHEREAS, The program requirements state that, beginning in 1989, 10% of the dollar value of paper and paper products procured by Central Management Services is to be spent on recycled paper and paper products, and that percentage gradually increased to its current statutory level of 50%, which was reached in 2000; and

WHEREAS, The program requires that Central Management Services, in coordination with the Illinois Environmental Protection Agency, implement waste reduction programs designed to achieve waste reduction of at least 50% by 2000; and

WHEREAS, Members of the General Assembly would like to verify that the requirements of the program are being met; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Auditor General is directed to conduct an audit of the State agency materials recycling program; and be it further

RESOLVED, That the audit include, but not be limited to, the following:

(1) An examination of the spending on recycled paper and paper products by State agencies for compliance with the State agency materials recycling program, 415 ILCS 20/3; and

(2) An examination of the waste reduction programs instituted by Central Management Services for compliance with the waste reduction targets of the State agency materials recycling program; and be it further

RESOLVED, That Central Management Services, the Environmental Protection Agency, and any other State agency or other entity having information relevant to this audit are urged to cooperate fully and promptly with the Auditor General's Office in the conduct of this audit; and be it further

RESOLVED, That the Auditor General commence this audit as soon as possible and report its findings and recommendations upon completion in accordance with the provisions of the Illinois State Auditing Act; and be it further

RESOLVED, That suitable copies of this resolution shall be delivered to the Auditor General, the Director of the Environmental Protection Agency, and the Director of the Illinois Department of Central Management Services.

HOUSE RESOLUTION 579

Offered by Representative Evans:

WHEREAS, Illinois has the sixth highest cancer mortality in the country and is among the group of states with the largest socioeconomic, racial, ethnic, and rural disparities in stage at diagnosis, mortality, and outcomes in the nation; and

WHEREAS, The University of Illinois Cancer Center (UICC) has striven to reduce and eliminate inequalities in cancer outcomes through community-driven, scientific solutions for equitable outcomes in screening, diagnosis, treatment, and survivorship; and

WHEREAS, UICC and partners have addressed cancer disparities for more than 30 years in a variety of ways, including with basic science to identify mechanisms of disparities, in translational science to test new treatments that can eliminate disparities, and in population science to test multilevel strategies that address structural, social, and behavioral drivers of cancer disparities in communities, federally qualified health centers, and safety net settings; and

WHEREAS, UICC's demonstrated scientific excellence and capability for cancer health equity has always been centered in genuine, bidirectional relationships across community, healthcare, government, and academic sectors; and

WHEREAS, UICC is uniquely positioned to address cancer equity through outreach, practice, and science, given its Majority Minority Representation in Research, including possessing primarily minority and low-income participant representation through tissue biorepositories, clinical trials, and public health studies focused on ensuring innovations in prevention, early detection, treatment, and cures for cancer have equitable effects and access, which are made possible through quality, affordable cancer care available under the University of Illinois Hospital & Health Sciences System, from equitable, low or no-cost hereditary risk assessment and genetic services to equitable precision oncology treatments and survivorship; and

WHEREAS, UICC is committed to the expansion of its infrastructure throughout the State of Illinois, an infrastructure that is centered on eradicating disparities in cancer care access and outcomes, which leverages its application for National Cancer Institute (NCI) designation; and

WHEREAS, NCI designation is an accreditation given by the National Institutes of Health to elite U.S.-based medical and laboratory institutions to demonstrate that these institutions are leaders in addressing the nation's cancer burden through research; and

WHEREAS, NCI-designated cancer centers provide economic benefits for their communities, with the potential of over \$1 billion in economic impact, by creating thousands of middle and high-wage jobs, recruiting world-class physicians and scientists, partnering with private corporations, and attracting philanthropic donations and with the ability to secure millions of dollars in additional funding for cancer research through exclusive partnerships with the National Institutes of Health; and

WHEREAS, NCI-designated cancer centers offer significant benefits for communities, including federal funding that UICC would use for equity-driven, inclusive training and elevation of the next generation of diverse healthcare workers and researchers, providing education in STEM programs and mentorship opportunities, and producing a diverse, stable, future healthcare workforce focused on historically underserved communities; and

WHEREAS, NCI-designated cancer centers benefit from additional funding and resources to optimize infrastructure for community outreach and engagement, including multilevel enhancements for cancer education of evidence-based information to communities, technical assistance for healthcare systems, including federally qualified health centers and safety net facilities to enhance the quality of affordable, accessible primary and specialty cancer care, and training for community members and leaders to be embedded in science as partners and decision-makers to characterize and eliminate cancer disparities; and

WHEREAS, Patients cared for by NCI-designated cancer centers have lower mortality rates, and said cancer centers are at the forefront of developing, testing, and scaling cutting-edge, novel tools, therapies, and innovations for their communities and beyond; and

WHEREAS, NCI designation for UICC would have the institution join the distinguished ranks of two existing NCI-designated cancer centers in the State of Illinois, Northwestern University and the University of Chicago; having three NCI-designated cancer centers, each with significant resources, would result in major cumulative growth and significant increases in the economic, educational, community, and health benefits for the State and its communities; and

WHEREAS, An additional NCI cancer center, unique in its focus on cancer disparities through community engagement, has significant potential to reduce cancer burden by increasing access to the continuum of quality cancer care through partnerships across the State and by the implementation of a community-to-bench model, where communities guide and partner with providers and researchers to ensure science is inspired by and reflects community needs, priorities, and strengths; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we support the accreditation of the University of Illinois Cancer Center (UICC) as an additional NCI-designated cancer center in Illinois, which will be focused and driven to characterize and eliminate disparities in cancer outcomes; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the University of Illinois Cancer Center.

HOUSE RESOLUTION 580

Offered by Representative Evans:

WHEREAS, High cholesterol, also called hypercholesterolemia, is the chronic presence of high levels of cholesterol in the blood that can lead to cardiovascular disease (CVD) and even cardiovascular (CV) events like heart attacks or strokes; and

WHEREAS, The Centers for Disease Control and Prevention (CDC) estimates that CVD is arguably the most underappreciated public health crisis of our time; someone in the U.S. has a heart attack every 40 seconds, yet approximately 80% are preventable; and

WHEREAS, Low-density lipoprotein cholesterol (LDL-C), or "bad" cholesterol, is an easily modifiable risk factor for CVD; lower LDL-C is associated with a reduced risk of heart attack and stroke; and

WHEREAS, Heart disease is the leading cause of death in the U.S. among racial and ethnic minority populations; and

WHEREAS, The American Heart Association (AHA) has demonstrated that Hispanic Americans are at exceptionally high risk for cardiovascular disease and coronary heart disease, both of which can lead to a stroke or heart attack; and

WHEREAS, More than 80 million adults have high LDL-C; and

WHEREAS, The AHA indicates that CVD disproportionately affects minority populations; 52.3% of Hispanic males and 42.7% of Hispanic females over the age of 20 are affected by CVD; 60.1% of Black males and 58.8% of Black females 20 years of age and older have CVD; and

WHEREAS, The CDC found that one in three deaths in the U.S. is due to heart disease, and this results in more than \$216 billion in healthcare costs; and

WHEREAS, Nearly 60% of middle-aged Hispanic adults have high cholesterol, yet only half are aware of this, according to a study published in the Journal of the American Medical Association; and

WHEREAS, A study published in the American Journal of Preventative Cardiology found cholesterol testing, an important preventive measure for reducing the risk of cardiovascular disease, declined during the COVID pandemic; and

WHEREAS, The resources needed to bend the curve in CVD exist, yet 71% of hypercholesterolemia patients at high risk of a CV event never achieve recommended LDL-C treatment guideline thresholds; and

WHEREAS, The LDL-C Action Summit, a consortium of the nation's leading cardiovascular stakeholder groups, seeks to cut cardiovascular events in half by 2030; and

WHEREAS, The CDC's Million Hearts program seeks to improve access and quality of care to reduce heart disease, stroke, and death; and

WHEREAS, The U.S. Department of Health and Human Services Office of Minority Health recognizes April as National Minority Health Month; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare April 2024 as "Minority Health Month" in the State of Illinois; and be it further

RESOLVED, That we urge all Americans to learn their LDL-C level; and be it further

RESOLVED, That we urge the Illinois Department of Public Health to update the State's cardiovascular plan to accelerate quality improvements and measures to achieve improved health outcomes for CVD patients; and be it further

RESOLVED, That we urge the Illinois Department of Public Health to develop campaigns to increase cholesterol tests during the month of April; and be it further

RESOLVED, That we urge providers to treat all CVD patients in accordance with American College of Cardiology treatment guidelines; and be it further

RESOLVED, That suitable copies of this resolution be presented to the Illinois Department of Public Health and the U.S. Department of Health and Human Services.

HOUSE RESOLUTION 582

Offered by Representative Delgado:

WHEREAS, The Illinois Supreme Court administers the State's legal system, regulates the legal profession, and seeks to foster a diverse and inclusive legal system; and

WHEREAS, Despite more and more LGBTQ+ people and people living with HIV who are living as their authentic selves, the Illinois Supreme Court does not have a formal education requirement for attorneys, judges, and courtroom staff to be aware of and meet the social and cultural needs of LGBTQ+ communities and people living with HIV; and

WHEREAS, In 2023, more than 600 anti-LGBTQ+ bills were introduced in statehouses across the country, including initiatives to criminalize healthcare for trans individuals, to create licenses to discriminate against LGBTQ+ families, and to deny LGBTQ+ students the opportunity to experience the stories of people like themselves, and such anti-LGBTQ+ bills are contrary to the values of the State of Illinois; and

WHEREAS, As LGBTQ+ people and families visit Illinois to access reproductive healthcare and gender-affirming care or move to Illinois in order to escape the oppression of cruel and harsh anti-LGBTQ+ regimes in other states, attorneys, judges, and courtroom staff in Illinois will more frequently come into contact with and represent LGBTQ+ people who need legal services to defend their rights, freedom, and bodily autonomy; and

WHEREAS, The Movement Advancement Project's August 2016 report, entitled Unjust: How the Broken Criminal Justice System Fails LGBT People of Color, wrote that "Discrimination against LGBT people, particularly LGBT people of color, is pervasive, and it infiltrates the halls of justice", and that "Judges, prosecutors, and even defense attorneys tasked with representing LGBT people often rely on misinformation, stereotypes, and inflammatory language when interacting with LGBT people"; for instance, "LGBT immigrants frequently encounter judges who are unfamiliar with the challenges facing LGBT people in other countries or who use incorrect language to refer to transgender immigrants"; and

WHEREAS, Lambda Legal's Protected and Served? 2022 report includes data from a national survey about the experiences of LGBTQ+ people and people living with HIV when in courts and courthouses; and

WHEREAS, Of survey participants who had appeared in court, 22.2% of those who identified as LGBTQ+, women, or individuals living with HIV indicated that someone in the legal profession, including judges, public defenders, prosecutors, court clerks, court security, or other court employees, made negative comments to or about them relating to sexual orientation, gender identity or expression, or HIV status; and

WHEREAS, In that same report, 30.1% of transgender participants had their gender identity inappropriately revealed in court; in particular, transgender participants of color were more likely to have their gender identity revealed in court than were those who were white; specifically, 42.9% of Indigenous trans people, 42.3% of Black trans people, 34.5% of Latinx trans people, and 23.3% of white trans people reported having their gender identity inappropriately revealed in court; and

WHEREAS, The report additionally revealed that 25.0% of people living with HIV said that their HIV status, which is private health information, was inappropriately revealed in court; and

WHEREAS, According to the 2015 US Trans Survey, 13% of respondents reported negative experiences in a court or courthouse because of being transgender; additionally, 6% of respondents reported negative experiences when accessing legal services from an attorney, a clinic, or a legal professional because of being transgender; negative experiences include being denied equal treatment or service, verbally harassed, or physically attacked because of being transgender; and

WHEREAS, Reports by the Movement Advancement Project and Lambda Legal and the US Trans Survey highlight the pervasive harassment, discrimination, and exclusion that LGBTQ+ people and people living with HIV experience in law offices, legal clinics, courts, and courthouses; this harassment, discrimination, and exclusion contribute to the distrust of the legal system by LGBTQ+ people and people living with HIV; in fact, according to Lambda Legal's survey, 32.2% of LGBTQ+ people do not trust the court system at all while only 8.5% completely trust the court system; and

WHEREAS, The Illinois Supreme Court and relevant authorities have the authority to require that attorneys, judges, and courtroom staff be trained in LGBTQ+ and HIV cultural competency as part of continuing education; having such a requirement will increase the ability of attorneys, judges, and courtroom staff to meet the social and cultural needs of a diversifying state; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Illinois Supreme Court and relevant authorities to require, as a consistent part of continuing education, LGBTQ+ and HIV cultural competency education for all attorneys, judges, and courtroom staff in the State of Illinois; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Illinois Supreme Court, the Supreme Court of Illinois Judicial College Board of Trustees, the Director of the Administrative Office of the Illinois Courts, and the Administrator of the Attorney Registration and Disciplinary Commission.

HOUSE RESOLUTION 583

Offered by Representative Benton:

WHEREAS, In November 2024, National Apprenticeship Week will celebrate its 10th anniversary of raising awareness of the vital role that apprenticeships play in providing opportunities to learn and earn on the pathway to good, quality jobs and well-paying careers with the opportunity for career advancement; and

WHEREAS, Building off of the success of National Apprenticeship Week, the U.S. Department of Labor and its Apprenticeship USA initiative will celebrate the first Youth Apprenticeship Week in 2024 to highlight the benefits and value of registered apprenticeships for young people ages 16-24; and

WHEREAS, Registered Apprenticeship programs allow youth and young adults to obtain relevant training and experience to start their careers while earning competitive wages and often include the opportunity to earn college credit as well, creating a sustainable pipeline of skilled and diverse talent for critical industries; and

WHEREAS, The advancement and well-being of Illinois depends upon its ability to expand workforce opportunities for people in all areas of the State, including through Registered Apprenticeship programs that are able to meet the changing demands of the economy while providing a path to success and stability and opportunity to contribute to America's industries for all qualified individuals regardless of their race, sexuality, involvement in the justice system, gender, geography, ethnicity, or disability status; and

WHEREAS, Registered Apprenticeship programs for youth are able to combine a proven, industry-driven training model for apprenticeships with colleges and universities, including community

colleges, to provide access to a broader array of education and skills development for young people, allowing them greater opportunities for sustained success while addressing challenges, including, but not limited to, rebuilding our country's infrastructure, addressing critical supply chain demands, supporting a clean energy workforce, modernizing our cybersecurity response, and addressing care economy issues; and

WHEREAS, The United States Department of Labor is bringing together employers, industry associations, labor organizations, community-based organizations, workforce partners, educational institutions, and governments to celebrate Youth Apprenticeship Week from May 5-11, 2024; and

WHEREAS, Themes being highlighted for the inaugural Youth Apprenticeship Week include the importance of parents and guardians, building awareness through partnerships with schools and creating pathways through pre-apprenticeship, and expanding youth apprenticeships for underserved populations in rural, suburban, and urban communities; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the week of May 5-11, 2024 as "Youth Apprenticeship Week" in the State of Illinois; and be it further

RESOLVED, That we encourage business leaders, educators, families, and young people to learn more about the opportunities that youth apprenticeship programs provide and to encourage the development and expansion of youth apprenticeship programs in Illinois.

HOUSE RESOLUTION 584

Offered by Representative Williams, Jawaharial:

WHEREAS, Superman's origin is one of the best-known stories in comic book history; and

WHEREAS, Superman's date of birth has been a matter of debate over his career as a crime fighter; and

WHEREAS, February 29 was ordained as Clark Kent's birthday in a 1976 edition of DC Comics' Super Calendar", which also listed a number of historic occasions and established birthdays for numerous other characters, including Lois Lane; and

WHEREAS, DC Comics' initial reasoning for establishing Superman's birthday on leap day was because the day only appears every four years, which could explain why Superman is still "young" after appearing in comics for generations; and

WHEREAS, Superman's ties to Illinois include the town of Metropolis in Southern Illinois, which was proclaimed as the "Hometown of Superman" by the Illinois House of Representatives on June 9, 1972; and

WHEREAS, Superman's date of birth has bounced from date to date, but only one date, February 29, has been officially celebrated by DC Comics in recent years; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare February 29, 2024 as "Superman Day" in the State of Illinois.

HOUSE RESOLUTION 585

Offered by Representative Davis, Will:

WHEREAS, The Professional Review Panel is responsible for evaluating and recommending modifications to the Evidence-Based Funding Formula to ensure all students have access to a quality education, including educational support services; and

WHEREAS, Educational support services are provided by employees, including, but not limited to, custodial employees, transportation employees, food service providers, classroom assistants, administrative staff, and paraprofessional educators; and

WHEREAS, Employees providing educational support services are accomplished professionals who keep our schools running and our students safe, healthy, and ready to learn; and

WHEREAS, Low wages are contributing to Illinois' shortage of employees providing educational support services; and

WHEREAS, A minimum hourly rate of no less than \$22 is recommended for employees providing educational support services; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we direct the Professional Review Panel and the Illinois State Board of Education to conduct the analysis and financial modeling required to evaluate the implications of implementing the recommended \$22 minimum hourly rate for employees providing educational support services; and be it further

RESOLVED, That the analyses should include the district impact of incremental increases beginning with \$20 in school year 2025-2026, \$21 dollars in school year 2026-2027, and \$22 in school year 2027-2028; and be it further

RESOLVED, That the Professional Review Panel and the Illinois State Board of Education should include their findings in a written report to the General Assembly and Governor by December 31, 2024.

HOUSE RESOLUTION 586

Offered by Representative Halbrook:

WHEREAS, Over the past several years, elected officials in Illinois have passed a series of reforms intended to publicly show that Illinois is a safe haven for migrants; and

WHEREAS, In 2017, the General Assembly passed the Illinois TRUST Act, which prohibits law enforcement from using or inquiring about a person's immigration status as part of their investigatory duties and prohibits local law enforcement from working with agents from U.S. Immigration and Customs Enforcement (ICE); and

WHEREAS, Between 2020 and 2022, under Governor JB Pritzker, the majority party in the legislature implemented a series of healthcare coverage expansions for low-income immigrant seniors and adults; and

WHEREAS, The true cost of this healthcare on state taxpayers was unknown to the general public until late March 2023 when the Illinois Department of Healthcare and Family Services (HFS) released a report by its contracted actuary that highlighted the significant costs associated with the healthcare expansion; and

WHEREAS, HFS paused enrollment related to Medicaid benefits for undocumented immigrant seniors and adults as of November 6, 2023 and July 1, 2023, respectively; and

WHEREAS, HFS released information dated December 14, 2023 that showed dramatic growth in the Medicaid program for undocumented immigrants, which will potentially require \$792 million in general revenue funds (GRF) in State Fiscal Year (FY) 2024; and

WHEREAS, Despite pauses to new enrollees, FY 2024 cost projections still exceed FY 2024 appropriations by over \$242 million; and

WHEREAS, Aside from Medicaid, Illinois has provided or committed over \$638 million in funding to address the crisis involving asylum seekers since August 2022; and

WHEREAS, The funding has been provided through programs at HFS, the Illinois Department of Human Services, the Illinois Emergency Management Agency, and the Illinois Housing Development Authority; and

WHEREAS, The funding includes \$115 million in direct funding from the State to the City of Chicago for asylum seeker support services, food, and shelter, and to municipalities to support asylum seekers statewide; and

WHEREAS, On November 16, 2023, Governor Pritzker announced new additional State investments, via the Illinois Department of Human Services, totaling \$160 million to fund winterized base camps and welcoming centers and to provide services to asylum seekers as they await hearings; and

WHEREAS, The House of Representatives believes there should be more transparency in how State funds are used to fund asylum seekers and undocumented immigrants here in Illinois; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we direct the Auditor General to conduct a performance audit of the State spending on asylum seekers and undocumented immigrants, and the audit shall include:

(1) A review of the Illinois Department of Healthcare and Family Services' program enrollment numbers and amount of money expended for fiscal years 2022, 2023, and 2024 on Medicaid services for asylum seekers and undocumented immigrants; and

(2) A comprehensive analysis of any spending by any State agency on asylum seekers and undocumented immigrants for fiscal years 2022, 2023, and 2024; and be it further

RESOLVED, That we urge the Illinois Department of Healthcare and Family Services, the Illinois Department of Human Services, the Illinois Emergency Management Agency, the Illinois Housing Development Authority, and any other entity having information relevant to the audit to cooperate fully and promptly with the Office of the Auditor General in the conduct of this audit; and be it further

RESOLVED, That we direct the Auditor General to commence this audit as soon as possible and report his findings and recommendations upon completion in accordance with the provisions of Section 3-14 of the Illinois State Auditing Act; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Governor JB Pritzker, Speaker of the House Emanuel "Chris" Welch, President of the Senate Don Harmon, House Minority Leader Tony McCombie, and Senate Minority Leader John Curran.

HOUSE RESOLUTION 587

WHEREAS, Encouraging the production and consumption of locally grown produce can foster the preservation of Puerto Rico's rich culinary traditions, promote healthier eating habits, and enrich our national cultural heritage; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we express our strong support for the initiative to reprogram USDA funds allocated to Puerto Rico toward purchasing locally grown items in Puerto Rico; and be it further

RESOLVED, That we urge the United States Congress to endorse and implement this initiative in recognition of its potential to foster economic growth, promote sustainability, enhance resilience, and enrich cultural heritage; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President of the United States, the U.S. Senate Majority Leader, the U.S. Senate Minority Leader, the U.S. Speaker of the House, the U.S. House of Representatives Minority Leader, all members of the Illinois Congressional Delegation, and the Governor of Puerto Rico.

HOUSE RESOLUTION 588

Offered by Representative LaPointe:

WHEREAS, Many people living with serious mental illnesses, including bipolar disorder, major depressive disorder, schizophrenia, and schizoaffective disorder or gastrointestinal disorders such as gastroparesis, upset stomach, nausea, and vomiting, may be treated with medications that work as dopamine receptor blocking agents, including antipsychotics and antiemetics; and

WHEREAS, While ongoing treatment with these medications can be necessary, prolonged use is associated with tardive dyskinesia (TD), an involuntary movement disorder that is characterized by uncontrollable, abnormal, and repetitive movements of the face, torso, limbs, and fingers or toes; and

WHEREAS, Even mild symptoms of TD can impact people physically, socially, and emotionally; and

WHEREAS, It is estimated that TD affects approximately 600,000 people in the United States, and approximately 65 percent of people with TD have not been diagnosed, making it important to raise awareness about the symptoms; and

WHEREAS, It is important that people taking these medications be monitored for TD by a healthcare provider; regular screening for TD is recommended by the American Psychiatric Association; and

WHEREAS, Clinical research has led to approval of treatments for adults with TD by the U.S. Food and Drug Administration, and recognition and treatment of TD can make a positive impact in the lives of many people experiencing psychotic and mood disorders; and

WHEREAS, The Illinois House of Representatives can utilize its position to raise awareness of TD among the public and medical community; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare May 5-11, 2024 as "Tardive Dyskinesia Awareness Week" in the State of Illinois; and be it further

RESOLVED, That we encourage anyone experiencing uncontrollable, abnormal, and repetitive movements to consult their healthcare provider regarding their symptoms.

HOUSE RESOLUTION 594

Offered by Representative Coffey:

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Rules of the House of Representatives of the 103rd General Assembly are amended by changing Rules 10 and 18 as follows:

(House Rule 10)

10. Committees.

(a) The committees of the House are: (i) the standing committees listed in Rule 11; (ii) the special committees created under Rule 13; (iii) any subcommittees created under these Rules; (iv) the Rules Committee created under Rule 15; (v) any committees created under Article X or Article XII; and (vi) any Committee of the Whole. Committees of the Whole shall consist of all Representatives.

(b) Except as otherwise provided in this Rule and subject to Rules 12 and 13, all committees shall have a Chairperson and Minority Spokesperson, who may be of the same political party. A Minority Spokesperson may not be appointed until after a Chairperson has been appointed. Standing committees that have Co-Chairpersons from different political parties shall not have a Minority Spokesperson. Special committees that have Co-Chairpersons from different political parties shall not have a Minority Spokesperson. No member may be appointed to serve as a Chairperson, Minority Spokesperson, or Co-Chairperson of any committee unless the member is serving in at least his or her third term as a member of the General Assembly, including any terms in which the member was appointed to fill a vacancy in the office of Representative or Senator. Each committee may have a Vice-Chairperson appointed by the Speaker. The number of majority caucus members and minority caucus members of all committees, except the Rules Committee created under Rule 15 and as otherwise provided by these Rules, shall be determined by the Speaker. The Speaker shall file a notice with the Clerk setting forth the number of majority caucus and minority caucus members of each committee, which shall be journalized. A member may be temporarily replaced on a committee if the member is otherwise unavailable. The appointment of a member as a temporary replacement shall remain in effect until (i) the permanent member who was replaced is in attendance at the hearing and has been added to the committee roll, (ii) the appointing authority withdraws the temporary replacement appointment or appoints a different member to serve as the temporary replacement, or (iii) the hearing is adjourned or the authority has expired for a re-convened hearing following a recess of the committee, whichever occurs first. All leaders are non-voting ex-officio members

of each standing committee and each special committee, except that the leaders may also be appointed to standing committees or special committees as voting members. The Speaker may also appoint any member of the majority caucus, and the Minority Leader may appoint any member of the minority caucus, as a non-voting member of any standing committee or special committee.

(c) The Chairperson of a committee has the authority to call the committee to order, designate which legislative measures and subject matters posted for hearing shall be taken up and in what order, order a record vote to be taken on each legislative measure called for a vote, preserve order and decorum during committee meetings, establish procedural rules (subject to approval by the Speaker) governing the presentation and consideration of legislative measures and subject matters, and generally supervise the affairs of the committee. Any such procedural rules must be filed with the Clerk and copies provided to all members of the committee. The Vice-Chairperson of a committee or other member of the committee from the majority caucus may preside over its meetings in the absence or at the direction of the Chairperson. In the case of standing or special committees with Co-Chairpersons from different political parties, the "Chairperson" for purposes of this Rule is the Co-Chairperson from the majority caucus.

(c-5) Notwithstanding any other provision of these Rules, the Chairperson of a committee shall order a hearing to be held and a record vote to be taken on each bill that is referred to the committee as a member-sponsored initiative under Rule 18. This subsection (c-5) may not be suspended.

(d) A vacancy on a committee, or in the position of Chairperson, Co-Chairperson, Vice-Chairperson, or Minority Spokesperson on a committee, exists when a member resigns from the position, ceases to be a Representative, or changes political party affiliation. Resignations and notices of a change in political party affiliation shall be made in writing to the Clerk, who shall promptly notify the Speaker and Minority Leader. Replacement members shall be of the same political party as that of the member who resigns, and shall be appointed in the same manner as the original appointment, except that in the case of a vacancy in the position of Chairperson or Co-Chairperson, the replacement member need not be from the same political party. The Speaker or Minority Leader may appoint a temporary replacement to fill a vacancy until such time as a permanent member has been appointed. In the case of vacancies on subcommittees, the parent committee shall fill the vacancy in the same manner as the original appointment.

(e) The Chairperson of a committee has the authority to call meetings of that committee, subject to the approval of the Speaker. In the case of standing or special committees with Co-Chairpersons from different political parties, the Co-Chairperson from the majority caucus has the authority to call meetings of the special committee, subject to the approval of the Speaker. Except as otherwise provided by these Rules, committee meetings shall be convened in accordance with Rule 21.

(f) Except for those provisions that may not be suspended, this This Rule may be suspended only by the affirmative vote of 71 members elected.

(House Rule 18)

18. Referrals to Committees.

(a) All House bills and Senate bills, after being initially read by the Clerk, are automatically referred to the Rules Committee.

(b) The Rules Committee may refer any such bill before it to a standing committee or a special committee. During even-numbered years, the Rules Committee shall refer to a standing committee or a special committee only appropriation bills implementing the budget and bills deemed by the Rules Committee, by the affirmative vote of a majority of those appointed, to be of an emergency nature or to be of substantial importance to the operation of government. This subsection (b) applies equally to House Bills and Senate Bills introduced into or received by the House.

(b-5) Notwithstanding subsection (b), the Rules Committee may refer any legislative measure to a joint committee of the House and Senate created by joint resolution. That joint committee shall report back to the Rules Committee any recommendation for action made by that joint committee. The Rules Committee may, at any time, however, refer the legislative measure to a standing or special committee of the House.

(c) The Chairperson of a standing committee or a special committee may refer a subject matter or a legislative measure pending in that committee to a subcommittee of that committee, regardless of whether the subject matter or legislative measure has been posted for hearing.

(d) All legislative measures favorably reported by a standing committee or a special committee, or discharged from a standing committee or a special committee under Rule 58, shall be referred to the House and placed on the appropriate order of business, which shall appear on the Daily Calendar.

(c) All committee amendments, floor amendments, joint action motions for final action, conference committee reports, and motions to table committee amendments, upon filing with the Clerk, are automatically referred to the Rules Committee. The Rules Committee may refer any committee amendment to the standing committee or the special committee to which the bill or resolution it amends has been referred for its review and consideration. The Rules Committee may refer any floor amendment, joint action motion for final action, conference committee report, or motion to table a committee amendment to the House or to a standing committee or a special committee for its review and consideration. Any floor amendment, joint action motion for final action motion for final action, conference committee is out committee report, or motion to table a committee is out of order, except that any floor amendment, joint action motion for final action, conference committee amendment favorably reported by, or discharged from, a standing committee is deemed referred to the House by the Rules Committee for purposes of this Rule.

(f) The Rules Committee may at any time refer or re-refer a legislative measure from a committee to a Committee of the Whole or to any other committee. If a bill or resolution is re-referred from a standing or special committee to a Committee of the Whole or to any other committee pursuant to this Rule, any committee amendments pending in the standing or special committee shall be automatically re-referred with the bill or resolution.

(g) Notwithstanding any other provision of these Rules, any bill pending before the Rules Committee shall be immediately discharged and referred to a standing committee, special committee, or order of the Daily Calendar, as provided in this Rule, if the Principal Sponsor of the bill files a motion that is signed by no less than three-fifths of the members of both the majority and minority caucuses, provided each member signing the motion is a sponsor of the underlying bill subject to the motion and the motion specifies the appropriate standing committee, special committee, or order on the Daily Calendar to which the bill shall be referred. Such a motion shall be filed, in writing, with the Clerk. All other legislative measures may be discharged from the Rules Committee only by unanimous consent of the House. A bill or resolution discharged from the Rules Committee shall be referred as follows: (i) a bill or resolution that was not previously referred shall be referred to the standing committee or special committee designated on the motion, subject to the notice requirement of Rule 21; (ii) a bill or resolution re-referred to the Rules Committee from a standing committee or special committee shall be re-referred to that committee, subject to the notice requirement of Rule 21; and (iii) a bill or resolution re-referred to the Rules Committee from an order of business on the Daily Calendar shall be re-referred to the same order of business, provided the bill or resolution shall be carried on the Daily Calendar for at least one legislative day prior to consideration by the House. Legislative measures, other than bills or resolutions, that are discharged from the Rules Committee shall be referred as follows: (i) an amendment, joint action motion for final action, or conference committee report shall be referred to the committee that considered the underlying bill or resolution and (ii) any other legislative measure shall be referred to the proper order of business on the Daily Calendar, provided the legislative measure shall be carried on the Daily Calendar for at least one legislative day prior to consideration by the House. Rulings of the Presiding Officer related to this subsection (g) may not be appealed. This subsection may not be suspended.

(g-5) During each calendar year, each Representative may designate up to 5 bills as a member-sponsored initiative by filing with the Clerk of the House a written motion to have the bill recognized as a member-sponsored initiative and referred to the standing committee or special committee requested in the motion. Any bill that is designated as a member-sponsored initiative by written motion under this subsection (g-5) shall be immediately discharged and referred to the standing committee or special committee or special committee designated in the motion notwithstanding any other provision of these Rules. This subsection (g-5) may not be suspended.

(h) Except for those provisions that may not be suspended, this Rule may be suspended only by the affirmative vote of 71 members elected.
