Mr. Speaker -- I am directed to inform the House of Representatives that the Senate has adopted the following Senate Joint Resolution, in the adoption of which I am instructed to ask the concurrence of the House of Representatives, to-wit:

### SENATE JOINT RESOLUTION NO. 16

WHEREAS, It is a core mission of the National Guard to provide the states with units that are trained and equipped to protect life and property; and

WHEREAS, The Fire Department of the 183rd Fighter Wing of the Illinois Air National Guard is such a unit; and

WHEREAS, The Department, which is based out of the Abraham Lincoln Capital Airport in Springfield, Illinois, provides invaluable people, equipment, and resources for meeting the State's needs in responding to emergencies and natural disasters; and

WHEREAS, In 2005, the U.S. Defense Base Closure and Realignment Commission announced that the 183rd Fighter Wing would lose its F-16 aircraft; and

WHEREAS, The National Guard Bureau announced that, without a flying mission, the firefighter positions for the 183rd would be eliminated as of April 1, 2008; and

WHEREAS, The removal of the Fire Department at the 183rd would have a substantial negative impact on the safety of the flying public, on the emergency-response capabilities of Springfield and the surrounding communities, and on those communities' ability to respond to natural disasters and to homeland security; and

WHEREAS, U.S. Senator Dick Durbin recently requested an MC-12 Mission from Secretary of Defense Robert Gates for the 183rd Fighter Wing, Illinois Air National Guard to ensure the Illinois Air National

Guard's ability to further its homeland defense and disaster relief efforts; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we urge the United States Congress and the National Guard Bureau to take all necessary steps to ensure that the Fire Department of the 183rd remains located at the Abraham Lincoln Capital Airport in Springfield, Illinois for the protection and preservation of the lives and property of citizens of Central Illinois; and be it further

RESOLVED, That a copy of this resolution be delivered to Lieutenant General H. Steven Blum, Chief, National Guard Bureau, the President pro tempore of the U.S. Senate, the Speaker of the U.S. House of Representatives, and each member of the Illinois congressional delegation.

Mr. Speaker -- I am directed to inform the House of Representatives that the Senate has adopted the following Senate Joint Resolution, in the adoption of which I am instructed to ask the concurrence of the House of Representatives, to-wit:

### SENATE JOINT RESOLUTION NO. 32

WHEREAS, CommunityHealth was founded in 1993 by Serafino Garella, M.D., a board-certified Internist and Nephrologist, as a direct response to the Chicago metro area community's lack of access to reliable health care; and

WHEREAS, CommunityHealth operates an innovative model supported by volunteerism and philanthropy, guiding it to be the leader that defines excellence in delivering comprehensive,

patient-centered health care at no cost to low-income, uninsured individuals and families in need of a medical home; and

WHEREAS, CommunityHealth is dedicated to serving the uninsured and underserved in Chicago and surrounding communities, it has provided since its founding upwards of 170,000 medical and education visits for more than 30,000 uninsured men, women, and children; today, CommunityHealth provides medical and educational visits for more than 7,000 patients a year; and

WHEREAS, With more than 650 volunteers, including 285 physicians from Chicago's leading health care institutions, CommunityHealth represents a grassroots response to the needs of the uninsured; in 2008, its volunteers donated more than 42,000 hours of time; its innovative relationships with eight Chicagoland medical schools and residency programs have established CommunityHealth as an important medical-training center; and

WHEREAS, Of the 1.3 million uninsured who live in the Chicago metro area, like the vast majority of the uninsured, most of CommunityHealth's patients are from working families; specifically, 80% come from working families, all lack health insurance, all are living at or below 250% of the federal poverty level, 43% present one or more chronic health conditions, many are new immigrants and don't speak English, and several patients travel great distances to receive CommunityHealth's free care; and

WHEREAS, In the beginning the storefront clinic was open just a few hours per week, today after demand for services ballooned and the number of healthcare volunteers grew, CommunityHealth operates a clinic six days a week, including four evenings and Saturdays, providing a broad range of primary and specialty care, as well as education, health promotion and case management services; all examinations, lab services and medications are free; and

The following resolution was offered and placed in the Committee on Rules.

### HOUSE JOINT RESOLUTION 34

Offered by Representative Currie:

BE IT RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the two Houses shall convene in Joint Session on Wednesday, March 18, 2009 at the hour of 12:00 o'clock noon for the purpose of hearing his Excellency Governor Patrick J. Quinn present to the General Assembly his Report on the Condition of the State of Illinois and to hear the Budget Message for the Fiscal Year 2010, as required by Chapter 15, Section 20/50-5 of the Illinois Compiled Statutes.

### SENATE RESOLUTION

The following Senate Joint Resolution, received from the Senate, was read by the Clerk and referred to the Committee on Rules: SENATE JOINT RESOLUTION 2 (Beiser).

At the hour of 8:46 o'clock a.m., the House Perfunctory Session adjourned.

At the hour of 1:11 o'clock p.m., the House reconvened perfunctory session.

### HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

### HOUSE RESOLUTION 160

Offered by Representative Sacia:

WHEREAS, Horse processing is the most tightly regulated animal harvest; and

WHEREAS, Horse processing is the only animal processing for which transportation is regulated; and WHEREAS, The Horse Welfare Coalition estimates that annually 90,000 to 100,000 unwanted horses will be exposed to potential abandonment and neglect if horse processing plants are forced to close and horse export options are eliminated; and

WHEREAS, Those 90,000 to 100,000 unwanted horses will compete each year for adoption with the 32,000 wild horses that United States taxpayers are currently paying \$40 million to shelter and feed; and

WHEREAS, The nation's inadequate, overburdened, and unregulated horse rescue and adoption facilities cannot handle the influx of approximately 60,000 or more additional horses each year that would result from a harvesting ban, according to the Congressional Research Service; and

WHEREAS, Many zoo animal diets rely on equine protein because it closely resembles the food that the zoo animal would consume in the wild; and

WHEREAS, Many veterinarians and animal nutritionists assert that equine protein is the healthiest diet for big cats and rare birds; and

WHEREAS, The only source of equine protein that is inspected by the United States Department of Agriculture will be eliminated if federal legislation shuts down horse processing facilities; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we respectfully urge all members of the Illinois congressional delegation to support the continuation of horse processing in the United States and to offer incentives that help create horse processing plants, such as state-inspected horse harvest for export; and be it further

RESOLVED, That we respectfully urge the Congress of the United States to support new horse processing facilities and the continuation of existing facilities on both the state and national level; and be it further

RESOLVED, That we respectfully urge the House of Representatives of the Congress of the United States to oppose H.R. 503 of the 111th Congress and to support the processing of horses in the United States and internationally; and be it further

RESOLVED, That we support the location of United States Department of Agriculture-approved horse processing facilities on state, tribal, or private lands under mutually acceptable and market-driven land leases and, if necessary, a mutually acceptable assignment of revenues that meets the needs of all parties involved with the horse processing facility; and be it further

RESOLVED, That after adoption, copies of this resolution shall be sent by the Clerk of the Illinois House of Representatives to the members of Illinois congressional delegation, the President pro tempore of the United States Senate, and the Speaker of the United States House of Representatives.

### **HOUSE RESOLUTION 163**

Offered by Representative Cross:

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that there is created a task force to study local government development standards and processes and their effect on watershed, wetlands, and floodplains. The task force shall consist of the following members: 4 members of the House of Representatives appointed by the Speaker of the House, one of whom shall be appointed to serve as co-chairperson; 4 members of the House of Representatives appointed by the Minority Leader of the House, one of whom shall be appointed to serve as co-chairperson; and at least one representative from each of the following: a statewide organization representing municipal interests, a land conservation entity, and a property development entity; and be it further

RESOLVED, That the goal of the task force is to secure improved management practices in local government development standards, with a focus on all of the following:

- (1) Local government development practices and the short-term and long-term impact on lands affected and subsequent property owners.
- (2) Topics of mass grading, compensatory storage, drainage, runoff, bank stabilization, diversion of flood waters, enormous impacts on pervious surfaces, deforestation, and elimination of prairie and wetlands.
  - (3) Local government zoning authority practices and their interaction with private developers; and be it further

RESOLVED, That the task force shall report its findings and recommendations to the General Assembly on or before January 1, 2010.
