Senate; one of whom shall be appointed by the Minority Leader of the Senate; one of whom shall be appointed by the Speaker of the House of Representatives; and one of whom shall be appointed by the

RESOLVED, That the Task Force may hold hearings on the issue of unemployment insurance for contingent academic workers and shall report its findings to the General Assembly on or before July 1, 2010; and be it further
