WHEREAS, The literacy of citizens of the State of Illinois is essential for the civil, social, and economic well-being of the State of Illinois; residents' literacy and education skills are required for individuals to reap the full benefit of opportunities available in the State of Illinois; and

WHEREAS, Many older people in the State of Illinois lack the reading, math, or English skills to read a prescription and follow medical instructions, endangering their lives and the lives of their loved ones; and

WHEREAS, Illinois' economy is transforming to one that demands new knowledge, skills, and credentials; given the skills needed to compete in today's society, the need for a pathway system that prepares learners to enter and succeed in post-secondary education and employment is important; and

WHEREAS, Adult education services are needed now more than ever; there are millions of Illinois residents who have either not completed their high school education or lack the basic literacy skills and language skills needed to obtain jobs in Illinois; for these individuals, obtaining these skills prepares them to enter middle skill jobs and post-secondary education; and

WHEREAS, Through a diverse provider system and collaboration with stakeholders to increase access to adult education services, the Illinois Community College Board envisions adult education as the foundation of a career pathway system that prepares adult learners for economic self sufficiency; the Illinois Community College Board is committed to strengthening instructional programs and services that equip students with the skills needed to successfully compete in today's society; and

WHEREAS, The purpose of Adult Education is to assist adults to become literate and to obtain the knowledge and skills necessary for self-sufficiency employment; assist adults who are parents to obtain the educational skills necessary to become full partners in the educational development of their children; and assist adults in the completion of a secondary school education; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the week of April 25, 2010 as Adult Education and Family Literacy Week in the State of Illinois; and be it further

RESOLVED, That we support the designation of Adult Education and Family Literacy Week in the State of Illinois, including raising public awareness about the importance of adult education and family literacy and encouraging people across the State of Illinois to support programs to assist those in need of adult education and family literacy programs; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Adult Education and Family Literacy program, governed by the Illinois Community College Board.

### **HOUSE RESOLUTION 1119**

Offered by Representative Reis:

WHEREAS, Project Labor Agreements (PLAs) effectively deny nearly 85.5% of the U.S. private construction workforce (those who do not belong to a labor union) the ability to gain employment on almost all public work projects; PLAs reduce competition and significantly drive up costs for taxpayers; and

WHEREAS, PLAs put special interests ahead of the public interest by essentially restricting the bidding process to contractors backed by big labor unions, while denying others the opportunity to perform the job at a better price; and

WHEREAS, PLAs require contractors, including construction contractors, to agree to the terms of a one-time collective bargaining agreement with labor unions, without regard to the wishes of the employees, as a condition of performing work on a particular construction project; and

WHEREAS, Numerous academic studies have compared the impact of PLAs on bid and final construction costs when compared to similar non-PLA projects and have found that PLAs cost 10% to 18% more per square foot; and

WHEREAS, PLAs force construction employees who are not members of a union to be shut out of working on PLA projects; PLAs also force construction employees to pay union dues and fees, follow union hiring hall guidelines, and obey inefficient union work rules for their craft for the life of a PLA project, even though they have freely chosen to NOT belong to a union; and

WHEREAS, Associations that represent small, disadvantaged, minority and women-owned businesses, such as the National Black Chamber of Commerce and the National Association of Women Business Owners, are publicly opposed to PLAs; local minority workers are shut out of PLA projects because they are overwhelmingly under-represented in members of key unions, including trade unions and craft unions; and

WHEREAS, PLAs deny taxpayers the accountability they deserve from government while encouraging waste and discrimination in contracting; and

WHEREAS, PLAs significantly limit and, in some instances, prohibit the majority of the taxpaying

construction contractors from working on a public or private construction project because of their non-union affiliation; these agreements are a form of discrimination against law-abiding, taxpaying Illinois citizens and employers; and

WHEREAS, Free and open competition is conducive to production, economic growth, and efficient use of limited resources; it is in the public interest, especially when public contracts and tax dollars are concerned, that all qualified and capable contractors and workers are fairly considered; and

WHEREAS, Union affiliation should not be one of the determining factors in awarding construction contracts; free and open competition is the only way to protect public and private interests, stretch scarce construction dollars, and maximize product quality; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Governor to withdraw Executive Order 2010 - 03 and discontinue the use of PLAs on State and Federal Public Works Projects in Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Governor.

### **HOUSE RESOLUTION 1120**

Offered by Representative Riley:

WHEREAS, Several State-operated developmental disability or mental health facilities that serve adults with developmental disabilities and mental illness have closed in recent years; and

WHEREAS, It is critical that former residents of these facilities receive services and supports necessary to meet their needs, whether they transition to a community-based agency, another State-operated facility, or home care; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that when the Department of Human Services closes a State-operated developmental disability or mental health facility after the adoption of this resolution, the Department shall track and report how these individuals' health care and other service and support needs are being met for one year after the closure of the State-operated developmental disability or mental health facility, detailing the number of individuals that have been transferred or transitioned out of a State-operated developmental disability or mental health facility due to facility closures; the setting to which these individuals were transferred or transitioned to; and how these individuals' health care and other service and support needs are being met following transfer or transition from a State-operated developmental disability or mental health facility; and be it further

RESOLVED, That the Department shall submit this report to the Governor and the General Assembly by January 31st of each year following the closure of a facility, and that the report shall be made available to the public; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Secretary of Human Services.

### **HOUSE RESOLUTION 1121**

Offered by Representative Bill Mitchell:

WHEREAS, The island nation of Haiti is steeped in a rich culture and history; on January 12, 2010, a magnitude-7.0 earthquake struck Haiti, with its epicenter just outside the capital and population center of Port-au-Prince; and

WHEREAS, The Haitian government has confirmed a death toll of more than 230,000 persons as a result of the disaster; and

WHEREAS, Following the catastrophic damage to their villages and cities, many of the earthquake survivors now live in tent cities and are more vulnerable than ever to epidemics of infectious disease, particularly with the region's rainy season approaching; and

WHEREAS, Due to many factors, including the already-extreme poverty of the nation, thousands of Haitian children had been provably and legally abandoned and relinquished to the Haitian government by their parents prior to the devastation of that January day; and

WHEREAS, These children, known as "Category 3" orphans, are officially confirmed as orphans eligible for intercountry adoption but do not meet the specific criteria outlined by the United States Department of Homeland Security that would allow them to enter the United States; and

WHEREAS, An additional unknown number of "Category 2" orphans--those children who are both eligible for intercountry adoption and matched with American adoptive parents prior to January 12, 2010--have yet to be allowed to join their new families in the United States; and

WHEREAS, At least twenty-one orphans are destined for families in the United States, though their adoptions have since been mired in unfortunate bureaucracy; and

WHEREAS, Twelve of these children remain in diplomatic limbo in a Pittsburgh, Pennsylvania facility, while at least nine remain at the God's Littlest Angels orphanage near Port-au-Prince, run by Dixie Bickel of Clinton, Illinois; and

WHEREAS, In 2007, the United Nations Children's Fund numbered the orphan population of Haiti at more than 380,000 children; following the earthquake, some organizations estimate that number to have more than tripled; and

WHEREAS, Whatever the number of orphans, there are families in Illinois and throughout the United States who are ready, willing, and able to welcome these provably abandoned children into loving homes; and

WHEREAS, Every provably abandoned child who is taken into a home within the United States dramatically reduces the strain on the post-earthquake relief efforts in Haiti; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we remember the victims and survivors of the Haiti earthquake disaster; and be it further

RESOLVED, That we implore the United States government to expedite the approval of "Category 2" and "Category 3" orphans so that the children who are in need of loving homes may find them quickly and safely; and be it further

RESOLVED, That we applaud the efforts of organizations such as God's littlest Angels orphanage, that are so dedicated to important relief work in Haiti, and we call on all Illinois citizens to support such organizations in whatever capacity they are able; and be it further

RESOLVED, That suitable copies of this resolution be sent to Illinois Governor Pat Quinn; Hillary Clinton, United States Secretary of State; Kathleen Sebelius, Secretary of the federal Department of Health and Human Services; Julie Hamos, Director of the Illinois Department of Human Services, and the Illinois congressional delegation.

### HOUSE JOINT RESOLUTION 116

Offered by Representative Chapa LaVia:

WHEREAS, The Korean War began on June 25, 1950 and raged for 3 bloody years; 1.5 million United States soldiers, including thousands from the State of Illinois, answered the call to arms during the war; and WHEREAS, 54,246 United States citizens, including 1,754 Illinois residents, lost their lives while fighting in Korea; and

WHEREAS, A total of 103,284 United States soldiers were wounded during the fighting in Korea, with 7,140 soldiers taken prisoner and 8,177 soldiers listed as missing in action; and

WHEREAS, A total of 131 Medals of Honor were given to United States soldiers fighting in Korea for acts of exceptional bravery and courage, with 93 Medals of Honor given posthumously; 8 Medals of Honor were given to soldiers from Illinois, with 6 given posthumously; and

WHEREAS, The service and sacrifice of United States soldiers during the Korean War is equal to the service and sacrifice of United States soldiers in any of our nation's wars throughout our history; and

WHEREAS, The number of living Korean War veterans continues to dwindle each year, depriving those deceased warriors the opportunity to share their experiences and to accept the thanks for their service from a grateful nation; and

WHEREAS, The Korean War is often referred to as "The Forgotten War" because it fell between the conclusion of World War II and the beginning of the Vietnam War, and because the shaky truce that ended open hostilities in 1953 left the conflict without official closure; and

WHEREAS, The 60th anniversary of the start of the Korean War occurs on June 25, 2010; and

WHEREAS, The State of Illinois is commemorating the 60th anniversary of the Korean War by supplying information each month about the State's involvement in the conflict, starting in June 2010 and running through July 2013, to the State's newspapers, radio, and TV stations; and

WHEREAS, The Illinois Historic Preservation Agency, the Illinois Department of Veterans' Affairs, the Illinois Korean Memorial Association, and the Abraham Lincoln Presidential Library and Museum, along

with the Illinois Press Association and the Illinois Broadcasters Association, are sponsoring "Illinois Remembers the Forgotten War" to ensure that "The Forgotten War" is no longer forgotten in Illinois; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we designate the date of June 25, 2010 as Korean War Remembrance Day in the State of Illinois; and be it further

RESOLVED, That we encourage all Illinois residents to remember and appreciate the brave men and women who served honorably and paid the ultimate price defending our freedom during the Korean War to ensure that this generation, and those to follow, never forget these heroes and the values for which they fought.
