#### HOUSE RESOLUTION 1346

Offered by Representative Walker:

WHEREAS, The Illinois Covering ALL KIDS Health Insurance Program was created by the General Assembly and the Governor in 2005 with the intent to make Illinois the first state in the nation to provide affordable, comprehensive health insurance for every child in the State; and

WHEREAS, At the time the Covering ALL KIDS Program was established, it was estimated based on adjusted 2003 Census data that 253,000 children in Illinois were without health insurance, more than half of whom came from working and middle class families who earned too much to qualify for other State health care assistance programs, but did not have enough money to afford private health insurance; in the years since, due to the effects of a national recession and economic slowdown worse than any experienced since the Great Depression era, the need to provide access to health care to children whose families lost jobs, income, and insurance formerly provided by a parent's employer, has become even greater; and

WHEREAS, Research shows that uninsured children suffer because they do not have access to adequate medical care; this factor puts uninsured children at higher risk for hospitalization or missed diagnoses of serious conditions; children without health insurance often delay treatment, which can result in more complex, specialized, expensive, and emergency care for critical conditions; and

WHEREAS, Studies have demonstrated that children with health coverage are more likely to get preventative care, stay healthy, have higher rates of school attendance, and perform better academically; and

WHEREAS, While the uninsured pay approximately 35% of their medical bills out of pocket, more than 40% ends up being absorbed by those who do have health insurance in the form of higher premiums; and

WHEREAS, The Covering ALL KIDS Program is intended to make available to children comprehensive health insurance to cover doctors' visits, hospital stays, prescription drugs, vision care, dental care, and medical devices; parents are required to make monthly premiums and co-payments for doctors' visits and prescription drugs at affordable rates determined by their family's income; and

WHEREAS, The Illinois Hospital Association, the Illinois Academy of Family Physicians, and the Illinois State Medical Society supported the creation of the Covering ALL KIDS Program; businesses, labor organizations, community service agencies, non-profit organizations, clergy, and elected officials from across the State gave the Program their endorsement; and

WHEREAS, Legislation to establish the Covering ALL KIDS Program, House Bill 806 of the 94th General Assembly, passed the House and the Senate with bipartisan majorities in October 2005; the bill

was signed into law in November 2005 and became effective July 1, 2006; and

WHEREAS, The clear intention of the lawmakers who supported the creation of the Covering ALL KIDS Program was that it would be run in a competent, professional, and responsible manner; that State health care agency officials and employees would use the authority granted to them by statute to administer the Program properly and to ensure that enrollees and their families were correctly screened for State residency and income verification and required to pay the appropriate premiums for their income level; and that proper documentation and records for Program participants would be maintained; and

WHEREAS, In September 2008, lawmakers approved via unanimous, bipartisan votes House Bill 1533 of the 95th General Assembly, which became effective June 1, 2009 and required the Illinois Auditor General to conduct annual audits of the Covering ALL KIDS Program, including payments for health services covered by the Program and contracts entered into by the Department of Healthcare and Family Services; and

WHEREAS, On May 11, 2010, the Auditor General released a report entitled "Program Audit of Covering ALL KIDS Health Insurance Program"; among the audit's findings were that the Department of Healthcare and Family Services incorrectly categorized some documented immigrants as undocumented immigrants, the number of undocumented immigrants, as well as the costs associated with them, are overstated in data provided by the Department, and the number of documented immigrants, as well as the costs associated with them, are also understated; the Auditor General noted that by not correctly classifying documented immigrants, not only is the Department reporting incorrect data, it is also losing out on federal matching funds it could be receiving for documented immigrants; and

WHEREAS, The Auditor General also found that the Department of Healthcare and Family Services and the Department of Human Services were not obtaining documentation to support eligibility in some instances; in particular, procedures for verifying residency and income had not been utilized in many of the case files reviewed by the Auditor General; as a result, the Auditor General could not determine whether eligibility was determined correctly by the Departments; this could result in a family paying a higher premium or co-pay, or could result in the State paying for a greater portion of a child's medical services than necessary; and

WHEREAS, The Auditor General reported that the Department of Healthcare and Family Services had difficulty producing complete and accurate sets of data in a timely fashion for the audit; that the Department of Healthcare and Family Services and the Department of Human Services did not have adequate controls in place to ensure that individuals over the age of 18 were terminated from Covering ALL KIDS eligibility as required by State law; that the Departments did not have adequate controls in place to ensure that individuals were not enrolled in the Covering ALL KIDS Program more than once with the likely consequence that duplicate enrollees would overstate the number of children served by the Program as well as indicate a weakness in internal controls associated with enrolling the children; and

WHEREAS, The Auditor General's report contained 13 recommendations; 8 recommendations were specifically for the Department of Healthcare and Family Services and 5 recommendations were for both the Department of Healthcare and Family Services and the Department of Human Services; both Departments generally agreed or partially agreed with all 13 recommendations; and

WHEREAS, It is vitally important that the people of Illinois have faith that the Covering ALL KIDS Program is being administered according to the requirements of the law and in the best interests of the taxpayers of Illinois; that participants are screened correctly for residency, eligibility, and income levels; that enrollees pay the proper amounts for the care they receive; and that proper records are maintained; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we request that the Director of the Department of Healthcare and Family Services, the Secretary of the Department of Human Services, the Chief Operating Officer of the State, and the Deputy Governor with responsibility for the Covering ALL KIDS Health Insurance Program, be prepared to testify before the House State Government Administration Committee during the General Assembly's 2010 fall Veto Session about the steps they have taken to rectify the problems uncovered by the Auditor General's audit of the Covering ALL KIDS Program; that we urge the Governor to take appropriate action to hold those who have failed to operate the Covering ALL KIDS Program properly or misled the public, press, lawmakers, or auditors accountable for their actions via discipline, reprimand, or termination; and be it further

RESOLVED, That copies of this resolution be delivered to the Governor, the Chief Operating Officer for the State of Illinois, the Director of the Department of Healthcare and Family Services, and the Secretary of the Department of Human Services.

WHEREAS, During the past year the Illinois Student Assistance Commission, administrator for the program, has authorized placement of nearly 20% of program participants' financial contributions into inherently risky alternative investments, including \$135 million in three separate hedge funds; and

WHEREAS, Hedge funds and private equity investments often do not provide the level of transparency

appropriate for public institutional investments of this kind; and

WHEREAS, This level of exposure to alternative investments is at best questionable, given the relatively small size of the College Illinois! portfolio and could expose the program to unnecessary financial risk; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that, in response to reports that the Illinois Student Assistance Commission lost \$10.7 million of its \$12.7 million investment in ShoreBank, a privately held company that has been declared to be in financial trouble by federal regulators, we direct the Illinois State Board of Investment to conduct an independent asset allocation study of College Illinois! investments to determine the overall level of risk associated with the program's investment mix and provide the results of that study to the General Assembly and the Governor no later than January 15, 2011; and be it further

RESOLVED, That we direct the Auditor General to conduct a special audit of College Illinois! operations to document growth in program administrative costs and determine the efficacy of program administration on behalf of participants and provide the results of this special audit to the General Assembly and the Governor no later than January 15, 2011; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Illinois State Board of Investment and the Auditor General.

WHEREAS, The events of September 11th served as a catalyst for the "war on terror", which has become one of the largest scale international conflicts in history; the "war on terror" has involved combat operations in nearly a dozen countries, supported by hundreds of thousands of American troops throughout the last 9 years; and

WHEREAS, The lasting physical effects of the attack can still be seen at the former site of the World Trade Center; American sentiment claims this location as hallowed ground, with thousands of people visiting the site every year to pay respects to those who perished in the cowardly attacks and to show support for the ongoing "war on terror"; and

WHEREAS, The American Society for Muslim Advancement and the Cordoba Institute have proposed a development plan to build a \$100 million mosque and Muslim Community Center at 45 Park Place in Lower Manhattan; this location is a mere 2 blocks from Ground Zero, which has provoked concern among segments of the American public and politicians from both parties alike; and

WHEREAS, The perpetrators of the September 11th attacks were Muslim extremists; while the proposed mosque and Muslim Community Center would be a place of peace and worship, many Americans question the appropriateness of honoring Islam in such close proximity to Ground Zero, where thousands died and hundreds of victims were never recovered; and

WHEREAS, Typically, tragedies of such large scale are honored at the site with monuments to remember and honor the fallen; the proposed building of a mosque and Muslim Religious Center in such close proximity to the site of the attack has been controversial and could negatively impact those visiting the area to pay respects to the thousands of innocent victims; and

WHEREAS, Throughout history, the locations of tragic occurrences and monuments have been claimed by the victims and families of victims to memorialize the event and honor its victims; the decision to allow the American Society for Muslim Advancement and the Cordoba Institute to build a mosque and Muslim Religious Center at Ground Zero has energized protests across the U.S., generating negative media attention and jeopardizing the integrity of future memorials; and

WHEREAS, While freedom of speech, freedom of religion, and property rights allow for such a structure to be built, sensitivity to the concerns of American citizens should be prioritized by choosing another location for the Muslim Community Center to show respect for the lives lost on September 11, 2001; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the American Society for Muslim Advancement and the Cordoba Institute to reconsider their plans regarding the building of a mosque and Muslim Community Center in such close proximity to the site of the largest scale tragedy in the United States to date; and be it further

RESOLVED, That suitable copies of this resolution be presented to President Barack Obama, New York City Mayor Michael R. Bloomberg, New York Governor David A. Patterson, and the Manhattan Community Board.

WHEREAS, Concerns have been raised that, when State employees, enrollees in State-subsidized programs, and privately covered individuals use a mail order pharmacy outside of the geographic boundaries of Illinois, significant revenues are lost due to the inability to collect taxes from the out-of-state pharmacies; and

WHEREAS, The mission statement of the Department of Revenue includes the responsibility of serving as the tax collection agency for the State and units of local government; therefore, be it

#### HOUSE RESOLUTION 1442

Offered by Representative Durkin:

WHEREAS, The month of November is designated as National Diabetes Awareness Month; and

WHEREAS, As many as 3 million Americans suffer from type 1 diabetes, a chronic, genetically-determined, debilitating disease affecting every organ system; and

WHEREAS, More than 15,000 children each year are diagnosed with type 1 diabetes, a disease caused by an autoimmune attack that destroys the insulin-producing beta cells of the pancreas; and

WHEREAS, 827,000 Illinoisans, 8.4% of the State's population, have been diagnosed with diabetes; diabetes costs the Illinois economy \$7.3 billion annually; and

WHEREAS, Diabetes is one of the most costly chronic diseases, costing the United States economy more than \$174 billion and costing individuals with diabetes an average of \$13,000 in annual health care costs, compared to \$2,600 for individuals without diabetes; and

WHEREAS, Insulin treats, but does not cure, this potentially deadly disease and does not prevent the complications of diabetes, which include blindness, heart attack, kidney failure, stroke, nerve damage, and amputations; and

WHEREAS, The National Institutes of Health has established 6 goal areas to guide type 1 diabetes research, focused on the reduction, prevention, and cure of type 1 diabetes and its complications; and

WHEREAS, The National Institutes of Health's research goals are to identify the genetic and environmental causes of type 1 diabetes, prevent or reverse type 1 diabetes, develop cell replacement therapy, prevent or reduce the occurrence of hypoglycemia in persons with type 1 diabetes, prevent or reduce the complications of type 1 diabetes, and attract new talent and apply new technologies to research on type 1 diabetes; and

WHEREAS, Federal funding has enabled research focused on determining the underlying genetic and environmental causes of diabetes and testing promising new treatments to halt and reverse the autoimmune attack that causes type 1 diabetes; and

WHEREAS, A cure for type 1 diabetes will require restoring beta cell function, either by replacement with transplantation or by beta cell regeneration; and

WHEREAS, The development of a 'closed-loop' artificial pancreas would greatly alleviate the daily burden of disease management for type 1 diabetes patients by continuously monitoring blood sugar levels, infusing insulin as necessary when blood glucose levels become too high, and warning patients when blood glucose levels become dangerously low; and

WHEREAS, Continued progress toward a cure for type 1 diabetes depends on training the next generation of diabetes researchers; and

WHEREAS, Congress has provided \$150 million annually through fiscal year 2011 for the Special Statutory Funding Program for Type 1 Diabetes Research; and

WHEREAS, The Special Statutory Funding Program for Type 1 Diabetes Research has provided nearly \$16 million to Illinois institutions for type 1 diabetes research; and

WHEREAS, Leading type 1 diabetes researchers have recommended a total funding level of \$4.1 billion for fiscal years 2009 through 2013 in order to meet the National Institutes of Health's type 1 research goals; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Congress to renew the funding for the Special Statutory Funding Program for Type 1 Diabetes Research in 2010 for multiple years, so that a cure for type 1 diabetes and its complications can be found; and be it further

RESOLVED, That suitable copies of this resolution be sent to each member of the Illinois Congressional delegation.

#### HOUSE RESOLUTION 1481

Offered by Representative Watson:

WHEREAS, The federal government, now more than ever, needs to eliminate wasteful spending programs from its budget; and

WHEREAS, The federal deficit recently hit \$13.5 trillion; and

WHEREAS, The Department of Defense will spend \$708 billion on defense spending in the 2011 fiscal year for both base defense programs and overseas contingency operations to promote the safety and welfare of our nation; and

WHEREAS, Congress has planned to appropriate \$465 million for an alternate GE F-136 engine for the F-35 Joint Strike Fighter program in the Defense Appropriations Bill; and

WHEREAS, The Department of Defense has already contracted the Pratt & Whitney F-135 engine, which has gone through multiple series of testing and development; and

WHEREAS, No military aircraft in the past 3 decades has been procured with multiple engine suppliers; and

WHEREAS, Developing the alternate engine would cost \$2.9 billion dollars over the next 2 to 3 years; and

WHEREAS, Having multiple engine suppliers will require additional spending for 2 sets of parts, 2 production and maintenance lines, and additional personnel and training, which will lead to the production of fewer Joint Strike Fighter planes; and

WHEREAS, A sharp, curving section of railroad right-of-way leading into Centralia from the south causes some of the most extreme delays, where the maximum speed allowed on the rails is only 10 miles per hour; the grade crossings for these tracks are frequented by both motor vehicle commuters and approximately 40 freight trains a day; with some railroad trains being almost one mile long, motorists must wait for many minutes to cross the tracks; and

WHEREAS, The residents of the affected towns have spoken out against these aforementioned delays for over a decade in city council meetings and town forums alike and have called for rerouting of rail lines to reduce these delays and health hazards in their daily lives; the municipalities of Centralia and Wamac have both passed resolutions to support this route change; and

WHEREAS, Two potential routes have been identified for the potential route relocation; both routes involve an investment in new track and are promising to unclog the bottleneck areas located in the towns of Centralia and Mt. Vernon; therefore, be it
